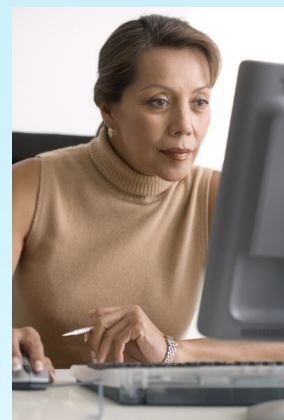
Note: This bulletin has been updated. Modifier U1 was removed as the third modifier included for Transportation, Level 1 in Tables 2 and 4. Providers billing for Transportation, Level 1 for the CIH/FSW are required to list T2002 U7 U5, and the third modifier is not required.

IHCP announces corrections to new rates for DA and DDRS waivers, effective July 1, 2023

New rates for the Division of Aging (DA) Aged and Disabled (A&D) Waiver and Traumatic Brain Injury (TBI) Waiver, and the Division of Disability and Rehabilitative Services (DDRS) Community Integration and Habilitation (CIH) waiver and Family Supports Waiver (FSW) were announced in *Indiana Health Coverage Programs (IHCP) Bulletin [BT202359](#)*.

Incorrect rates or limits were reported for some of the services, and one service listed the incorrect waivers for that service. The corrections are listed in the following tables (*corrections are highlighted in the tables*):

- Table 1 – Lists the corrected daily and monthly rates for DA assisted living services.
- Table 2 – Shows corrections for the limits on DDRS transportation services.

Recent changes were also made to DDRS residential habilitation services hourly rates and to the Residential Habilitation and Support (RHS) daily rates. These changes are reflected in [Table 5](#) (*changes are highlighted in this table*).
