Differences clarified between HCBS Transportation service under PathWays Waiver and NEMT service

The Office of Medicaid Policy and Planning (OMPP) clarifies the differences between the Home- and Community-Based Services (HCBS) Transportation service provided to Indiana PathWays for Aging (PathWays) Waiver members and the nonemergency medical transportation (NEMT) service available to PathWays program members.

HCBS Transportation service – PathWays Waiver

This HCBS Transportation service is available to participants who have an active PathWays Waiver. This service enables participants served under the PathWays Waiver to gain access to waiver and other nonmedical community

services, activities and resources, specified by the service plan.

Transportation services through the PathWays Waiver are reimbursed as two types of service:

- Level 1 Nonassisted Transportation The participant does not require mechanical assistance to transfer in and out of the vehicle.
- Level 2 Assisted Transportation The participant requires mechanical assistance to transfer into and out of the vehicle.



Nonmedical transportation is billed as a combination of a base trip code and a mileage code. Providers must bill a base trip and mileage code together.

Providers that are approved to provide transportation under the PathWays Waiver must follow these documentation standards:

- Identify need in the service plan.
- Outline services in the service plan.
- Document that the provider meets and maintains the requirements for providing services under Indiana Administration Code 455 IAC 2; documentation maintained by the provider or its agent.
- Specify applicable (if any) limits on the amount, frequency or duration of this service.



Transportation services provided under the PathWays Waiver must not duplicate transportation services provided under the Indiana Medicaid State Plan or any other waiver service. Other transportation activities not allowed under the PathWays Waiver include services provided to participants receiving services in Adult Family Care and Assisted Living settings.

The PathWays managed care entities (Anthem, Humana or UnitedHealthcare) or Gainwell Technologies reimburse transportation claims when the following conditions are met:

- An approved service authorization includes the waiver transportation service.
- The provider is an approved provider to deliver waiver transportation services.
- The participant is not receiving services in Adult Family Care and Assisted Living settings.

Nonemergency medical transportation service – PathWays program

NEMT is a covered service under the Indiana Medicaid State Plan for all PathWays members. The Indiana Health Coverage Programs (IHCP) reimburses NEMT for members to get to or from an IHCP-covered service from an IHCPattested provider. NEMT services are intended to assist members in accessing medical appointments due to a lack of transportation or insufficient resources to cover travel expenses. NEMT services occur when needs are not immediate, such as scheduled appointments, dialysis, chemotherapy, physical therapy, primary care or specialist visits, and picking up prescriptions.

The NEMT service is managed either through the state's contracted broker or through the MCE's contracted broker. For most NEMT trips, the provider must be part of the broker's provider network and must submit all claims to the appropriate broker to receive reimbursement. Some NEMT services are carved out of the brokerage model (see IHCP Bulletin BT2024119).

Summary

Table 2 summarizes the two different transportation services available to PathWays members: the HCBS Transportation service available through the PathWays Waiver and the NEMT service available to PathWays program members.
