# Gainwell responds to questions about P.O. Box changes

After the publication of *Indiana Health Coverage Programs (IHCP) Bulletin <u>BT202455</u>, Gainwell Technologies received questions from stakeholders. Those questions and responses apply to many stakeholders and are provided in this bulletin.*

#### P.O. Box questions and responses

 The P.O. Box I send information to is not listed in Table 1. For example, I send refund checks to P.O. Box 2303, Dept 130, Indianapolis IN 46204-2303. Because I don't see P.O. Box 2303 on the table, does that mean it's not changing?

If the P.O. Box is not listed in the "Current P.O. Box" column of <u>Table 1</u>, it is not changing and you do not need to make any changes for those addresses.

2. When should I start sending mail to the "New P.O. Box" listed below?

Stakeholders should begin sending mail on Aug. 1, 2024. Gainwell will be checking the "new" P.O. Boxes prior to Aug. 1, and will also continue checking the "current" P.O. Boxes beyond Aug. 1.





4. I noticed the name of a P.O. Box may have changed slightly from what I currently have in my system. Is that an issue? For example, currently I send information to P.O. Box 7269 with the header "Gainwell CMS 1500 Claims." The new box (P.O. Box 50447) says "Gainwell Medical Claims;" do I need to change to accommodate?

No, you do not need to make that change. The most important thing is making sure you are using the right P.O. Box number and address. Be sure to include "Gainwell" or "IHCP" in the top address line (follow how they are listed in the <a href="IHCP">IHCP</a> in the top address line (follow how they are listed in the <a href="IHCP">IHCP</a> Quick Reference Guide and provider reference modules for the information you are sending). If the P.O. Box and address are correct, it will get where it needs to go. A bulletin will be published in early July that will list the P.O. Boxes and the different names attached to them.
