IHCP announces additional ICD-10-CM coding updates, effective Oct. 1, 2025

The Indiana Health Coverage Programs (IHCP) previously published billing information for the annual update of International Classification of Diseases, Tenth Revision (ICD-10) Clinical Modification (CM) diagnosis codes and Procedure Coding System (PCS) procedure codes in *IHCP Bulletin BT2025141*. The IHCP is publishing additional

information regarding the annual ICD code update. These changes apply retroactively to dates of service (DOS) on or after **Oct. 1, 2025**.

Presumptive Eligibility for Pregnant Women

Benefits for Presumptive Eligibility for Pregnant Women (PEPW) members are limited to ambulatory prenatal care for certain qualifying diagnoses. Effective for dates of service (DOS) on or after Oct. 1, 2025, the diagnosis codes in Table 1 will be added as qualifying diagnoses for PEPW services. These updates will be reflected in *Presumptive Eligibility for Pregnant Women Codes*, accessible from the <u>Code Sets</u> webpage at in.gov/medicaid/providers.

Table 1 – ICD-10 diagnosis codes added for PEPW services, effective for DOS on or after Oct. 1, 2025

Diagnosis code	Code description
Z59861	Financial insecurity, difficulty paying for utilities
Z59868	Other specified financial insecurity
Z59869	Financial insecurity, unspecified

Routine foot care

The IHCP covers routine foot care only for members with a qualifying systemic disease. Effective for DOS on or after Oct. 1, 2025, the diagnosis code in Table 2 will be added as a qualifying diagnosis for routine foot care. This update will be reflected in *Podiatry Services Codes*, accessible from the <u>Code Sets</u> webpage at in.gov/medicaid/providers. See the <u>Podiatry Services</u> provider reference module for additional coverage criteria and limitations.

Table 2 – ICD-10 diagnosis code added for routine foot care, effective for DOS on or after Oct. 1, 2025

Diagnosis code	Code description
E11A	Type 2 diabetes mellitus without complications in remission

Visual evoked potential testing

The IHCP reimburses optometrists for visual evoked potential (VEP) testing only when billed with a qualifying diagnosis code. Effective for DOS on or after Oct. 1, 2025, the diagnosis codes in Table 3 will be added as qualifying diagnoses for VEP testing by an optometrist. These updates will be reflected in Vision Services Codes, accessible from the Code Sets webpage at in.gov/medicaid/providers.



Table 3 – ICD-10 diagnosis codes added for optometrist VEP testing, effective for DOS on or after Oct. 1, 2025

Diagnosis code	Code description
G35A	Relapsing-remitting multiple sclerosis
G35B0	Primary progressive multiple sclerosis, unspecified
G35B1	Active primary progressive multiple sclerosis
G35B2	Non-active primary progressive multiple sclerosis
G35C0	Secondary progressive multiple sclerosis, unspecified
G35C1	Active secondary progressive multiple sclerosis
G35C2	Non-active secondary progressive multiple sclerosis
G35D	Multiple sclerosis, unspecified
