### Explanation for Question 5

LMI- Area benefit is the clearest and most common way for a community to meet a National Objective and be eligible for CDBG. If a community chooses to use limited clientele to qualify for CDBG, they would be required to use income verification from all of the families all of the residents who would be utilizing the service and they would have to demonstrate for 5 years after the project were funded that 51% of the people who were served were low to moderate income. If you contact a community liaison, they will be able to provide you some strategic direction on the best choice for a national objective.
