Program Income Report Instructions

How to Complete and Submit a Program Income Report.

- 1. This report is to be filled out utilizing the grants management system (GMS) report.
- 2. The <u>Program Income Report</u> (excel spreadsheet) must be completed prior to starting the report in GMS.
- 3. Open the CDBG-CV <u>Program Income Report</u> (excel spreadsheet)
- Save a copy of the excel spreadsheet in your device with the format name (CDBG-CV Program Income Report_ UGLGs name). For example: CDBG-CV Program Income Report _ City of Auburn
- 5. Proceed to completing the report utilizing the instructions.
- 6. Print a copy of the completed GMS report form and have the Chief Elected Official sign and date the certification. This certifies the report's accuracy. Submit this Certification (scan the signed copy and upload it to GMS.
- 7. Once the document has been signed, please upload the completed report to GMS-
- 8. Reports should be submitted in OCRA's GMS system under the corresponding grant.
- 9. Save a copy of the report for your local file.
- 10. This reporting will be required quarterly in perpetuity.
 - Q1: For the period of January 1 through March 31 the report is due no later than April 30
 - Q2: For the period of April 1 through June 30 the report is due no later than July 31
 - Q3: For the period of July 1 through September 30 the report is due no later than October 31
 - Q4: For the period of October 1 through December 31 the report is due no later than January 31
- 11. Submit program income report by the due date in GMS.

Completing the CDBG-CV Program Income Report - Line by Line

Section VI - Portfolio of Revolving Loan Fund

For all loans made with proceeds from program income or CDBG-CV Grants as part of OCRA's COVID-19 Response Program for Economic Activities, follow these steps to fill out Part 2 of the report:

Section 6)

- a) Enter Business Name: name each individual business that received funds from the RLF.
- b) Enter **Loan identification number**: this should be a unique identification code that helps identify the loan originated to the individual business.
- c) Enter **Date Loan was originated**: date of when the loan was made/ originated or issued to the individual business.
- d) Enter **Loan Amount Issued**: the amount issued or the principal amount (this number should not include any charges for administrating cost for processing the loan).
- e) Enter **Loan Term:** enter this number in months. For example, if a loan repayment term is two years, the loan term should be typed out as 24 months.
- f) Enter Loan Interest Rate charge to the loan: this number should be a percentage.

Section 7)

- g) Enter the **Status of Loan** for each business loan indicate whether: current, delinquent, default, write-off, forgiven or paid in full.
- h) Enter **Explanation:** For loans in default or a write-off should include a brief explanation of collection efforts on Column h.
 - Note on **Forgiven Loans**: Per OCRA' program requirements loan balance can be forgiven if business retains jobs for at least 2 years this would satisfy the national objective of LMI Jobs.

Section 8)

- i) Enter **Current Loan Balance**: This number should reflect the current balance including any payments made towards the principal of the loan originated. This section should reflect the k) program income receipts i) ending loan balance.
- j) Enter Administrative fee charged on loan up to this period.
- k) Enter Program Income Receipts up to this Period: this number should reflect the total payments received from the loan up to this period including interest charged and any late payments charged on loan payments. This section should match the amount from the excel sheet section j)- i) ending loan balance with interest. This is the program income collected for the period of the reporting period.
- Enter Ending Loan Balance: this number is the total future payments of the original loan balance with any additional interest for each individual business loan. This is the amount of the principal and interest to be paid over the course of the loan term.

Section 9)

<u>Job Retention (LMJ</u>): This section would require for the grantee to utilize the latest Job Retention Report approved by OCRA.

- m) Enter the **Number of Jobs Retained**: This number is the number of jobs positions retained at end of the reporting year by each individual business. Utilized the latest job retention report approved by OCRA to enter the latest number of job positions retained.
- n) Enter the **Number of LMI Jobs/Positions**: This number is the number of job position retained that are held by LMI people in each individual business. Utilized the latest job retention report approved by OCRA to enter the number of LMI jobs for each individual business.

Section 10)

<u>Will the Grantee forgive the loan?</u> For local revolving loan programs established to carry out economic activities as part of the COVID-19 Response Program Phase 1,2 & 3, OCRA allows the remaining owed balance to be converted to a forgivable grant if the business retains the jobs for at least two (2) years. Generally, the LMJ National Objective is met at the onset of the projects, and program requirements are completed within two years of the grant award.



Section 1) Enter **Beginning Balance**: Starting balance of revolving loan fund from the prior period reported.

Section 2) Enter Receipts this period: It represents receipts of Program Income

- a. Enter **Loan Repayments:** It refers to the Program Income in the form of principal and interest repaid for this reporting period
- b. Enter **Interest Earned:** The amount of other Program Income received such as interest earned on any bank deposits, interest accrued if the RLF is held in an

interest-bearing account, or late payment charges associated with loans.

- c. Enter **Other Explanation on Interest Earned:** For amounts received during the reporting period that are not described in a. or b. above. Add a brief explanatory comment as needed in the <u>Other Explanations on Interest Earned</u> box or attach an additional explanatory statement if you need more room for explanation. If not applicable entre "not applicable".
- d. Enter **Total Receipts:** Calculated all amount that a) loan repayments + b) interest earned.

Section 3) Enter **Balance Available**: This amount reflects the balance before obligations are deducted. Section 1: Beginning Balance+ Section 2) Receipts this period total receipts to show the balance before obligations are deducted.

Section 4) Obligations This Period represent discharges from the RLF during the reporting period.

Enter **Administrative Cost**: Enter the amount of any eligible revolving loan fund administration costs paid from the revolving loan fund.

- e. Administration cost is up to 1% of Total Receipts [Section 2) d)] during the time period.
- f. If Administration Cost exceed this 1% limit amount for any reason, provide a brief explanation to clarify the situation and the percentage charged.

Enter **Loans**: This amount represents new loans originated during the reporting period using funds from the RLF on Section 4) b). Only report the fundings amount of loans without the administrative cost

Enter **Total Obligations**: Enter the number from the addition of Section 4 a) Administrative Cost +b) Loans] to show remaining balance for the time period.

Section 5) Enter **Ending Balance**: Subtract Section 3 Balance available minus Section 4) c) Total Obligations]. The number should reflect the end of period balance in the local RLF, this is the total amount of funding that is eligible to be re-loaned out.
