

# **CenterPoint Electric Rates**

<u>CenterPoint Energy</u> customers can comment on the utility's electric rate request at a late February IURC hearing in Evansville or in writing through early March. The utility's \$118.8 million proposal would raise annual revenues over three phases to be fully implemented in 2026.

#### **Public Field Hearing:**

The IURC has scheduled a public field hearing in this case for Thursday, Feb. 29, at the Old National Events Plaza (715 Locust Street, Evansville) in the Locust Room.

The hearing will include 2 sessions: an afternoon session beginning at 2:00 p.m. local time, and an evening session beginning at 6:00 p.m. local time. No final decisions about the case will be made at the hearing.

OUCC attorneys and technical staff are reviewing the utility's request and are scheduled to file testimony on Mar. 12. A Commission order is expected later this year.

Natural gas rates are not at issue in this case.

# NIPSCO Natural Gas Rates

The OUCC is recommending an \$81.1 million reduction to <u>Northern Indiana Public Service Company's</u> (NIPSCO's) requested gas rate increase. The utility is requesting a \$161.9 million increase to its natural gas base rates.

Most of NIPSCO's request is attributable to new transmission and distribution improvements, most of which have been approved in previous Commission cases.

While reducing the utility's request by more than half, the OUCC's recommendations would also keep NIPSCO's monthly residential customer service charge at its current \$16.25 level. The utility proposes raising the charge to \$25.50.

NIPSCO rebuttal testimony is due Feb. 28 with a Commission order expected this summer. Electric rates are not at issue in the case.

### **Additional Cases**

- In January, NIPSCO filed supplemental testimony revising its proposal to build and operate a
  new power plant at the Schahfer generating site near Wheatland. The proposed 400-megawatt
  natural gas-fired plant would partially replace the existing Schahfer coal-fired facility which is
  slated for retirement. The OUCC is scheduled to file testimony on March 26.
- The Indiana Court of Appeals has upheld the IURC's most recent rate order for <u>Community Utilities of Indiana</u>, which serves parts of four northwest Indiana counties. The order significantly reduced the utility's requested water and sewer rate increases.
- The OUCC has filed testimony recommending reducing <u>Marysville-Otisco-Nabb Water</u> <u>Corporation's</u> rate request from 63.9% to 29.1%.
- Public comments are invited in the Edwardsville Water Authority rate case through Mar. 28.
