
OUCC'S MOTION TO MODIFY PROCEDURAL SCHEDULE
(Unopposed)

The Indiana Office of Utility Consumer Counselor (“OUCC”) requests the Commission modify the procedural schedule in this matter as follows:

1. The OUCC and all intervenors are scheduled to file their testimonies on January 8, 2016 and Petitioner is scheduled to file any rebuttal testimony on January 29, 2016. A final evidentiary hearing is scheduled for February 17, 2016.
2. Within the past three weeks and over the course of the next two weeks, the OUCC’s Water/Wastewater Division has had or will have to file testimonies in more than six cases, five of which are rate cases. Due to the number of filings, the OUCC will be unable to file its testimony on January 8, 2016 without undue hardship.
3. The OUCC requests a modification of the procedural schedule whereby it, as well as any intervenors, would file its testimony on Tuesday, January 12, 2016, Petitioner would provide any rebuttal on February 2, 2016, and the final hearing would still take place as currently scheduled February 17, 2016. Counsel for American Suburban Utilities and Intervenor have agreed to the modification as proposed without review of form of the motion.

WHEREFORE, the OUCC requests that the Commission revise the procedural schedule for this Cause in accordance with the dates set forth in paragraph no. 3 of this motion.
