By agreement of the parties, CWA Authority, Inc. ("CWA Authority"), CWA Authority Industrial Group ("Industrial Group"), and the Indiana Office of Utility Consumer Counselor ("OUCC") (collectively "the Parties") respectfully request an extension through, and including, Thursday, January 28, 2016 for the OUCC and Industrial Group (collectively "Consumer Parties") to file their respective cases-in-chief.


Pursuant to the Commission's Docket Entry dated January 15, 2016, the Consumer Parties were granted a one business day extension from January 22, 2016 to January 25, 2016 in which to file their respective cases-in-chief. That same Docket Entry extended CWA Authority's rebuttal, and the Consumer Parties' cross-answering, filing dates to February 22, 2016.

The reason for the requested extension is that the Parties have been engaged in settlement discussions, and request the additional time to continue pursuing those negotiations.

At this time the Parties are not seeking further modification of the procedural schedule in this Cause. The Parties, however, respectfully notify the Commission that they may seek such a modification depending on the outcome and timing of the negotiations.

Counsel for the OUCC is authorized to indicate counsel for CWA Authority and the Industrial Group have reviewed this Joint Motion and agree to its content.


