

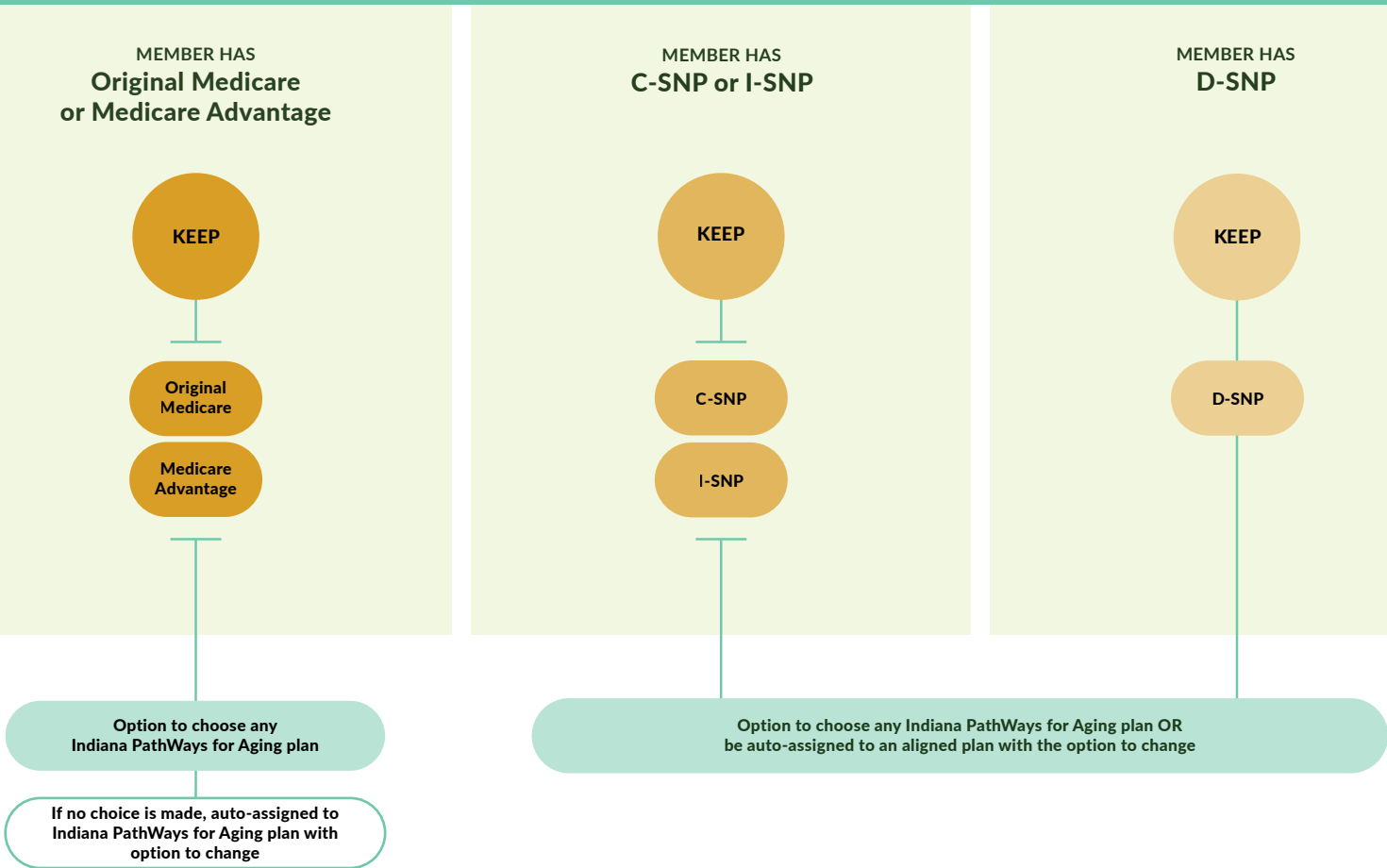


Dual Eligible Enrollment Options

AT LAUNCH: JULY 1, 2024

Effective July 1, 2024, Hoosiers age 60-plus who receive Medicaid will transition to Indiana PathWays for Aging (Medicaid), Indiana’s Medicaid managed care program. Indiana PathWays for Aging allows members to choose a health plan and get coordinated care on *their* terms, with greater independence and access to all the benefits they are qualified to receive at home and in their community. Some Indiana PathWays for Aging members are dually eligible and qualify for Medicare and Medicaid:

Indiana PathWays for Aging Members Choose How They Receive Care

1. Members can **select an Indiana PathWays for Aging Managed Care Entity (MCE)**: Anthem, Humana or United Healthcare. Members who do not choose an MCE will be assigned to one, with the option to change.
2. Members may **change their Indiana PathWays for Aging health plan** before the effective enrollment date, within 90 days of enrolling, or annually after that.
3. Dually eligible Indiana PathWays for Aging members may **choose how they receive Medicare benefits**: Original Medicare, Medicare Advantage, D-SNP, C-SNP or I-SNP.
 - Medicare choice is primary, and only the D-SNP option has program integration with Indiana PathWays for Aging.
 - *Effective January 1, 2025*: If an Indiana PathWays for Aging member chooses to enroll in a D-SNP, the selected **D-SNP and Indiana PathWays for Aging MCE must align**, which means they are affiliated with the same parent organization.
