Mr. Andree appeared before the Board to discuss the positive response on his initial application for licensure in the state of Indiana.

Mr. Andree indicated that during the time that he was in high school and in early college, he made some bad decisions regarding drugs and alcohol. He indicated that his major problem has been with cocaine and that he had a lesser problem with alcohol. He indicated that he currently does not engage in any formal support for addiction, but does have a strong support structure in place at home and at his employment. He underwent an intensive outpatient program in Bloomington, Indiana at Amethyst House for cocaine abuse after being arrested for possession of cocaine. He indicated that he successfully

completed this program and the drug charges were later dismissed. He indicated that he was not aware of what his specific diagnosis was.

He is currently employed with Hoosier Veterans Assistance Foundation with Bryan Dysert as his LCSW supervisor.

#### F. Presentation from ICAADA

Craig Andler, Director for ICAADA, presented to the board regarding an opportunity for his program to allow individuals graduating from a Masters addiction counseling program to take the examination at the time of graduation rather than waiting until they are submitting a licensure application with the board. Mr. Andler requested that in these cases the board accept the scores at the time of application, even though the exam would have been taken two years prior to application. Mr. Andler confirmed that the applicant would be taking exactly the same examination required for licensure through this program. The Board indicated that this proposed program would be acceptable and the board would accept the examination at the time of application.

#### IX. ADMINISTRATORS' REPORT

Mr. McGee informed the Board that there were no bills currently pending in the state legislature which would directly affect the Board, other than the Art Therapy bill previously discussed by Juliet King. Mr. McGee indicated that there was a bill pending which would include mental health professionals into the group who could be held criminally responsible for engaging in child seduction.
