Notice of the hearing was published in the Indiana Register on January 8, 2025, as well as the full text of the proposed rule.

The purpose of this hearing was to hear public comment regarding LSA Document 24-616 concerning fees, fines, and civil penalties that may be imposed by Indiana Speech Language Pathology and Audiology Board. All those who address the Board were requested to give their names and addresses for the purpose of the record and this hearing. Only those who address their comments to the chair will be recognized. Individual public comments shall be limited to 3 minutes in length. The Board will consider all comments made at this hearing in deciding what action to take on the above-mentioned rule.

Upon adoption by the Board and approval by the Attorney General and Governor, said rules will become effective 30 days after filing with the Indiana Register.
