Ms. Wall mentioned that they may want to consider having a practicing pharmacist as part of the working group.

Mr. Palombo as well as Tara Teachout appeared on behalf of Express Scripts regarding this matter.

Mr. Palombo appeared originally before the Board regarding this matter at the July 2016 meeting.

They currently have had the same work at home model approved for technicians in the states of Arizona for the past five (5) years; New Mexico for the past three (3) years and New Jersey for the past eight (8) years with no problems.

The technician must have at least six (6) months of employment before they could be considered for the work at home program. Only employees who have demonstrated the ability to work independently and have shown consistent above average performance will qualify for the work at home program.

The technician will work at home in a controlled environment. No data resides on the computers and they are not able to print anything from it. Basically, they will be doing data entry from home. A pharmacist will double check the technician's work before moving the order forward to be filled.

Donna Wall indicated that the Board can work with IC 25-26-13-4(c) Variance to rules to see if they can allow a pilot project. Variance is a pilot program that the Board has some control over.

They discussed that it will be only technicians living and working in Indiana and that the Board's Compliance Officers can go in and do an inspection of the home work site.

The Board must give public notice, therefore this matter will be placed on the April 10, 2017 agenda.

The Board thanked Mr. Palombo for the presentation.

856 IAC 2-7-5 says in part:

(b) The following training is required:

(1) Completion of a comprehensive training program approved by the controlled substance advisory committee.

(2) Any additional training as required by the supervising veterinarian or site administrator.

(c) A veterinarian licensed to practice in Indiana, holding a valid Indiana controlled substances registration and federal DEA registration, must verify in writing that the employee has been trained adequately to store, handle, or use controlled substances. The written verification must be maintained at the facility in a reasonably retrievable manner.

(d) The limited permit holder or site administrator shall maintain documentary proof of training in a reasonably retrievable manner at the facility for review by an authorized official of any governmental agency charged with enforcement of this rule.

Under 35-48-3-2 Limited permits for entities operating animal shelters states in part:

(b) A humane society, animal control agency, or governmental entity entitled to receive a permit under this chapter must:

(1) apply to the board according to the rules established by the board;

(2) pay annually to the board a fee set by the board for the limited permit; and

(3) submit proof, as determined by the board, that the employees of an applicant who will handle a controlled substance are sufficiently trained to use and administer the controlled substance.

(c) All fees collected by the board under this section shall be credited to the state board of pharmacy account.

(d) Storage, handling, and use of controlled substances obtained according to this section are subject to the rules adopted by the board.

(e) Before issuing a permit under this section, the board may consult with the board of veterinary medical examiners.

Staff inquired what the approved training programs are. The Board stated they do not have a policy regarding this training.

#### **Level 2 – “Generalists” or “Community Pharmacy” – license would specify**

- Successfully completed a nationally accredited education/training program
- Pass a national psychometrically appropriate exam – if pass the retail only exam – they can work in community retail pharmacy; if they wish to move to a different environment they must take the PTCB. If pass PTCB they can work in all pharmacy environments.
- No tech to pharmacist ratio
- Require 20 hours of CE every 2 years with 1 of those hours in law

#### **Level 3 – “Specialist” –**

- Proposed three (3) areas of specialty – Compounding, Pharmacy Management and Patient Care Specialist.
- Extended training beyond level 2. Cannot move from level 1 to a level 3. Board can determine what certification or additional training is needed.
- Require 30 hours CE with 1 of those hours in law and 3 hours in their specialty
- Under Pharmacy Management – tech can be pharmacy manager however cannot over rule a pharmacist on any patient care issues
- Patient Care Specialist – tech check tech, but only check level 2 techs. Level 1 always under a pharmacist. Works with pharmacists to collect patient specific clinical data, give immunizations, provide other areas of simple patient testing (BP or glucose or INR) or possible education

All technicians would take and pass a law exam.

Mr. Covington informed the Board that this would take a legislative change.


