## Statistics Reporting Mechanism

The Committee reviewed the various statistics necessary for the Midwifery Committee to report to the Indiana State Department of Health and the Medical Licensing Board of Indiana.

- Births
  - Live births
  - o Still births
  - Deaths
- Scope of care
  - Number of weeks of prenatal care provided
  - Number of weeks of postpartum care provided
- Referrals
  - Number of transfers to hospitals
  - Number and type of referrals to physicians for cause
  - Number of transfers to other providers
- Outcomes
  - Number of mothers breastfeeding after 6 weeks
  - Number of infants/mothers referred for cause after birth

The Committee also requested reaching out to the Indiana State Department of Health and the Medical Licensing Board of Indiana to see if they need any additional statistics.

# **Review of Application Process**

To date, 7 midwives have been licensed with 2 pending applications. There was discussion about changing the expiration date, but it was decided to leave it at March 31, 2019 to coincide with the annual reporting requirements for midwives.

## **Birth Certificates and Forms**

The Committee discussed their interest in being added to the birth certificate worksheet, version 30, utilized by the State Department of Health. The midwives indicated their profession needs added to the description of where pre-natal care was received and the attendant. They also need access to the Genesis system.

There being no further business, the meeting adjourned at 10:15 a.m.
