B. Electronic Data Processing System – Scriptly (856 IAC 1-29-1)

a. Privately held company seeking board approval. Competitors include Red Sale, Pioneer. Can support both retail and mail order pharmacies. It is possible to track a single profile across the system. Provided a prepared packet for the board. Work with various EDIs. BOP staff to determine how many Electronic Data Processing Systems are currently approved. Referenced DSCSA compliance/compatibility. Working in Illinois, Kentucky, California, Main and Arizona currently based upon customer demand. Provides own customer service. First platform went live 4/1/2021. No reported security breaches.

b. Motion to approve Meador/Bunton 7-0-0, motion carries.

C. CSR Principal Place of Business – IC 35-48-3-3(g)

a. Discussion about DEA and CSR language. If two adjacent connected buildings had separate addresses, DEA required a separate license. What does Indiana require? DEA used to issue exception letters if requested but no longer does so. Indiana Code references, "principal place of business." It's the board's responsibility to determine what "principal place of business" means.

Cody Drug – Non-Resident Pharmacy Application

Will Douglas, owner of Cody Drug, appeared before the Board regarding their non-resident pharmacy application. Registered as a 503A (all patient specific). Asked if still compounding tirzepatide. Discussed the shortage list regarding tirzepatide. According to Will Douglas, some attorneys state Cody Drug is not essentially copying this product. This is not all that Cody Drug compounds. Not a fly by night operation for GLP1s. Also compound, HRT (non-sterile), ED, longevity, veterinary. Compound both sterile and non-sterile compounds. No testosterone or injectable testosterone. Uses a third party for Environmental Reports (need last 2). Also needs training documentation. Don't need 795 and 797 procedures. Not on probation or been denied in any other state. BOP believes compounding tirzepatide after the shortage ending can't be compounded for Indiana residents. Discussed Texas's required pharmacy technician training program requirements. Two or three Indiana clinics are interested in using Cody Drug if licensed.

Dispensed in a blister pack. Nurse on duty at the facility is an RN five days/week. Discussed how the Controlled Substance is dispensed during non-medically covered hours. Jail staff administers medicine twice/day. Use a medication cart.

Based out of northern Kentucky. Do have physical locations in Indiana. BOP inspected the Daleville facility. Do have passing inspections for Bloomington and Mishawaka

locations. This inspection failed because our Inspector could not get into the facility. Discussed referring the matter to the OAG. Board counsel advised that the board could issue a Cease and Desist or denial. Stacey Parker clarified that this is strictly an off-site storage warehouse facility. All purchasing and distribution is done in Indianapolis. This includes all record keeping. Zaneta clarified that if they are seeking to license this facility, inspectors would be required to have access to personnel files. Discussed the options available to the board including approving the second inspection and referring to the OAG.

After discussion, the Board moved to approve the application pending a passing inspection.
