She was placed on a work improvement plan for thirty (30) days to turn her attitude around as she was management, and they felt she was setting a bad example.

She started a new position on February 28, 2023, and hasn't had any issues with her current position.

<u>Jairo Rodriguez, P.A., Initial Application – Positive Response</u>

Mr. Rodriguez appeared virtually with camera before the Committee and was not represented by counsel regarding a positive response on his initial application.

He explained that from 2008 to 2013 he worked in the same practice, he was one (1) of two (2) physician assistants that covered for the pain management providers.

A patient overdosed on pain medication that he had prescribed. Patient took three-fourth's (3/4) of a bottle of pain medication with a half (1/2) bottle of Vodka and Xanax prescribed by her family physician.

It was determined that his standard of care was good and in 2014/2015 the case was dropped.

In 2019, Nevada reopened the case, they gave him two options; he could go to trial with costs possible up in the \$100,000 or accept a public reprimand and pay a fine. He took the reprimand/fine option.

In 2022 he applied for a Texas license and based upon the Nevada action, they approved his license, but he must send them quarterly reports to his compliance officer.

He is currently practicing in NY full time and wants to do telehealth in Indiana.

He is also fully licensed in the following states: NV, NY, CA, FL, TX, PA, OH, WI, MI and IL.

He also completed the Vanderbilt course for proper prescribing of controlled substances. He stated he hasn't prescribed any controlled substances since 2020.
