Currently unable to prescribe controlled substances as pharmacy board suspended CSR for 90 days.

Kendra Reyes – Human resources director for Clarion – former employee of Dr. Sheets in June 2023, was only employed for a couple weeks. Worked primarily as office manager – testified as to what she witnessed with regard to CSR prescriptions. Paid by office via W2. Also, she was prescribed Adderall by Dr. Sheets for weight loss. About 40-50

Jamie Scholl – Works as an LPN for the last four (4) years. Worked at a long-term care facility where she worked for Dr. Sheets 2013-2017 then was employed for Dr. Sheet's office for 7-8 years. Rarely ordered urinary drug screens (UDS)on patients. Continued to prescribe even after UDS came back showing positive for drugs unprescribed. Described being present during liposuction in the office

Jennifer Jordan - Is currently a student studying social work. Was a patient of Dr. Sheets about 2015 then became an employee about 2017. Worked as a Medical assistant in the office, was licensed as a CAN. August 2023 resigned. Continue to be a patient after she became employee, was prescribed Adderall and Xanax.

Regina Sheets – Respondent's wife, currently going through a divorce. Lived in/shared a house with respondent. Shed on property had medical records stored inside, provided photos as an Exhibit 1.

Jody Malone – LPN, worked with Dr. Sheets at the nursing home where Dr. Sheets was the medical director. Later became employee at his practice. Testified that Dr. Sheets asked her to change patient notes by adding additional notes for files related to prescribing, stated that he "may be in trouble". Reported this to the police.

Dr. Sheets – Physician for 28 years, states that some of the witnesses were fired for stealing and that he filed police reports. No charges have been filed, has been unable to file civil suit as he cannot find anyone to take his case.

Key fob/random password generator was used to store prescriptions and was occasionally left outside in a mailbox. Was given to employees on occasion.

A motion was made and seconded to DENY summary suspension for ninety (90) days.
