Case Summary: On or about July 23, 2024 the Board denied Dr. Adam's request to renew his license. On or about August 12, 2024 Dr. Adam's submitted a request to appeal the Board's decision. He indicated that he was currently incarcerated at the time of his renewal appearance but was represented by counsel. He provided the Board an update on his current criminal matters, and discussed how it did not impact his practice as a dentist. He discussed the steps he has taken to ensure that a similar situation does not occur.

Dr. Burke was called as witness. She attested to Dr. Adam's character as a professional colleague who has worked with him.

Rebecca "Becky" Sprague was called as witness. She attested to Dr. Adam's character as a dental office manager.

The Board took notice of the exhibits on file for review which include copies of the current court records, and letters of recommendation.

Mr. Robertson stated that he is aware of the Board's concerns regarding the charges as they do fall under the convictions of concern laws; however, he indicated that there are mitigating circumstances for the Board to consider in Dr. Adam's case.

**Board Action:** A motion was made and seconded to grant Dr. Adam's appeal and approve Dr. Adam's license renewal on probation with the following terms:

- Indefinite probation for the duration of the criminal terms.
- 2 Compliance officer visits while on probation for the first year, and upon the Board's request for the following years if still on probation.
- Personally appear every other meeting while on probation.
- Follow all terms of the criminal terms set forth by the courts.

The Board discussed if tele-dentistry would occur, Mr. Smith indicated that it would not. He stated that an Indiana dentist would be present for all events, and if one was not available the event would be cancelled.

**Board Action:** A motion was made and seconded to deny Dr. Negrescu's application for dental licensure.

#### 2. Madison Struck, LDH – LA Permit

Ms. Struck's application for a dental hygiene anesthesia permit was submitted for review of her anesthesia training documentation. The Board noted that the documentation submitted does not show she has met the requirements. Her program will have to submit a letter that outlines what she has completed.

Ms. Struck's application was tabled.

## 3. Divija Takkalapelly (DDS)

Dr. Takkalapelly's application for dental licensure by examination was submitted for review. Dr. Takkalpelly graduated in 2008 from the NTR University of Health Sciences which is a nonaccredited college. He completed a post-doctoral program at the Georgia School of Orthodontics from 2021 to 2024. The Board discussed if the two-year program meets the statutory requirements. The applicant must show completion of one of the following: (a) An accredited institution that reasonably ensures a level of competency equal to that of graduates of accredited dental colleges, as determined by the board; (b) A general practice residency program at an accredited institution; (c) Advanced education in a general dentistry program from an accredited institution. Based upon review it does not meet the statutory requirement.

**Board Action:** A motion was made and seconded to deny Dr. Takkalapelly's application for dental licensure.
