# IX. Personal Appearances

- 1. Heidi King: King's license expired in October 2009. She has been licensed in Illinois since that time. King responded "Y" to question #5. She had a conversation with a patient and his wife that was seen as speaking out of turn. Because of what was said and their feelings, the patient and his wife said King breached HIPAA. She got into his charting system even though he was not her patient at the time. They had become friends and his wife would text her whenever he was back in the hospital. King had a HIPAA violation for misusing confidential information (she had talked about a patient in another patient's room) in 2016. King's employer terminated her on the spot after she had been working there for about 5 years. After King was let go, she stayed home, but kept her license active. King worked briefly as a birth assistant for a midwifery clinic and last worked as a nurse in 2016. There was a motion made and seconded to not reinstate the license until proof of completion of an RN refresher course with a clinical component. Cooper/Morris. 6-0-0
- 2. Lanah Adams: Adams' reinstatement application was submitted in March 2021 after her license expired in October 2020. Adams was under the impression based on conversations with her manager at Creekside Health and Rehab, that she had a license because of the Covid expansion. She was also fired from her employer because she was very sick and had to be admitted to the hospital. She believes it was either December 2020 or January 2021 that she was fired. She was in the hospital starting December 21, 2020, for three days. A motion was made and seconded to renew free and clear and refer to the attorney general's office. King/Murphy 5-1-0

- 3. Ashly Kern: Kern applied for a compact license and answered "yes" to a question about a criminal matter. Her minor children were home alone, and she was involved in a child services investigation. She signed a pretrial diversion agreement that said that as long as she was not in any other trouble, the court would dismiss the charges. She just signed the pretrial diversion agreement last month, so she still has a year. A motion was made and seconded to deny the compact application. King/Cooper 6-0-0. The aggravating factors included an absence of transparency, the level of the felony charges, and overall poor judgement.
- 4. Eli Chadwick: Chadwick gradated nursing school in May 2020. Chadwick has failed the NCLEX 3 times. She took ATI but did not receive a green light. A motion was made and seconded to allow Chadwick to test one more time and Chadwick must enroll in an NCLEX review course that will provide a 95% predictability score or greater. Cooper/King 6-0-0
- 5. Kari Horner, Horner graduated MedTech College in Fort Wayne on April 16, 2011. She has failed the exam multiple times. She did not pass any client needs categories and had the minimum number of questions. She recently completed a review course, but she did not pass after completion. A motion was made and seconded to deny the application. King/Newkirk 6-0-0. The aggravating factors included the time period, number of questions she is earning, and how many of client needs categories that were below standards.
- 6. Terika Travis: Travis graduated in December 2019. She already an LPN. She has taken NCLEX 3 times and failed. She last tested in April and had 145 questions. She passed 2 client needs categories. In previous attempts she got 130 and 75 (first time). She is currently enrolled in Kaplan, and she has been given until September to finish the course. A motion was made and seconded to allow her to test after completing a review course that would provide her with a 95% predictability score. Cooper/Morris 6-0-0
- 7. Chelsea Johnston: The Board denied the recommended order that was issued after her previous personal appearance. Her last arrest was in 2014. She was chosen for the Student Nurse Academy while in school. She has had stable employment, only switching for a raise. She is currently employed at Deaconess as a Graduate Tech and has never had any discipline at work. Initially, it was recommended that she be placed on probation because of the volume of criminal history and how she handled dealing with authority figures. A motion was made and seconded to issue free and clear. King/Newkirk 6-0-0.
- 8. Steven Armstrong: Armstrong submitted a reinstatement application. His IN license is expired, but he got licensed in KY and has been practicing since the expiration. He had previous DUIs (2006 & 2007) that were previously reported to the Board. In 2018 he was pulled over for a DUI in KY. He hit a parked car in his neighborhood. Armstrong says he only drinks occasionally. On the night of the accident, he had been at a party and then took an Uber home. Then he went out to eat and that's when the DUI occurred. He was assessed in 2019 as part of a court order where the recommendation was that he did 16 weeks of alcohol education, which he completed. He also had a breathalyzer in his car for 16 months. All charges have been resolved. Armstrong is applying for licensure because he moved to New Albany, Indiana. His KY license is active and unencumbered. A motion was made and seconded to reinstate his license free and clear. Morris/Murphy 5-1-0
