1. Jennilee McFarland

Ms. McFarland appeared for an application with a positive response. She had an OWI conviction. She presented evidence of meeting with a mental health counselor and compliance with her court order. She reports attending AA meetings to keep up with her recovery. She reported having insight into and regret for her actions. Her criminal probation is due to end in January 2026. Kaniewski appeared for a positive response related to a criminal case for a domestic issue. The case resulted in a year-long pretrial diversion which was completed in 2022. He failed to disclose the arrest on his 2022 renewal. He reported the failure to disclose may be due to a substance use issue at the time and reports that he has since been to rehab. ## Consideration of Application for Funeral Director license by Reciprocity

1. Scott Rolfes

Rolfes appeared to speak to his application based on his licensure in Ohio, where he has been licensed since 1998 as a funeral director and embalmer. His original passing score on his national examination was lower than the Indiana passing score. He still lives and works in Ohio but is working for a company that has a location in Richmond. Because Ohio requires the national boards, and he received a passing score based on their requirements, the board was comfortable issuing the license. A motion was made and seconded.
