**INSPECTOR CALVERT DISCUSSION REGARDING BEAUTY CULTURE SCHOOL FLOORPLANS, MICRONEEDLING AND MICRO CHANNELING**

1) Inspector Calvert asked the Board if beauty culture schools need all workstations in one room or can they have workstations in multiple rooms?

Based on the rule that schools need one instructor per 20 students, schools may not separate stations in multiple rooms. Also, with the wording in the administrative rules indicating "A classroom" and "A laboratory/clinic floor", beauty culture schools cannot use multiple rooms.

2) Inspector Calvert would like staff to send the assigned inspector the floorplan for the inspection of a new beauty culture school .

3) Microneedling: It was the determination of the Board that microneedling is not the practice of beauty culture. The Board would like staff to ask the Medical board to make a determination as to whether it is a medical procedure or not.

4) Micro Channeling: (vibration therapy, no needles used) The Board determined this is not included in the practice of beauty culture.

11. **Probation** - OVLKD LLC 4206800 – Personal License of owner on probation – old salon stated released from probation but his Personal still shows probation.
12. **Denial** – Uptown Nail Salon LLC 4221070 – Failed Inspection, unlicensed workers, fraudulent licenses, unsanitary conditions, bribery.
