DISCUSSION

Open Door Law: The Committee requested Ms. Schuster to explain the open door law as it relates to the Committee and any sub-committees they may form.

Ms. Schuster explained that any decisions made by Committee members must be done in public forum. Sub-committees may be established to discuss/work on certain things, but they must be done here and in public form. These must be posted on an agenda on the website as well as outside the office.

The Committee thanked Ms. Schuster for her information.

<u>Peer Review:</u> The Indiana Midwife Association or the North American Registry of Midwifes (NARM) constantly does community peer reviews.

They do routine basic community peer review for educational betterment of the community. They try to have four (4) to five (5) a year. They make the announcement on line. They do not keep any formal minutes and shred all notes after it's complete.

They also do them if a complaint has been lodged. There isn't a way to ensure their decision on a complaint is binding. NARM has the ability to resend credentials. On the disciplinary peer reviews they do keep some records locked up. They keep record of any grave concerns and/or where any harm has been done.

Oregon has a good functional peer review. Nicole indicated she would do some legal research on how to get peer review.

Mary Helen Ayres submitted a peer review draft which is based primarily on NARM's peer review, complaint and grievance process.

After reviewing and discussing the draft Mary Helen submitted the Committee moved to ACCEPT the draft pursuant to any additions and research that Ms. Schuster is going to do.

<u>Clarification of observations:</u> The Committee discussed that it looks like the intent of the law is for 20 observation births; 20 births directly supervised by a physician; 20 birth assists; 20 births as primary attendant.

They discussed specifically the 20 births directly supervised by a physician – they felt this would be while they were acting as a Dula; providing information to a patient.

Looks like their intent was for a total of 80 births and the Committee requested Nicole Schuster to get a more formal opinion

Let the record reflect that Diane Holmes did not participate in the rest of the meeting.

<u>Conditions requiring referral or transfer:</u> A list of prenatal, intrapartum, maternal postpartum and newborn postpartum conditions was given out to all members at the May meeting.

The list was also approved by the Committee at the May meeting.

In discussing this list again, the Committee indicated they need to add fetal demise to the list also. The Committee moved to add 'Fetal Demise' to the list.

Ms. Fagan indicated she felt that under the prenatal conditions number ten (10) that states "Current substance abuse know to cause adverse effects" the 'know to cause adverse effects' should be taken off and it should just read 'current substance abuse'. She also indicated that chronic urinary tract infections should be added

<u>Collaboration recommendations:</u> Maryann Griffin and Dr. Wagoner passed out results of a survey they sent out asking physicians if they would be willing to sign a collaborative agreement with a midwife.

Results: Dr. Wagoner indicated he sent the survey out to seventy-five (75) physicians and of those only twelve (12) responded. Of the twelve (12) only one (1) indicated they would sign the agreement all others said no they would not. Of the one's that said 'no' two (2) were concerned with liability issues; one (1) indicated it must be approved by his employer first; three (3) were not in favor of having CDEM's period; one (1) was retired and no longer practicing and five (5) did not indicate a reason why they said no.

Maryann Ayres indicated she sent a survey out to twenty-five (25) physicians and of those twenty (20) responded. Of the twenty (20) only (1) indicated they would sign the agreement all others said no they would not. Of the ones that said 'no' three (3) were concerned with liability issues; twelve (12) indicated their employer/hospital would not allow it; two (2) were not in favor of having CDEM's; three (3) simply indicated they were not willing to sign it. Clearly physicians aren't willing to sign the agreements

Kathy Williams, Lobbyist joined in on this discussion and asked the Committee do you think a physician would agree to collaborate if they didn't have to sign a collaborative agreement?

The Committee discussed Kathy's statement and stated that maybe physicians would be willing to collaborate if they only had to register with the Medical Board. They decided to do a new survey putting this in the survey vs the collaborating agreements.

After much discussion, the Committee moved to TABLE the legislative discussion to the next meeting.
