Respondent Director's funeral director license, FD01015193, shall be placed on INDEFINITE SUSPENSION, without the right to petition for reinstatement for SIX (6) MONTHS from the date of this Final Order.

Further, Respondent Facility's current probation, as imposed in the Board's license renewal order on April 13, 2023, shall be MODIFIED. Respondent Facility's funeral home license, FH19900032, shall remain on INDEFINITE PROBATION, without the right to petition for removal of probation for ONE (1) YEAR from the date of this Final Order.

Respondents' discipline shall be subject to the following terms and conditions:

I. Obey All Laws

Respondents shall obey all federal, state, and local laws, including those rules relating to the practice of funeral service in Indiana.

II. Continuing Education

Within SIX (6) MONTHS from the date of this Final Order, Respondent Facility shall submit proof that each of its associated funeral directors, including Respondent Director, have taken the Indiana Funeral Director Association's Crash Review Course.

Such continuing education credits shall not count towards the total number of credits required to maintain licensure.

III. Reporting and Personal Appearances

Respondents shall continue to submit QUARTERLY REPORTS according to the terms set forth in the Board's license renewal orders of April 12 and 13, 2023.

Respondents' obligation to make quarterly personal appearances as set forth in the Board's license renewal orders shall likewise remain in effect for the duration of their discipline.

IV. Obligation to Cooperate and Resolve

For the duration of their discipline, Respondents shall have an obligation to cooperate with any and all OAG investigations into consumer complaints filed against them. Respondents shall make all reasonable efforts to resolve such complaints to the satisfaction of the consumers involved.

This obligation includes the submission of written responses to consumer complaints, where requested, and the production of any subpoenaed documents.

V. Designation of Managing Funeral Director

Respondent Facility shall have the obligation to designate a new managing funeral director with the Board for the duration of Respondent Director's suspension. Such designation shall occur according to the procedure set out in Board's statutes and rules regarding managing directors.

VI. Civil Penalty

Prior to petitioning for reinstatement, Respondent Director shall pay a civil penalty of five thousand dollars (\$5,000.00). prior to petitioning for withdrawal of probation, respondent facility shall pay a civil penalty of two thousand five hundred dollars (\$2,500.00).

VII. Fee

Pursuant to Ind. Code § 4-6-14-10(b), Respondents shall each pay a fee of five dollars (\$5) to be deposited into the Health Records and Personal Identifying Information Protection Trust Fund.

VIII. Maintain Active Licenses

Respondents shall maintain active licenses for the duration of their discipline.

IX. Pass IPLA Inspection

Prior to petitioning for withdrawal of probation, Respondent Facility shall request and pass another IPLA inspection.

X. Reinstatement and Withdrawal of Probation

Respondents shall be responsible for petitioning the Board for reinstatement and removal of probation. Respondents must pay all fines and fees in full prior to petitioning for reinstatement and removal of probation.
