PERSONAL APPEARANCE

Katherine Ann Campaneria – Positive Response – Initial Application

Katherine Ann Campaneria appeared before the Board to discuss her positive response on her application. She has multiple criminal occurrences in North Dakota. She is currently on criminal probation in North Dakota. She resided in North Dakota with a limited support system so became in a depressive state and began to drink. She was in an abusive relationship while in North Dakota. She admitted to making poor decisions while living in North Dakota. In October 2024, she was in Texas, had a terrible job, bad relationship. She has applied for a job in Indiana, contingent on obtaining her athletic trainer license. She last worked as an athletic trainer in September of 2024. Her BOC is current. She is current with her continuing education. She is currently an active member of AA and plans to continue. She did receive at least 6 speeding tickets and has a suspended license in North Dakota. She is looking for a fresh start and second chance now in Indiana. She will be on alcohol monitoring while on criminal probation, as well. She provided a proposed plea deal, that is not a final order
