#### VI. Education

1. Grace College BSN Initial accreditation site visit report – Kristen Richmond DNP, RN
Education Compliance Officer Toni Herron stated that Grace College was appearing for initial accreditation of the BSN program. The program was represented by Dr. Richmond, Dr. Bosch and Dr. Roberts. Ms. Herron explained to the Board that currently Grace College conducts the BSN as a satellite of Bethel University. After feedback from students, faculty, the community representatives Grace College have decided to conclude the cooperative agreement with Bethel and conduct the program solely on their campus. Board member Kim Cooper asked if the curriculum had been developed without the use of intellectual property from the Bethel program and how long that took. Dr. Richmond stated that a team of faculty and consultants built the curriculum independently over the period of seven (7) months. Ms. Herron stated that the College has been supportive by providing financial resources and identifying how the campus resources could be tailored to support the nursing program.

Grace College is requesting an initial cohort of twenty-seven (27) students, with the initial cohort to begin Fall of 2026 with program completion 2030. Didactic will take place on the Grace campus and all three (3) major health systems in the area will support clinical experiences.

After discussion, the Board voted to approve initial accreditation with the terms requested. Cooper/Sego 6-0-0.

2. Trine University initial site visit report for Fort Wayne satellite campus – Angel Jennings PhD, MSN, RN

Dr. Jennings, Dr. Clemens and Susan Rasmussen appeared on behalf of the program. Dr. Jennings stated that they are requesting approval of an additional site for the ASN program, mirroring the same program currently presented in Angola. The Board debated whether this would be a new program with a separate program code or a satellite of the Angola location. After discussion, it was decided that the board would approve the initial with separate ISBN number with cohort of up to 40 students. Request to make correction to syllabi to grading scale. Cooper/Sego 6-0-0.

3. Leffler Academy construction site visit report – Amanda Leffler DNP, RN Approve Cooper/Sego 6-0-0

Joy Reed and Dr. Amanda Leffler appeared on behalf of the program. Ms. Herron stated that Leffler was requesting approval of the addition of an annex to their current building that would accommodate simulation. Ms. Herron stated that pictures of the new area were available in

the Board's packet. This change increases the number of beds available for skills, creates new simulation rooms with a control room and offers space for student collaboration. This collaboration space is on the second floor and Dr. Leffler checked the building codes. She found that as long as the student requiring accommodation can be accommodated elsewhere in the building, it meets code. After discussion, Ms. Cooper made a motion to approve the construction and Dr. Sego seconded. Motion carries 6-0-0.

4. Jersey College substantive change request for PRN modality change – Melissa Chase MSN, RN Ms. Chase and Park Smith appeared on behalf of the program. Jersey College is requesting approval for a substantive change to deliver content virtually. They cite weather issues that make travel unsafe, and unexpected last-minute faculty absence due to illness or lack of faculty due to staffing issues.

After discussion, the Board voted to approve weather related issues and deny in the circumstance of faculty availability or staffing issues. Mitigating factors include continuity for students, all students are provided with computer on admission, faculty development, student training and prep has been provided. Cooper/Magers 6-0-0

- 5. Anderson University substantive change of modality for NURS 4470 Kari Bryan MSN, RN-CE Ms. Bryan appeared on behalf of the program. Anderson is requesting a substantive change to the manner that NURS 4470 is delivered. With the current schedule, it is difficult to accommodate nurse athlete's schedules, so they are requesting to move the course to online modality. Ms. Cooper stated that the students were not admitted with this understanding, so the request is denied for 2027 but approved the modality change starting in Fall 2028. The suggestion was made to look at different projects to fulfil their goal of the course. Cooper/Sego 6-0-0.

Mr. Smarella, Dr. Litteral and Dr. Foster appeared on behalf of the program. Ms. Herron related the current NCLEX results year to date. Mr. Smarella stated that they currently have 50 active students and the projected closure of the program is March 2026. This depends on student progression. Mr. Smarella stated that Fortis had hired a Director of Nursing but declined to name that individual. Dr. Litteral stated he is not physically present each week. He is onsite every other week. He stated he can be present if there are issues. The Board decided to continue to submit monthly written reports and to have them return in person in November after Quarter 3 NCLEX results are available. Board makes motion to Approve the report. She received all her pre reqs from NFU. Nursing school was Ideal. The nursing program was not a face-to-face program. She graduated in

- 2021. She is currently licensed in Hawaii. States she tested several times in FL. Deny the application because the school is from the FBI Watch List.
- 14. Evenise Alcide\*\*- Evenise Alcide is appearing for the RN by examination application. Evenise graduated from Sigma College 04/03/2019. Sigma is part of Operation Nightengale. Failed to appear. Denied.
- 15. Cassandra Louis\*\*- Cassandra Louis is appearing for the RN by examination application. Cassandra graduated from Sigma College and never submitted over education documents or stated when she graduated on the application. Sigma is part of Operation Nightengale. Failed to appear. Denied.
- 16. Rose Buteau\*- Rose Buteau is appearing for the RN examination application. Rose graduated from Techni Pro Institute. Techni Pro is a part of Operation Nightengale. Failed to appear. Denied.
- 17. Magalie Jules Stimphile\*\*- Magalie Jules Stimphile is appearing for the RN examination application. Magalie graduated from Medworld School of Nursing on 08/20/2022. Medworld is apart of Operation Nightengale. Failed to appear. Denied.
- 18. Celine Stinfort\*\*- Celine Stinfort is appearing for the RN examination application. Celine graduated from Techni Pro Institute on 12/20/2017. Techni Pro Institute is a part of Operation Nightengale. Failed to appear. Denied.
- 19. Carline Lespinasse\*\*- Carline Lespinasse is appearing for the RN endorsement application. Carline graduated from Revelation University on 06/24/2022. Revelation is a part of Operation Nightengale. Failed to appear. Denied.
- 20. Pierre Merzier\*\*- Pierra Merzier is appearing for the RN endorsement application. Originally applied by examination. You can see on nursys.com they are already issued by examination in OH. Pierra graduated from Revelation University on 06/24/2022. Revelation University is a part of Operation Nightengale. Failed to appear. Denied.
- 21. Melissa Pietraszak\*\*- Melissa is appearing for the RN reinstatement. Melissa answered yes to #3. Melissa's RN license expired in 2021. Melissa does hold an active license in KY. Melissa is appearing because she disclosed an OWI that she was not charged with until APRIL of 25. Has been a nurse since 2007. Last worked in KY as a nurse in FEB of 25. She worked for a Cath Lab. Was there for a total of 5 years. She left because she was burned out. In Jan. 2021, Melissa left around 1pm and went all the way from KY to IN. Melissa drank and drove and was pulled over for DUI. She had an accident. She slid into the center median. No other cars involved. No passengers in the vehicle. No injuries. She was convicted of an OWI. 6 months' probation. master's in education for communications that she finished in 2019. Always had held an active license in the Philippines just not practice as a nurse. Recommendation to allow to sit for the NCLEX examination.

- 25. Luvie Lewis- No show/reset.
- 26. Oluwatoyin Gbolabo- No show/reset.
- 27. Makenzie Johnson- Makenzie is appearing for the RN examination application. Makenzie answered yes to #3(abcd). Makenzie graduated recently from Ivy Tech. Makenzie received an OWI in JAN of 2025. She was sentenced to probation. Recently graduated in MAY of 25. Makenzie was pulled over for drinking and driving. She does not know blood alcohol level. It was a blood draw. Currently, on probation with Hendricks County. Had to 90 days with sober links breathalyzer. Speak out course. Alcohol counseling classes (20 hours). Still on probation with everyday random drug testing. Probation is set to be over in AUG or FEB depending on when she completes requirements. Previous arrest in 2018 for minor consumption. Recommendation to allow the license to be issued. Issue the license onto probation for at least one year. One year of active practice. Quarterly reports, signed board orders, updated demographics. Criminal probation needs to be completed as well. Recommend an ISNAP evaluation. Will need to enter into RMA. The length of probation will be either one year or the length of RMA. Leeza has previous charges from 2015 of possession of cocaine and possession of narcotics. Leeza has recent neglect of dependent charges. That matter involved her 14-year-old getting ahold of her gun and shooting himself in the leg. January 4th – 8th the applicant went to FL with her youngest. Her oldest children stayed home. Her 15-year-old was in her closet getting some money from a money jar. The 15-year-old found her clip of her gun. The son went looking for more parts of the gun and ended up shooting himself in the leg. She was told that DCS closed the case out, but then Leeza found out she was charged by the state for her son shooting himself. Neglect of a dependent resulting in bodily injury. Goes to court next in July 2025. The arrest before this was in 2018 for a failure to appear for a civil matter. The very first arrest in 2015 she was arrested for maintaining common nuisance and possession of controlled substance and possession of marijuana. Leeza states the drug was heroin. That the kids were going to school. Leeza did two years' probation and was off probation in 2018. In 2020, she had both felonies reduced to misdemeanors. - 31. Leah Mann- Leah is appearing for the RN examination application. Leah did not disclose anything on the application. Leah is appearing because she received a reckless driving charge very recently in 2025. She graduated recently from Ivy Tech in Fort Wayne. The weekend after

- finishing school it was the weekend of St Patty's. The arrest came after the application date. Drove her friend around and was pulled over for an OWI. Blood Alcohol was .087. The case is finished, and she is on probation. The probation will end on June 29th, 2025. Has no other prior arrest history. Just one speeding ticket. Would have ordered an uber in the future. Currently working at heritage point for about 2 years and then working somewhere else for 5 years for PRN work. Both locations are aware of the incident. Recommend issuing the license onto probation for a period of 6 months. With 6 months of active practice. Complete resolution of the criminal matter, quarterly reports, signed board orders, updated demographics. Mitigating Factors-Actively progressing through her probation, transparent, displayed learning and growth about the episode, positive history of employment 2 years for full time and 5 years for part time and both agencies know about the events.

Cahardae just recently graduated from Hondros. She was dating a man that coerced her into trafficking into the jail. She entered into a diversion program. She was coerced into bringing in tobacco to the facility he was incarcerated at. She would take the contents of the package and leave it on the side of the road for someone else to pick up and take it to the facility (jail/prison). She states she only did this act one time. A detective called her about the incident, and she was not arrested at that time. Then she was arrested later on. The case was dismissed. Currently, employed at Community Nursing and Rehab and has been there for a few months. Recommendation to allow Cahardae to test and issue the license free and clear. Mitigating Factors consistent employment, with Trilogy for almost a decade.
- 33. Zenaida Bowers- Zenaida is appearing for the RN-Compact application. Zenaida received a charge in 2024 for an OWI. Zenaida is still dealing with this matter. Zenaida answered yes to #3 (abcd). Currently, Zenaida has a violation of probation hearing on June 6th. Also shows another violation hearing on June 27th. Only been arrested twice her whole life. May 24th, 2025. The matter has been resolved. The licensee will be off of probation in SEP of 2025. The arrest was a DUI. Worked a 12-hour shift in the IR department of IU. She was driving by herself at the time. AA classes. 8-10 weeks of IOP. One other prior arrest that was in the early 2000s. There was marijuana in car, and she was taken to jail. She was in jail for 6 hours and the charge was dismissed. Tania is currently still completing requirements for the criminal charge. Tania was alone and driving and was pulled over for not turning on turn signal. Alcohol Blood level was .08. Tania had to do 3 months of interlock. One evaluation with counselor. It was recommended to finish one group counseling session. She has completed all probation requirements, and the probation is for one year. She learned to not drive while she's drinking. Recommendation to allow to test. Issue the license onto probation. Probation for one year or length of criminal probation. 1 year of active practice. Quarterly reports, signed board orders, updated demographics. Mitigating Factor apart of court order she did have to meet with substance abuse counselor and was evaluated.
