**VI. Education**

1. Vincennes University construction site visit report – Jill Chrispell DNP, MSN Ed., RN

Dr. Jill Chrispell and Nellie Jpnes appeared on behalf of the program. Toni Herron, Education Compliance Officer stated that Vincennes University in Vincennes had built a new building for the College of Health Science and Human Performance. Ms. Herron stated that faculty for nursing had been involved in the planning for the construction and that faculty stated that they had received everything they had requested in the design and buildout. Intentional thought was placed into meeting future needs as well as current needs. The building came in under budget which allowed the purchase of all new simulation equipment for the three (3) simulation labs. After discussion, the Board member Julian Gallegos made a motion to approve immediate occupancy and use and Board member Angela Morris seconded. Gallegos/Morris 8-0-1 King abstained from voting. Cooper still out of room.

2. Ivy Tech Community College request of substantive change for pre-admission process for students applying to the Ivy Tech Nursing Program through partnership cohorts - Dr. Stephanie Knox and Michelle Gonser MSN, RN

Dr. Stephanie Knox and Michelle Gonser appeared on behalf of the program. Ivy Tech is requesting a substantive change to the pre-admission process for students that apply to Ivy Tech after initial admission to a liberal arts college or university. Dr. Knox shared that Hanover College approached Ivy Tech Madison about the progression option to admit qualified students to Hanover where they would complete their gen ed/pre-requisites and upon successful completion, would enter Ivy Tech Madison to complete the ASN. After completion of the ASN, they would return to Hanover to complete coursework and earn a BSN. A separate number of seats would be identified for the Hanover students, in addition to the current number admitted each cycle. If the designated cohort of ten (10) Hanover students was not filled, Ivy Tech Madison could back fill with qualified applicants that had not been seated through the usual admission process. The opportunity to do this across the state with other Ivy Tech campuses, and other liberal arts colleges and universities was discussed. After discussion, a motion was made to approve the request by Ivy Tech Madison with Hanover College for an initial ten (10) students in the Hanover cohort. Dr. King made the motion and Board member Rena Magers seconded. Motion passes 8-0-1 (Cooper abstained)

Further discussion revealed insufficient data existed to approve the concept to be initiated at other Ivy Tech campuses. When more data is available, the program may return for consideration of the option. Board member Dr. King moved to deny and Board member Emily Sego seconded. 8-0-1 (Cooper abstained).

Aggravating factors: She has been out of nursing longer than she was in, stepped away in 2011, lengthy involvement with cocaine, stress was a trigger. Mitigating factors: she stopped practicing and was transparent.

On 12/15/2024, she was charged with criminal recklessness with a deadly weapon. (Josh Mounty is her attorney) during an argument with her husband her firearm went off. Husband was intoxicated and she was trying to put the safety on to protect him. Original charge dismissed and reduced to a misdemeanor. She is not working as a nurse right now.
