VI. Education

1. Chamberlain University request for change in curriculum to hybrid modality – Ruth Mackenzie DNP, MS, RN

Dr. Ruth MacKenzie appeared on behalf of the program. Dr. MacKenzie stated that the request for change in modality was to address the changing needs of the student population from the traditional student to non-traditional student. The change is targeted to begin with the September 2023 cohort but would affect all students currently enrolled. General education courses that are currently in an online format will remain, which includes sciences and non-nursing courses like nutrition. Level 1 and 2 courses would require 50% in person face to face format, as those are foundational courses that benefit from in person instruction. Level 3 courses could be 25% in person as many of these courses have a significant clinical component. Level 4 would be 50%/50% to provide final preparation for graduation and practice. Board president Kim Cooper stated that the Board had precedent that these kinds of changes could be in place for incoming students, but that it was unfair to seated students to enact these changes for them. After discussion, it was agreed that the change in modality could be instituted for the incoming September 2023 cohort and successive cohorts, but that the currently seated students would finish their program with the modality in place currently. A motion was made and seconded to approve the hybrid plan for September 2023. Cooper/Morris 8-0-0.

2. Fortis College monthly report – Kristi Schoen MSN, RN

Kristi Schoen, Dr. Melvin Bolden, and Steve Hardin appeared on behalf of the program. Ms. Schoen stated that they are tracking NCLEX success by cohort, and that each cohort that has participated in the NCLEX Success curriculum have had improving results. Ms. Cooper congratulated the program on the improvements and increasing scores that have been apparent since Ms. Schoen's promotion to Dean. Mr. Hardin was asked about budget cuts mentioned in the faculty meeting minutes and he assured the Board that those cuts would not affect nursing. If adjunct were required because of increasing enrollment, those would be funded. Ms. Cooper stated that a lengthier discussion will need to occur in the future regarding NCLEX results for the past years, but that is not possible until the NCSBN provides the standard deviation for 2022 to ISBN. A motion was made and seconded to accept the report. Hamblen/Juengst 8-0-0.

3. Ancilla College of Marian University quarterly written report

Written report reviewed. Education Compliance Officer Toni Herron stated that there are only 3 students remaining in the program and are slated to complete in the Spring 2023. Ms. Cooper stated that the program will be allowed to teach out. She asked if the NCLEX results for the BSN students at Ancilla will be reported separately and Ms. Herron stated that they will be reported in aggregate along with the Indianapolis campus once they begin to test.
