DISCUSSION ITEMS


1. **Certificate of Authority (COA)** – The lack of Indiana requiring a COA is creating difficulty for surveyors trying to become licensed in other states. What can Indiana do to assist with this. The Board has no authority over a company, just over individuals.
2. **Continuing Education** – A question has been posed on how to broaden continuing education requirements. It was stated that there is enough variety within the requirements to maintain the present rules associated with continuing education as it stands.
3. **Records** - How are records handled for retired or surveyors who have passed away. There is no clear path as to what do to with surveyor records upon these circumstances.
