First question was pertaining to an appraisal completed in Missouri in October 2022. An applicant may claim full credit for an appraisal if they complete 75% or more of the work within the report. What work was completed on this log? A Trainee appraiser cannot review appraisal work. Per 876 IAC 3-2-9 Use of titles, whoever signs an appraisal report, must include INDIANA LICENSE XXXXXX whichever is applicable with the licensee's license. What procedure did you use intangible assets? Did not obtain certain expenses needed for the appraisal or supporting documentation related to the expenses. General costs were used instead of specific information. Must have plans, specifications and definitive documentation that is required. Her supervisor stepped into state that she submitted the incorrect work with her logs. That she submitted 12 reviews and two costs. Need new appraisal logs submitted to the board to review, in lieu of what she previously sent in. The log must be resubmitted. Sampling is how the Board reviews the logs that are submitted.

Motion was made by Mark Ratterman and seconded by Matt Kruse to request a new, reivsed log containing only appraisals completed by the applicant, to be submitted to the Board. The application is tabled for the current moment.
