I. PERSONAL APPEARANCE

A. John Michael Paron – Positive Response Renewal

John Michael Paron appeared before the Board about the positive response on his renewal. He graduated from Tulane and was licensed in 1990. In 2020 he was in a horrific accident, charged with hit and run causing death.

He never realized that he had struck a person, though he thought he had hit an animal. This occurred in a dark area on an Indian Reservation after departing a casino on the reservation. The person that was struck and killed did share with persons close to him, that he was planning on walking in front of a car so his life could end. He pled guilty in a plea deal, was not incarcerated. He surrendered his license in the state where this occurs. He is currently on criminal probation, with one year left of this probation. He does have a project with an engineering firm within the state, which is why he renewed. He did not report or attest on his renewal about this on his 2021 renewal. He does not hold an active license in Wisconsin. He surrendered his license in Louisiana. His webpage - About — BrandPoint Design – has not been updated and states that he is licensed to work in 10 states, where most of these licenses have lapsed.

Motion by Debra Schmucker and second Lisa Gomperts to renew on indefinite probation with the clean up on his website to provide accurate information, within 15 days of the Probationary Order, a spreadsheet of current licenses and their renewal dates as well as the expired licenses, any discipline or violations from other jurisdictions with quarterly reporting. The renewal starts at the end of the month. The Board will be requiring Continuing Education to be submitted at time of renewal as well as attesting that it has been completed.


The next meeting is December 10th.
