- S. Frain moved to deny the application for funeral director license in the matter of David Cook, FD01005263 based on the fact that he did not comply with the 2009 directive. Motion failed for lack of a second. Motion failed.

S. Frain moved to require an active intern license to sit for the funeral director examination. Motion failed do to a lack of a second. It was determined that the board has no authority to make a determination without rule promulgation. The agency has required an active license in the past so it will continue to do so until rules can be promulgated.

MINUTE NO. 12-69 NATHAN BUTLER FUNERAL HOME PRENEED FILES

P. St. Pierre reported that he completed the review of the Nathan Butler Funeral Home preneed files. He has determined which appear to be funded. He has contacted five funeral homes in the county that Nathan Butler Funeral Home was located in to ask if they would be willing to accept both funded and non-funded files. He explained that the funeral homes would be required to determine if the contracts were actually funded and to notify the purchasers that they have their file and they may transfer to another seller. He asked for guidance as to whether the board should include branches of a few of the five funeral homes he contacted in the mix of assigning the contracts. It was the consensus of the board to appoint the files to the five funeral homes rather than include the branches. The successor sellers are McClanahan-Lee Funeral Home, Welch & Cornett Funeral Home, Anderson-Poindexter Memorial Chapel, Cox Funeral Home, and Lester Jenkins & Sons Funeral Home, Inc. The board has set the precedent in the past that unfunded contracts may be paid out of the preneed consumer protection fund so the funeral homes that are assigned unfunded contracts may file a verified complaint requesting restitution from the preneed consumer protection fund. P. St. Pierre indicated that he should have the assignments ready for the next board meeting.

The balance of the preneed consumer protection fund is \$511,105.98.

The report needs to show the amount that was taken out of the fund so that the Board may correctly conduct their annual review of the fund from this point forward.

The board has been diligent in attempting to follow the statute regarding collecting payments in regard to the preneed consumer protection fund. The board consensus was to contact the Office of Management and Budget to ask them how they should consider the amount taken from the fund for deposit into the General Fund in determining if the board should require payment into the fund for preneed contracts sold in the calendar year 2012.

P. St. Pierre reported that he met with agency deputy director Lisa Bentley, the Indiana Funeral Directors Association, Indiana Cemetery Association to discuss present and future legislation. New legislation included

funeral training in the military and military spouses would suffice for the board's education requirement and electronic participation in board meetings will be allowed after the board adopts a policy. Future legislation may include Alkaline Hydrolysis, Require insurance companies to allow funeral directors to check the validity of a policy, and adding selling preneed without a certificate of authority to the cease and desist statute.
