COSMETOLOGY SCHOOL SANITARY RULES

- A student in a cosmetology school shall at all times, while serving a customer, wear a clean washable uniform of the same color and style established by the school and a student name badge, pursuant to 820 IAC 3-1-8(c).
- 2. A student shall:
 - (a) Wash hands with soap and fresh water or waterless hand sanitizer before serving each customer, pursuant to 820 IAC 3-1-8(a).
 - (b) Use a clean towel for each customer, pursuant to 820 IAC 3-1-10(a).
 - (c) Whenever a hair cape or drape is used, a clean towel or other clean protection shall be placed around the customer's neck in such a manner to prevent the hair cape or drape touching the skin, pursuant to 820 IAC 3-1-11.
 - (d) Clean thoroughly and sanitize immediately after use:
 - (1) Shampoo bowls.
 - (2) Shampoo sinks.

pursuant to 820 IAC 3-1-7(c).

- (e) Keep floors, walls and furniture clean and sanitary at all times, pursuant to 820 IAC 3-1-5.
- (f) All instruments shall be properly disinfected, pursuant to 820 IAC 3-1-6.

(a) All implements, except those that come in contact with blood or body fluids, shall be disinfected by complete immersion in a bactericidal, viricidal, and fungicidal disinfectant that is mixed and used according to the manufacturer's directions.

(b) All implements that have come in contact with blood or body fluids shall be disinfected by complete immersion in an EPA registered bactericide, viricide, fungicide, and tuberculocidal disinfectant that is mixed and used according to the manufacturer's directions.
(c) Spills, except those that contain blood or body fluids, shall be disinfected by use of an EPA registered bactericidal, viricidal, and fungicidal disinfectant that is mixed and used according to the manufacturer's directions.

(d) Spills that do contain blood or body fluids shall be disinfected by use of an EPA registered bactericidal, viricidal, fungicidal, and tuberculocidal disinfectant that is mixed and used according to the manufacturer's directions.

- A manicurist student shall at all times comply with manicurist sanitary rule, pursuant to 820 IAC 3-1-15, manicurist; cleanliness.
- 4. An electrologist student shall at all times comply with the electrologist sanitary rule, pursuant to 820 IAC 3-1-12, electrology; cleanliness.
- 5. An esthetician student shall at all times comply with the esthetics sanitary rule pursuant to 820 IAC 3-2-9, esthetics; cleanliness.
