**New Reciprocity Licensure for Additional Health Care Professionals  
beginning Monday, October 17, 2022**

**Indianapolis, IN** – The Indiana Professional Licensing Agency (IPLA) is pleased to announce that additional health care professionals now have a new means to apply for licensure through reciprocity in the state of Indiana. This is the second phase of the IPLA’s rollout and implementation of licensure through reciprocity for health care professionals under the requirements of [Indiana Code § 25-1-21](#).

Beginning Monday, October 17, 2022, this new reciprocity licensure will be available to the following professions/license types:

Eligible applicants seeking licensure through reciprocity for any of these professions/license types may apply for their official license as well as a provisional (temporary) license online at [MyLicense.IN.gov](http://MyLicense.IN.gov). The online application is the only means to apply for licensure through this method at this time.

The IPLA will proactively continue to roll out applications for licensure through reciprocity under the requirements of [Indiana Code § 25-1-21](#) for other eligible health care professionals. These applications will continue to be rolled out in phases through the end of the year. The IPLA will provide additional announcements and guidance when such information is ready to be made available.
