Application Instructions

The Committee reviewed the various licensure requirements to determine what would need to be provided to obtain licensure.

- CPM credential copy of certificate or card with expiration date
- Transcript must come directly from school
- Completion of MEAC program transcript from approved school and include list of approved schools
- Practical experience requirement to obtain CPM copy of CPM credential
- CPR card copy of card

- Pediatric Neonatal certification copy of card
- 80 additional births affidavit
- Liability insurance copy of insurance showing amount of coverage
- Certificate of completion for either ALSO, Best or Bridge Program

Application and Renewal Questions

The Committee reviewed the current physician application and determined that questions 1, 2, 3, 4, 5, 8, and 10 should be included in the midwife application.

For renewals, the midwife will need to attest to the completion of peer review sessions and continuing education requirements. There will also be a question asking if the midwife has allowed their CPM credential to lapse, expire or be relinquished.

Forms

Collaborative Agreements should include the following:

- CDEM and collaborative physician information
- Geographical location of CDEM and physician
- Referral protocol
- Methods of collaboration
- Patient encounter and chart reviews
- Treatment of at-risk clients
- Insurance coverage
- Scope of services provided by CDEM

Informed Consent – follow requirements in IC 25-23.4-4-3

Emergency Care Plans

- Should be filed with hospital
- Should follow guidelines in 844 IAC 17-1-11

Post-birth information

Should report information required by IC 25-23.4-4-6

Prescription drug protocol

Should follow requirements in IC 25-23.4-4-5

Annual Reports

The following were proposed as possible items to be reported: number of live births, still births and deaths; location of birth (ex. Home or hospital); any significant injuries; number of clients transported to hospital and reason for transport; number of weeks of post-partum care.

Collaborating Physician Registration

The application will include information about the collaborating physician. PLA will need to work with IT to develop an annual registration.

Change of Collaborating Physician

A change of collaborating physician form will be developed based on the Physician Assistant change/addition of supervising physician form.
