## MINUTE NO. 12-83 DISCUSSION OF THE STATE BUDGET AGENCY'S RESPONSE REGARDING THE PRENEED CONSUMER PROTECTION FUND BALANCE

Bill Keown addressed the board regarding the preneed consumer protection fund balance. He indicated that it was his opinion that transferring funds from the preneed consumer protection fund was illegal. He indicated that IPLA would have had to send a letter to the Budget Agency to transfer the funds. Pursuant to statute, the reason for the transfer was unlawful. He requested the board request an official opinion from the Office of the Attorney General regarding this matter.

Curtis Rostad agrees 100%. He added that further collections are a tax and only the Legislature can impose a tax. He reiterated his experience with attempting to meet with the Attorney General and his conversation with the Attorney General's assistants. IFDA members are prepared to sue the State of Indiana but they will wait until after the election.

P. St. Pierre will reach out to Woody Burton to attempt to resolve the matter and would like to hold off on the request for official opinion until after the meeting. P. St. Pierre will work with K. McDowell to draft the letter to be ready to send depending on the outcome of the meeting with Rep. Burton.
