PETITION FOR SUMMARY SUSPENSION

The State of Indiana, by Counsel, Elizabeth Kiefner Crawford and Thomas P. McGee, Deputy Attorneys General, move the Medical Licensing Board of Indiana (“Board”) to suspend the medical license held by Dr. Beverley Edwards, M.D. (“Respondent”) for ninety (90) days, and in support of its petition states the following:

1. Respondent is a licensed Physician in the State of Indiana holding Indiana license number 01026336.
2. This Board has jurisdiction to suspend Respondent’s license in accordance with the provisions of Indiana Code § 4-21.5-4 et seq. and Indiana Code § 25-1-9-10.
3. On or about January 21, 2010, Respondent’s Drug Enforcement Administration Certificate of Registration was placed on immediate suspension pursuant to 21 USC § 824 (d). Respondent was personally served with the Order To Show Cause and Immediate Suspension of Registration and advised that effective immediately she could no longer legally prescribe controlled substances.
4. On or about January 22, 2010, Respondent utilized the Signature, Drug Enforcement Administration Certificate of Registration Number, and Department of Public Safety Number (which controls the Texas controlled substance registration

program) of another doctor in order to issue prescriptions for controlled substances to two (2) of her patients.

5. If allowed to continue to practice as a licensed Physician, Respondent represents a clear and immediate danger to the public health and safety.

WHEREFORE, the State of Indiana requests that this Board set a hearing on this petition for summary suspension and suspend Respondent's license for a period of ninety (90) days and for all other proper relief.


