Cheri D. Brown, D.C.

Dr. Brown successfully completed the law examination. Dr. Brown is a 2008 graduate of Western States Chiropractic College and has taken and passed National Boards Parts I, II, III, IV and Physiotherapy. Dr. Brown is licensed in the state of Oregon. Dr. Brown responded positive to question #4 "Are you now being, or have you ever been, treated for drug or alcohol abuse?". Dr. Brown stated that in 1995 she was treated at Fairbanks for use of marijuana. Since that time there has been no problems.

No further incidents, has occurred since that time.
