## HOUSE ENROLLED ACT No. 1001

AN ACT to amend the Indiana Code concerning state and local administration and to make an appropriation.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. [EFFECTIVE JULY 1, 2003]

2

3 (a) The following definitions apply throughout this act:

4 (1) "Augmentation allowed" means the governor and the budget agency are  
5 authorized to add to an appropriation in this act from revenues accruing to the  
6 fund from which the appropriation was made.

7 (2) "Biennium" means the period beginning July 1, 2003, and ending June 30, 2005.  
8 Appropriations appearing in the biennial column for construction or other permanent  
9 improvements may be allotted as provided in IC 4-13-2-19.

10 (3) "Deficiency appropriation" or "special claim" means an appropriation available  
11 during the 2002-2003 fiscal year.

12 (4) "Equipment" includes machinery, implements, tools, furniture,  
13 furnishings, vehicles, and other articles that have a calculable period of service  
14 that exceeds twelve (12) calendar months.

15 (5) "Fee replacement" includes repayment on indebtedness resulting from financing  
16 the cost of planning, purchasing, rehabilitation, construction, repair, leasing,  
17 lease-purchasing, or otherwise acquiring land, buildings, facilities, and equipment  
18 to be used for academic and instructional purposes.

19 (6) "Other operating expense" includes payments for "services other than personal",  
20 services by contract", "supplies, materials, and parts", "grants, subsidies, refunds,  
21 and awards", "in-state travel", "out-of-state travel", and "equipment".

1 (7) "Pension fund contributions" means the state of Indiana's contributions to a  
2 specific retirement fund.  
3 (8) "Personal services" includes payments for salaries and wages to officers and  
4 employees of the state (either regular or temporary), payments for compensation  
5 awards, and the employer's share of Social Security, health insurance, life insurance,  
6 disability and retirement fund contributions.  
7 (9) "SSBG" means the Social Services Block Grant. This was formerly referred to  
8 as "Title XX".

9 (10) "State agency" means:  
10 (A) each office, officer, board, commission, department, division, bureau, committee,  
11 fund, agency, authority, council, or other instrumentality of the state;  
12 (B) each hospital, penal institution, and other institutional enterprise of the  
13 state;  
14 (C) the judicial department of the state; and  
15 (D) the legislative department of the state.

16 However, this term does not include cities, towns, townships, school cities, school  
17 townships, school districts, other municipal corporations or political subdivisions  
18 of the state, or universities and colleges supported in whole or in part by state  
19 funds.

20 (11) "Total operating expense" includes payments for both "personal services" and  
21 "other operating expense".

22 (b) The state board of finance may authorize advances to boards or persons having  
23 control of the funds of any institution or department of the state of a sum of  
24 money out of any appropriation available at such time for the purpose of establishing  
25 working capital to provide for payment of expenses in the case of emergency when  
26 immediate payment is necessary or expedient. Advance payments shall be made by  
27 warrant by the auditor of state, and properly itemized and receipted bills or invoices  
28 shall be filed by the board or persons receiving the advance payments.

29 (c) All money appropriated by this act shall be considered either a direct appropriation  
30 or an appropriation from a rotary or revolving fund.

31 (1) Direct appropriations are subject to withdrawal from the state treasury and  
32 for expenditure for such purposes, at such time, and in such manner as may be prescribed  
33 by law. Direct appropriations are not subject to return and rewithdrawal from the  
34 state treasury, except for the correction of an error which may have occurred in  
35 any transaction or for reimbursement of expenditures which have occurred in the  
36 same fiscal year.

37 (2) A rotary or revolving fund is any designated part of a fund that is set apart  
38 as working capital in a manner prescribed by law and devoted to a specific purpose  
39 or purposes. The fund consists of earnings and income only from certain sources  
40 or a combination thereof. However derived, the money in the fund shall be used  
41 for the purpose designated by law as working capital. The fund at any time  
42 consists of the original appropriation thereto, if any, all receipts accrued to  
43 the fund, and all money withdrawn from the fund and invested or to be invested. The  
44 fund shall be kept intact by separate entries in the auditor of state's office,  
45 and no part thereof shall be used for any purpose other than the lawful purpose  
46 of the fund or revert to any other fund at any time. However, any unencumbered  
47 excess above any prescribed amount shall be transferred to the state general fund  
48 at the close of each fiscal year unless otherwise specified in the Indiana Code.

For the conduct of state government, its offices, funds, boards, commissions, departments, societies, associations, services, agencies, and undertakings, and for other appropriations not otherwise provided by statute, the following sums in SECTIONS 3 through 10 are appropriated for the periods of time designated from the general fund of the state of Indiana or other specifically designated funds.

Included in the above appropriations for house and senate expenses are funds for a legislative business per diem allowance, meals and other usual and customary expenses associated with legislative affairs. Except as provided below, this allowance is to be paid to each member of the general assembly for every day, including Sundays, during which the general assembly is convened in regular or special session, commencing with the day the session is officially convened and concluding with the day the session is adjourned sine die. However, after five (5) consecutive days of recess, the legislative business per diem allowance is to be made on an individual voucher basis until the recess concludes.

Members of the general assembly are entitled, when authorized by the speaker of the house or the president pro tempore of the senate, to the legislative business per diem allowance for each and every day engaged in official business.

The legislative business per diem allowance that each member of the general assembly is entitled to receive equals the maximum daily amount allowable to employees of the executive branch of the federal government for subsistence expenses while away from home in travel status in the Indianapolis area. The legislative business per diem changes each time there is a change in that maximum daily amount.

In addition to the legislative business per diem allowance, each member of the general assembly shall receive the mileage allowance in an amount equal to the standard mileage

1 rates for personally owned transportation equipment established by the federal Internal  
2 Revenue Service for each mile necessarily traveled from the member's usual place  
3 of residence to the state capitol. However, if the member traveled by a means other  
4 than by motor vehicle, and the member's usual place of residence is more than one  
5 hundred (100) miles from the state capitol, the member is entitled to reimbursement  
6 in an amount equal to the lowest air travel cost incurred in traveling from the usual  
7 place of residence to the state capitol. During the period the general assembly is  
8 convened in regular or special session, the mileage allowance shall be limited to  
9 one (1) round trip each week per member.

10  
11 Any member of the general assembly who is appointed, either by the governor, speaker  
12 of the house, president or president pro tempore of the senate, house or senate minority  
13 floor leader, or Indiana legislative council to serve on any research, study, or  
14 survey committee or commission, or who attends any meetings authorized or convened  
15 under the auspices of the Indiana legislative council, including pre-session conferences  
16 and federal-state relations conferences, is entitled, when authorized by the legislative  
17 council, to receive the legislative business per diem allowance for each day in actual  
18 attendance and is also entitled to a mileage allowance, at the rate specified above,  
19 for each mile necessarily traveled from the member's usual place of residence to  
20 the state capitol, or other in-state site of the committee, commission, or conference.  
21 The per diem allowance and the mileage allowance permitted under this paragraph shall  
22 be paid from the legislative council appropriation for legislator and lay member  
23 travel unless the member is attending an out-of-state meeting, as authorized by the  
24 speaker of the house of representatives or the president pro tempore of the senate,  
25 in which case the member is entitled to receive:

- 26 (1) the legislative business per diem allowance for each day the member is engaged  
27 in approved out-of-state travel; and  
28 (2) reimbursement for traveling expenses actually incurred in connection with the  
29 member's duties, as provided in the state travel policies and procedures established  
30 by the legislative council.

31  
32 Notwithstanding the provisions of this or any other statute, the legislative council  
33 may adopt, by resolution, travel policies and procedures that apply only to members  
34 of the general assembly or to the staffs of the house of representatives, senate,  
35 and legislative services agency, or both members and staffs. The legislative council  
36 may apply these travel policies and procedures to lay members serving on research,  
37 study, or survey committees or commissions that are under the jurisdiction of the  
38 legislative council. Notwithstanding any other law, rule, or policy, the state travel  
39 policies and procedures established by the Indiana department of administration and  
40 approved by the budget agency do not apply to members of the general assembly, to  
41 the staffs of the house of representatives, senate, or legislative services agency,  
42 or to lay members serving on research, study, or survey committees or commissions  
43 under the jurisdiction of the legislative council (if the legislative council applies  
44 its travel policies and procedures to lay members under the authority of this SECTION),  
45 except that, until the legislative council adopts travel policies and procedures,  
46 the state travel policies and procedures established by the Indiana department of  
47 administration and approved by the budget agency apply to members of the general  
48 assembly, to the staffs of the house of representatives, senate, and legislative  
49 services agency, and to lay members serving on research, study, or survey committees



1 or commissions under the jurisdiction of the legislative council. The executive director  
 2 of the legislative services agency is responsible for the administration of travel  
 3 policies and procedures adopted by the legislative council. The auditor of state  
 4 shall approve and process claims for reimbursement of travel related expenses under  
 5 this paragraph based upon the written affirmation of the speaker of the house of  
 6 representatives, the president pro tempore of the senate, or the executive director  
 7 of the legislative services agency that those claims comply with the travel policies  
 8 and procedures adopted by the legislative council. If the funds appropriated for  
 9 the house and senate expenses and legislative salaries are insufficient to pay all  
 10 the necessary expenses incurred, including the cost of printing the journals of the  
 11 house and senate, there is appropriated such further sums as may be necessary to  
 12 pay such expenses.

20 Each member of the general assembly is entitled to a subsistence allowance of forty  
21 percent (40%) of the maximum daily amount allowable to employees of the executive  
22 branch of the federal government for subsistence expenses while away from home in  
23 travel status in the Indianapolis area:

- 24 (1) each day that the general assembly is not convened in regular or special session;  
25 and  
26 (2) each day after the first session day held in November and before the first session  
27 day held in January.

28  
29 However, the subsistence allowance under subdivision (2) may not be paid with respect  
30 to any day after the first session day held in November and before the first session  
31 day held in January with respect to which all members of the general assembly are  
32 entitled to a legislative business per diem.

33  
34 The subsistence allowance is payable from the appropriations for legislators' subsistence.

35  
36 The officers of the senate are entitled to the following amounts annually in addition  
37 to the subsistence allowance: president pro tempore, \$6,500; assistant president  
38 pro tempore, \$2,500; majority floor leader, \$5,000; assistant majority floor leader,  
39 \$1,000; majority caucus chair, \$5,000; assistant majority caucus chair, \$1,000; finance  
40 committee chair, \$5,000; budget subcommittee chair, \$4,000; finance committee ranking  
41 majority member, \$2,000; majority whip, \$3,500; assistant majority whip, \$1,000;  
42 minority floor leader, \$5,500; minority caucus chair, \$4,500; minority assistant  
43 floor leader, \$4,500; finance committee ranking minority member, \$3,500; minority  
44 whip, \$2,500; assistant minority whip, \$500; and assistant minority caucus chair,  
45 \$500.

46  
47 Officers of the house of representatives are entitled to the following amounts annually  
48 in addition to the subsistence allowance: speaker of the house, \$6,500; speaker pro  
49 tempore, \$5,000; deputy speaker pro tempore, \$1,500; majority leader, \$5,000; majority



1 caucus chair, \$5,000; assistant majority caucus chair, \$1,000; ways and means committee  
 2 chair, \$5,000; ways and means committee ranking majority member, \$3,000; speaker  
 3 pro tempore emeritus, \$1,500; budget subcommittee chair, \$3,000; majority whip, \$3,500;  
 4 assistant majority whip, \$1,000; assistant majority leader, \$1,000; minority leader,  
 5 \$5,500; minority caucus chair, \$4,500; ways and means committee ranking minority  
 6 member, \$3,500; minority whip, \$2,500; assistant minority leader, \$4,500; second  
 7 assistant minority leader, \$1,500; and deputy assistant minority leader, \$1,000.

9 If the funds appropriated for legislators' subsistence are insufficient to pay all  
 10 the subsistence incurred, there are hereby appropriated such further sums as may  
 11 be necessary to pay such subsistence.

 27 council, to a per diem instead of subsistence of \$75 per day during the 2003-2005  
 28 biennium. In addition to the per diem, such a person is entitled to mileage reimbursement,

 30 traveled from the person's usual place of residence to the state capitol or other  
 31 in-state site of the committee, commission, or conference. However, reimbursement  
 32 for any out-of-state travel expenses claimed by lay members serving on research,  
 33 study, or survey committees or commissions under the jurisdiction of the legislative  
 34 council shall be based on SECTION 19 of this act, until the legislative council applies  
 35 those travel policies and procedures that govern legislators and their staffs to  
 36 such lay members as authorized elsewhere in this SECTION. The allowance and reimbursement  
 37 permitted in this paragraph shall be paid from the legislative council appropriations  
 38 for legislative and lay member travel unless otherwise provided for by a specific

41 and the proceeds of the sale or sales shall be deposited in the state treasury. The  
42 amount so deposited is hereby reappropriated to that agency for other operating expenses  
43 of the then current year, if approved by the director of the budget agency.  
44

45 SECTION 20. [EFFECTIVE JULY 1, 2003]  
46

47 If any state penal or benevolent institution other than the Indiana state prison,  
48 Pendleton correctional facility, or Putnamville correctional facility shall, in the  
49 operation of its farms, produce products, or commodities in excess of the needs of



1 the institution, the surplus may be sold through the division of industries and farms,  
2 the director of the supply division of the Indiana department of administration,  
3 or both. The proceeds of any such sale or sales shall be deposited in the state treasury.  
4 The amount deposited is hereby reappropriated to the institution for expenses of  
5 the then current year if approved by the director of the budget agency. The exchange  
6 between state penal and benevolent institutions of livestock for breeding purposes  
7 only is hereby authorized at valuations agreed upon between the superintendents or  
8 wardens of the institutions. Capital outlay expenditures may be made from the institutional  
9 industries and farms revolving fund if approved by the budget agency and the governor.

10  
11 SECTION 21. [EFFECTIVE JULY 1, 2003]

12  
13 This act does not authorize any rehabilitation and repairs to any state buildings,  
14 nor does it allow that any obligations be incurred for lands and structures, without  
15 the prior approval of the budget director or the director's designee. This SECTION  
16 does not apply to contracts for the construction or maintenance of roads and bridges,  
17 to the acquisition of rights-of-way for roads or bridges, or to the state universities  
18 supported in whole or in part by state funds.

19  
20 SECTION 22. [EFFECTIVE JULY 1, 2003]

21  
22 If an agency has an annual appropriation fixed by law, and if the agency also receives  
23 an appropriation in this act for the same function or program, the appropriation  
24 in this act supersedes any other appropriations and is the total appropriation for  
25 the agency for that program or function.

26  
27 SECTION 23. [EFFECTIVE JULY 1, 2003]

28  
29 The balance of any appropriation or funds heretofore placed or remaining to the credit  
30 of any division of the state of Indiana, and any appropriation or funds provided  
31 in this act placed to the credit of any division of the state of Indiana, the powers,  
32 duties, and functions whereof are assigned and transferred to any department for  
33 salaries, maintenance, operation, construction, or other expenses in the exercise  
34 of such powers, duties, and functions, shall be transferred to the credit of the  
35 department to which such assignment and transfer is made, and the same shall be available  
36 for the objects and purposes for which appropriated originally.

37  
38 SECTION 24. [EFFECTIVE JULY 1, 2003]

39  
40 The director of the division of procurement of the Indiana department of administration,  
41 or any other person or agency authorized to make purchases of equipment, shall not  
42 honor any requisition for the purchase of an automobile that is to be paid for from  
43 any appropriation made by this act or any other act, unless the following facts are  
44 shown to the satisfaction of the commissioner of the department of administration  
45 or the commissioner's designee.

46 (1) In the case of an elected state officer, it shall be shown that the duties of  
47 the office require driving about the state of Indiana in the performance of official  
48 duty.

49 (2) In the case of department or commission heads, it shall be shown that the statutory



1 duties imposed in the discharge of the office require traveling a greater distance  
2 than one thousand (1,000) miles each month or that they are subject to official duty  
3 call at all times.

4 (3) In the case of employees, it shall be shown that the major portion of the duties  
5 assigned to the employee require travel on state business in excess of one thousand  
6 (1,000) miles each month, or that the vehicle is identified by the agency as an integral  
7 part of the job assignment. In computing the number of miles required to be driven  
8 by a department head or an employee, the distance between the individual's home and  
9 office or designated official station is not to be considered as a part of the total.  
10 Department heads shall annually submit justification for the continued assignment  
11 of each vehicle in their department, which shall be reviewed by the commissioner  
12 of the Indiana department of administration, or the commissioner's designee. There  
13 shall be an insignia permanently affixed on each side of all state owned cars, designating  
14 the cars as being state owned. However, this requirement does not apply to state  
15 owned cars driven by elected state officials or to cases where the commissioner of  
16 the Indiana department of administration or the commissioner's designee determines  
17 that affixing insignia on state owned cars would hinder or handicap the persons driving  
18 the cars in the performance of their official duties.

19  
20 SECTION 25. [EFFECTIVE JULY 1, 2003]

21  
22 When budget agency approval or review is required under this act, the budget agency  
23 may refer to the budget committee any budgetary or fiscal matter for an advisory  
24 recommendation. The budget committee may hold hearings and take any actions authorized  
25 by IC 4-12-1-11, and may make an advisory recommendation to the budget agency.

26  
27 SECTION 26. [EFFECTIVE JULY 1, 2003]

28  
29 The governor of the state of Indiana is solely authorized to accept on behalf of  
30 the state any and all federal funds available to the state of Indiana. Federal funds  
31 received under this SECTION are appropriated for purposes specified by the federal  
32 government, subject to allotment by the budget agency. The provisions of this SECTION  
33 and all other SECTIONS concerning the acceptance, disbursement, review, and approval  
34 of any grant, loan, or gift made by the federal government or any other source to  
35 the state or its agencies and political subdivisions shall apply, notwithstanding  
36 any other law.

37  
38 SECTION 27. [EFFECTIVE JULY 1, 2003]

39  
40 Federal funds received as revenue by a state agency or department are not available  
41 to the agency or department for expenditure until allotment has been made by the  
42 budget agency under IC 4-12-1-12(d).

43  
44 SECTION 28. [EFFECTIVE JULY 1, 2003]

45  
46 A contract or an agreement for personal services or other services may not be entered  
47 into by any agency or department of state government without the approval of the  
48 budget agency or the designee of the budget director. Each demand for payment submitted  
49 by the agency or department to the auditor of state by claim voucher under such contracts



1 or agreements shall be accompanied by a copy of the budget agency approval, or approval  
2 of any agency to whom the budget agency delegated signature authority, and no payment  
3 shall be made by the auditor of state without such approval. This SECTION does not  
4 apply to any contract entered into by an agency or department of state government  
5 that is the result of a public works project contract under IC 4-13.6.

6

7 SECTION 29. [EFFECTIVE JULY 1, 2003]

8

9 Except in those cases where a specific appropriation has been made to cover the payments  
10 for any of the following, the auditor of state shall transfer, from the personal  
11 services appropriations for each of the various agencies and departments, necessary  
12 payments for Social Security, public employees' retirement, health insurance, life  
13 insurance, and any other similar payments directed by the budget agency.

14

15 SECTION 30. [EFFECTIVE JULY 1, 2003]

16

17 Subject to SECTION 25 of this act as it relates to the budget committee, the budget  
18 agency with the approval of the governor may withhold allotments of any or all appropriations  
19 contained in this act for the 2003-2005 biennium, if it is considered necessary to  
20 do so in order to prevent a deficit financial situation.

21

22 SECTION 31. [EFFECTIVE JULY 1, 2002 (RETROACTIVE)]

23

24 The following appropriation is made for FY 2002-2003 in addition to those  
25 found in P.L. 291-2001:

15 The budget agency may employ one (1) or more architects or engineers to inspect  
16 construction, rehabilitation, and repair projects covered by the appropriations in  
17 this act or previous acts designated in this act.

18  
19 SECTION 36. [EFFECTIVE JULY 1, 2003]

20  
21 If any part of a construction or rehabilitation and repair appropriation made by  
22 this act or any previous acts has not been allotted or encumbered before the expiration  
23 of two (2) biennia, the budget agency may determine that the balance of the appropriation  
24 is not available for allotment. The appropriation may be terminated and the balance  
25 may revert to the fund from which the original appropriation was made.

26  
27 SECTION 37. [EFFECTIVE UPON PASSAGE]

28  
29 The budget agency may retain balances in the mental health fund at the end of any  
30 fiscal year to ensure there are sufficient funds to meet appropriations for state  
31 developmental centers in any subsequent year.

32  
33 SECTION 38. [EFFECTIVE JULY 1, 2003]

34  
35 If the budget director makes a determination at any time during either fiscal year of the  
36 biennium that the executive branch of state government cannot meet its statutory  
37 obligations due to insufficient funds in the state general fund, then notwithstanding  
38 IC 4-10-18, the budget agency, with the approval of the governor and after review by the  
39 budget committee, may transfer from the counter-cyclical revenue and economic  
40 stabilization fund to the state general fund an amount necessary to maintain a positive  
41 balance in the state general fund.

42  
43 SECTION 39. IC 4-15-1.8-7 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON  
44 PASSAGE]: Sec. 7. (a) The department shall do the following:

- 45 (1) Develop personnel policies, methods, procedures, and standards for all state agencies.  
46 (2) Formulate, establish, and administer position classification plans and salary and wage  
47 schedules, all subject to final approval by the governor.

8           SECTION 41. IC 4-30-16-3, AS AMENDED BY P.L.273-1999, SECTION 49, IS AMENDED  
9           TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 3. (a) The commission shall transfer  
10          the surplus revenue in the administrative trust fund as follows:

39 submit a plan for flexible scheduling to the commission by a date designated by the commission.

40 **subdivision not later than the last business day of the month in which the tax revenue is**  
41 **remitted to the state for deposit in the state gaming fund. However, if tax revenue is**

23 county shall provide for the distribution of the money received under this clause to one (1)

25 by the county fiscal body after receiving a recommendation from the county executive.

26 (B) Twenty percent (20%) shall be quarterly distributed to the county treasurer of a county  
27 having a population of more than ten thousand seven hundred (10,700) but less than twelve  
28 thousand (12,000) for appropriation by the county fiscal body after receiving a  
29 recommendation from the county executive. The county fiscal body for the receiving  
30 county shall provide for the distribution of the money received under this clause to one (1)  
31 or more taxing units (as defined in IC 6-1.1-1-21) in the county under a formula established  
32 by the county fiscal body after receiving a recommendation from the county executive.

33 (C) Sixty percent (60%) shall be retained by the county where the riverboat is docked for  
34 appropriation by the county fiscal body after receiving a recommendation from the county  
35 executive. The county fiscal body shall provide for the distribution of part or all of the  
36 money received under this clause to the following under a formula established by the  
37 county fiscal body:

38 (i) A town having a population of more than two thousand two hundred (2,200) but less  
39 than three thousand five hundred (3,500) located in a county having a population of more  
40 than nineteen thousand three hundred (19,300) but less than twenty thousand (20,000).

41 (ii) A town having a population of more than three thousand five hundred (3,500) located  
42 in a county having a population of more than nineteen thousand three hundred (19,300)  
43 but less than twenty thousand (20,000).

44 (c) For each city and county receiving money under subsection (a)(2)(A) or (a)(2)(C), the  
45 treasurer of state shall determine the total amount of money paid by the treasurer of state to the city  
46 or county during the state fiscal year 2002. The amount determined is the base year revenue for the  
47 city or county. The treasurer of state shall certify the base year revenue determined under this



1 subsection to the city or county. The total amount of money distributed to a city or county under  
2 this section during a state fiscal year may not exceed the entity's base year revenue. For each state

14 The treasurer of state shall make transfers on a monthly basis as needed to meet the obligations of  
15 the build Indiana fund. If in any state fiscal year insufficient money is transferred to the property  
16 tax replacement fund under subsection (a)(3) to comply with this subsection, the treasurer of state  
17 shall reduce the amount transferred to the build Indiana fund to the amount available in the property  
18 tax replacement fund from the transfers under subsection (a)(3) for the state fiscal year.

19 (e) Before August 15 of 2003 and each year thereafter, the treasurer of state shall distribute the  
20 wagering taxes set aside for revenue sharing under subsection (a)(1) to the county treasurer of each

35 county under IC 6-1.1-18.5);
- 36 (2) For deposit in a special fund or allocation fund created under IC 8-22-3.5, IC 36-7-14,  
37 IC 36-7-14.5, IC 36-7-15.1, and IC 36-7-30 to provide funding for additional credits for  
38 property tax replacement in property tax increment allocation areas or debt repayment.
- 39 (3) To fund sewer and water projects, including storm water management projects.
- 40 (4) For police and fire pensions.
- 41 (5) To carry out any governmental purpose for which the money is appropriated by the fiscal  
42 body of the city, town, or county. Money used under this subdivision does not reduce the  
43 property tax levy of the city, town, or county for a particular year or reduce the maximum levy

46 **an ensuing calendar year if, in the judgment of the county fiscal body, the increase is**



1 necessary to pay the obligations that will be incurred by the county for children's psychiatric  
2 residential treatment services during the ensuing calendar year. The maximum increase that  
3 the county fiscal body may recommend for a county may not exceed:

4 (1) the county's expected obligations under IC 12-19-7.5 for the ensuing calendar year;  
5 minus

6 (2) the portion of the county children's psychiatric residential treatment services  
7 property tax levy for the year preceding the ensuing calendar year that was available to  
8 pay obligations under IC 12-19-7.5.

9 (b) In making its recommendation, the county fiscal body shall consider the county's  
10 estimate of expected obligations under IC 12-19-7.5 but may make adjustments to the  
11 county's estimate.

12 (c) The decision of the county fiscal body under this section is a final determination that  
13 may not be appealed.

14 SECTION 89. IC 6-1.1-29-9, AS AMENDED BY P.L.273-1999, SECTION 57, IS AMENDED  
15 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 9. (a) A county council may adopt  
16 an ordinance to abolish the county board of tax adjustment. This ordinance must be adopted by July  
17 1 and may not be rescinded in the year it is adopted. Notwithstanding IC 6-1.1-17, IC 6-1.1-18,  
18 IC 6-1.1-19, IC 12-19-7, **IC 12-19-7.5**, IC 21-2-14, IC 36-8-6, IC 36-8-7, IC 36-8-7.5, IC 36-8-11,

29 method of welfare financing provided by this article, the county director may appeal for the right  
30 to borrow money on a short term basis to fund:

44 body may not do the following:

45 (1) Recommend or approve a request to borrow money made under this chapter unless the  
46 body determines that the family and children's fund **or the children's psychiatric residential**



1           **treatment services fund** will be exhausted before the particular fund can fund all county  
2 obligations incurred under this article.

3           (2) Recommend or approve a loan that will exceed the amount of the estimated deficit.

4           SECTION 92. IC 12-19-7.5 IS ADDED TO THE INDIANA CODE AS A NEW CHAPTER TO  
5 READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]:

6           **Chapter 7.5. County Financing of Children's Psychiatric Residential Treatment Services**  
7 **for Medicaid Eligible Children**

8           **Sec. 1. As used in this chapter, "children's psychiatric residential treatment services"**  
9 **means services that are:**

10           (1) **eligible for federal financial participation under the state Medicaid plan; and**

11           (2) **provided to individuals less than twenty-one (21) years of age who are:**

12               (A) **eligible for services under the state Medicaid plan;**

13               (B) **approved by the office for admission to and treatment in a private psychiatric**  
14 **residential treatment facility; and**

15               (C) **residing in a private psychiatric residential facility for the purposes of treatment**  
16 **for a mental health condition, based on an approved treatment plan that complies**  
17 **with applicable federal and state Medicaid rules and regulations.**

18           **Sec. 2. As used in this chapter, "fund" means the children's psychiatric residential**  
19 **treatment services fund established by section 5 of this chapter.**

20           **Sec. 3. As used in this chapter, "private psychiatric residential treatment facility" means**  
21 **a privately owned and operated facility that:**

22           (1) **provides inpatient treatment to individuals less than twenty-one (21) years of age for**  
23 **mental health conditions;**

24           (2) **is licensed or certified by:**

25               (A) **the division of family and children; or**

26               (B) **the division of mental health and addiction;**

4 Sec. 6. (a) For taxes first due and payable in 2004, each county must impose a county  
5 children's psychiatric residential services property tax levy equal to the amount determined  
6 using the following formula:

7 STEP ONE: Determine the sum of the amounts that were paid by the county minus the  
8 amounts reimbursed by the state (including reimbursements made with federal money),  
9 as determined by the state board of accounts in 2000, 2001, and 2002 for payments to

23 STEP SIX: Determine whether the amount calculated in STEP THREE, as adjusted in  
24 STEP FIVE, or the amount calculated in STEP FOUR, as adjusted in STEP FIVE, is  
25 greater. Multiply the greater amount by the assessed value growth quotient determined  
26 under IC 6-1.1-18.5-2 for the county for property taxes first due and payable in 2003.

27 STEP SEVEN: Multiply the amount determined in STEP SIX by the county's assessed  
28 value growth quotient for property taxes first due and payable in 2004, as determined

30 (b) For taxes first due and payable in each year after 2004, each county shall impose a  
31 county children's psychiatric residential treatment services property tax levy equal to the

35 (2) the greater of:

44 (c) For taxes first due and payable in 2004, the department of local government finance  
45 shall adjust the levy for each county to reflect the county's actual expenses incurred in

47 2002. In making this adjustment, the department of local government finance may consider



1 all relevant information, including the county's use of bond and loan proceeds to pay these

1       **Sec. 11. The budget finally approved and the tax levy recommended by the division shall**

- 4       (2) filed for consideration by the county fiscal body.

5       **Sec. 12. Except as otherwise provided, a budget submitted under section 11 of this chapter**  
6 **must be prepared and filed in the same form and manner and at the same time as the budgets**  
7 **and estimates of other county officers are prepared and filed.**

8       **Sec. 13. In September of each year, at the time provided by law, the county fiscal body**  
9 **shall do the following:**

10       (1) Make the appropriations out of the children's psychiatric residential treatment

28 Sec. 19. The following apply to bonds issued under this chapter:

- 29 (1) The bonds shall be issued so that one (1) series will be payable June 30 and one (1)  
30 series December 31 of each year in which bonds are payable.  
31 (2) The series must be as nearly equal as possible, considering the following:  
32 (A) The amount of the issue.  
33 (B) The number of serial maturities.  
34 (C) The denominations to be used.  
35 (3) The first series of bonds and the first interest payments must be payable June 30 of  
36 the year following the establishing of the annual tax levies immediately following the

38 (4) The county fiscal body may provide that the first two (2) series of bonds mature in

43 (B) provision is made for the payment of the bonds and interest that are payable in

45 Sec. 20. If the proceeds of the bonds authorized under this chapter are insufficient to  
46 enable the county to administer the child services of the county for the unexpired part of the  
47 fiscal year, additional loans may be made for that time.



1           **Sec. 21. (a) After the adoption of the bond ordinance by the county fiscal body, the county**  
2 **executive shall enter an order that does the following:**

3           **(1) Fixes the exact amount of the proposed loan. The amount of the proposed loan must**  
4 **be the maximum amount provided in the bond ordinance less any amount to be**  
5 **advanced from the general fund of the county.**

6           **(2) Fixes the exact rate of interest on the bonds or provides that the interest rate must**  
7 **be the lowest interest rate bid on the bonds. The interest rate may not exceed the**

14 **serial maturities of the bonds.**

15           **(d) The county executive shall adopt the form of bond to be used in the issuance of the**  
16 **bonds. The form shall be substantially followed in the issuance of the bonds.**

17           **Sec. 22. Upon the adoption of the order of the county executive under section 21 of this**  
18 **chapter, the county auditor shall give notice of the determination to make the loan and to**  
19 **issue the bonds.**

20           **Sec. 23. The provisions of laws concerning the right of a taxpayer to file a remonstrance**  
21 **and to appeal to the department of local government finance apply to this chapter. However,**  
22 **the notice of the determination shall be given in one (1) publication. A taxpayer has ten (10)**  
23 **days after the date of publication to file a remonstrance.**

24           **Sec. 24. Except as otherwise provided, the provisions of the general laws relating to the**  
25 **preparation and sale of bonds by counties apply to the preparation and sale of bonds issued**  
26 **under this chapter.**

27           **Sec. 25. (a) Before the sale of bonds under this chapter, the auditor shall publish notice of**  
28 **the sale one (1) time each week for two (2) consecutive weeks. All publications must be made**  
29 **at least seven (7) days before the date fixed for the sale of the bonds. The notice must be**  
30 **published:**

31           **(1) in two (2) newspapers published in the county; and**

32           **(2) one (1) time in a newspaper published in the city of Indianapolis.**

33           **(b) If the order of the county executive provides for a bid rate on the bonds, the notice of**

36           **(2) That the highest bidder for the bonds will be the person that offers the lowest net**  
37 **interest cost to the county. The net interest cost shall be determined by:**

38           **(A) computing the total interest on all of the bonds to maturity; and**

39           **(B) deducting any premium bid from the total interest determined under clause (A).**

40           **Sec. 26. The auditor shall sell bonds issued under this chapter to the highest bidder. If a**  
41 **satisfactory bid is not received for all of the bonds at the time fixed in the notice of sale, the**  
42 **auditor may do the following:**

43           **(1) Continue the sale from day to day.**

44           **(2) Sell bonds in parcels until otherwise directed by an order of the county executive.**

45           **Sec. 27. (a) All bonds issued under this chapter:**

46           **(1) are direct general obligations of the county issuing the bonds; and**

47           **(2) are payable out of unlimited ad valorem taxes that shall be levied and collected on**



1 all the taxable property within the county.

2 (b) Each official and body responsible for the levying of taxes for the county must ensure  
3 that sufficient levies are made to meet the principal and interest on the bonds at the time  
4 fixed for the payment of the principal and interest, without regard to any other statute. If an  
5 official or a body fails or refuses to make or allow a sufficient levy required by this section,  
6 the bonds and the interest on the bonds shall be payable out of the general fund of the county

15 (b) The proceeds of the bonds remaining after the payment of the costs of the issuance of

18 Sec. 29. The county fiscal body may authorize and make temporary loans for the use and  
19 benefit of the children's psychiatric residential treatment services fund in anticipation of  
20 current revenues of the county that are actually levied and being collected for the fiscal year  
21 in which the loans are authorized and made. Each temporary loan authorized and made  
22 under this section must be authorized and made in conformity with IC 36-2-6.

23 Sec. 30. Upon the affirmative vote of two-thirds (2/3) of the members of the county fiscal  
24 body, a county may issue the county's serial bonds for an amount not exceeding in aggregate  
25 the amount for which the county is indebted for the use of the children's psychiatric  
26 residential treatment services fund if the following conditions exist:

27 (1) The indebtedness for the use of the children's psychiatric residential treatment  
28 services fund is evidenced by bonds, notes, judgments, or obligations that are:

29 (A) issued or negotiated by the county; or

30 (B) rendered against the county.

31 (2) The serial bonds are issued for any of the following purposes:

32 (A) Funding or refunding the indebtedness or any part of the indebtedness.

33 (B) Reducing the rate of interest on the indebtedness.

34 (C) Extending the time of payment of the indebtedness.

35 (D) Canceling the amount of the indebtedness that becomes due.

36 Sec. 31. The serial bonds issued under section 30 of this chapter:

37 (1) may be of any denomination that is:

38 (A) not less than fifty dollars (\$50); and

39 (B) not more than one thousand dollars (\$1,000);

40 (2) shall be payable:

41 (A) at any place named on the serial bonds; and

42 (B) at any time not later than fifteen (15) years after the date of the serial bonds;

43 (3) may bear any rate of interest, payable annually or semiannually;

44 (4) shall be sold at not less than the par value of the bonds; and

45 (5) shall be sold in the manner provided for the sale of bonds issued under IC 12-20-23.

46 Sec. 32. (a) The county fiscal body shall add to the tax duplicate of the county:

47 (1) an annual levy sufficient to pay the yearly interest on the bonds issued under section



1           **30 of this chapter; and**

2           **(2) an annual levy sufficient to provide a sinking fund for the liquidation of the principal**  
3           **as the principal becomes due. The sinking fund shall be applied solely to the payment of**  
4           **the bonds.**

5           **(b) If the county fiscal body fails to levy a tax sufficient to pay the interest on the bonds or**  
6           **to liquidate the principal of the bonds as the principal becomes due, the county auditor shall**

40 (b) The advisory board shall meet at least four (4) times per year and shall also meet at the  
41 call of the executive director of the rural development council.

42 (c) The advisory board consists of the following members:

43 (1) The executive director of the Indiana rural development council, who serves as an ex  
44 officio member and as the chairperson of the advisory board.

45 (2) Two (2) members of the senate, who may not be members of the same political party,  
46 and who are appointed by the president pro tempore of the senate.

47 (3) Two (2) members of the house of representatives, who may not be members of the



1 same political party, and who are appointed by the speaker of the house of  
2 representatives.

3 (4) A representative of the commissioner of agriculture, to be appointed by the governor.

4 (5) A representative of the department of commerce, to be appointed by the governor.

5 (6) A representative of the department of workforce development, to be appointed by the  
6 governor.

7 (7) Two (2) persons with knowledge and experience in state and regional economic needs,  
8 to be appointed by the governor.

9 (8) A representative of a local rural economic development organization, to be appointed  
10 by the governor.

11 (9) A representative of a small town or rural community, to be appointed by the  
12 governor.

13 (10) A representative of the rural development council, to be appointed by the governor.

14 (11) A representative of rural education, to be appointed by the governor.

15 (12) A representative of the league of regional conservation and development districts,  
16 to be appointed by the governor.

17 (13) A person currently enrolled in rural secondary education, to be appointed by the  
18 governor.

19 (d) The members of the advisory board listed in subsection (c)(1) through (c)(3) are  
20 nonvoting members.

21 (e) The term of office of a legislative member of the advisory board is four (4) years.  
22 However, a legislative member of the advisory board ceases to be a member if the member:

23 (1) is no longer a member of the chamber from which the member was appointed; or

24 (2) is removed from the advisory board by the appointing authority who appointed the  
25 legislator.

26 (f) The term of office of a voting member of the advisory board is four (4) years. However,  
27 these members serve at the pleasure of the governor and may be removed for any reason.

28 (g) If a vacancy exists on the advisory board, the appointing authority who appointed the  
29 former member whose position has become vacant shall appoint an individual to fill the  
30 vacancy for the balance of the unexpired term.

31 (h) Six (6) voting members of the advisory board constitute a quorum for the transaction  
32 of business at a meeting of the advisory board. The affirmative vote of at least six (6) voting  
33 members is necessary for the advisory board to take action.

34 SECTION 178. IC 4-4-9.5-4 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO  
35 READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 4. (a) The rural development council  
36 fund is established to be used exclusively for:

37 (1) the purposes set forth in sections 2 and 3 of this chapter;

38 (2) administrative expenses and personnel expenses incurred by the council in carrying

7 **Sec. 1.** As used in this chapter, "department" refers to the department of commerce  
8 established by IC 4-4-3-2.

9 **Sec. 2.** As used in this chapter, "fund" refers to the technology development grant fund  
10 established by section 8 of this chapter.

11 **Sec. 3.** As used in this chapter, "political subdivision" has the meaning set forth in

13 **Sec. 4.** As used in this chapter, "redevelopment commission" refers to a redevelopment

28 (C) Pharmaceutical manufacturing.

29 (D) Agribusiness.

30 (E) Nanotechnology or molecular manufacturing.

31 (3) Information technology, including the following:

32 (A) Informatics.

33 (B) Certified network administration.

34 (C) Software development.

35 (D) Fiber optics.

36 (4) Twenty-first century logistics, including the following:

37 (A) High technology distribution.

38 (B) Efficient and effective flow and storage of goods, services, or information.

39 (C) Intermodal ports.

40 **Sec. 7.** As used in this chapter, "technology product" means a product that involves high  
41 technology activity or otherwise involves targeted employment.

42 **Sec. 8.** The technology development grant fund is established to provide the necessary  
43 money for grants to redevelopment commissions under this chapter and the administration  
44 of this program.

45 **Sec. 9.** The fund shall be administered by the department.

46 **Sec. 10.** The expenses of administering the fund shall be paid from money in the fund.  
47 Interest that accrues from these investments shall be deposited in the fund.



1           **Sec. 11. The treasurer of state shall invest the money in the fund not currently needed to**  
2 **meet the obligations of the fund in the same manner as other public funds are invested.**

3           **Sec. 12. Money in the fund at the end of a state fiscal year does not revert to the state**  
4 **general fund.**

5           **Sec. 13. The department shall establish a grant application procedure for redevelopment**

7           **Sec. 14. To qualify for a grant under this chapter, a redevelopment commission must:**

8           **(1) submit an application in the form prescribed by the department;**

10           **(A) the redevelopment commission has established a technology park; and**

27           **(b) The total of all grants provided under this chapter for a technology park may not**  
28 **exceed the following:**

29           **(1) Two million dollars (\$2,000,000) for the leasing, construction, or purchase of capital**  
30 **assets.**

31           **(2) Two million dollars (\$2,000,000) for operating expenditures, and, subject to**  
32 **subsection (d), with not more than five hundred thousand dollars (\$500,000) being**  
33 **distributed in any one (1) fiscal year.**

34           **(c) This subsection applies to a grant provided under subsection (b)(1) for the leasing of**  
35 **a capital asset. The grant may be applied only to lease payments made during:**

37           **(2) each of the three (3) fiscal years immediately following the fiscal year;**

38 **in which the grant is provided.**

39           **(d) The annual distribution of a grant under subsection (b)(2) may not exceed the**

2 **Sec. 17. A capital expenditure grant under this chapter shall require that the lesser of:**

3 (1) two million dollars (\$2,000,000); or

4 (2) fifty percent (50%) of the total capital costs;

5 of the project being funded by the grant be matched from other sources.

6 **Sec. 18. The department may, under rules established by the department of local**  
7 **government finance and the procedures established by the department, award grants from**  
8 **the fund to one (1) or more political subdivisions to reimburse the political subdivisions for**  
9 **ad valorem property taxes allocated to an allocation area as a result of a resolution adopted**  
10 **under IC 36-7-32-15.**

11 SECTION 180. IC 6-1.1-12.2 IS ADDED TO THE INDIANA CODE AS A NEW CHAPTER  
12 TO READ AS FOLLOWS [EFFECTIVE JANUARY 1, 2003 (RETROACTIVE)]:

13 **Chapter 12.2. Deduction for Aircraft**

14 **Sec. 1. This chapter applies only to the following:**

15 (1) Aircraft that:

16 (A) have a seating capacity of not more than ninety (90) passengers;

17 (B) are used in the air transportation of passengers or passengers and property; and

18 (C) are owned or operated by a person who is:

19 (i) an air carrier certificated under Federal Air Regulation Part 121; or

20 (ii) a scheduled air taxi operator certified under Federal Air Regulation Part 135.

21 (2) Aircraft that:

22 (A) are used to transport only property, regardless of whether the aircraft is operated  
23 as a common carrier for compensation; and

24 (B) are owned or operated by a person who is:

25 (i) an air carrier certificated under Federal Air Regulation Part 121; or

26 (ii) a scheduled air taxi operator certified under Federal Air Regulation Part 135.

27 **Sec. 2. As used in this chapter "abatement property" refers to aircraft described in section**  
28 **1 of this chapter.**

29 **Sec. 3. As used in this chapter, "aircraft" has the meaning set forth in 49 U.S.C. 40102.**

30 **Sec. 4. As used in this chapter, "air transportation" means transportation of passengers**  
31 **or property by aircraft as a common carrier for compensation.**

32 **Sec. 5. As used in this chapter, "business entity" refers to a corporation (as defined in**  
33 **IC 6-3-1-10) or partnership (as defined in IC 6-3-1-19).**

34 **Sec. 6. As used in this chapter, "Indiana corporate headquarters" means a physical**  
35 **presence in Indiana of a domestic business entity that results in Indiana being the regular or**  
36 **principal place of business of its chief executive, operating, and financial officers.**

37 **Sec. 7. As used in this chapter, "subsidiary" means a business entity in which another**  
38 **business entity with an Indiana corporate headquarters has at least an eighty percent (80%)**  
39 **ownership interest.**

40 **Sec. 8. As used in this chapter, "taxpayer" means a business entity that:**

41 (1) has an Indiana corporate headquarters; or

42 (2) is a subsidiary of a business entity with an Indiana corporate headquarters;

43 and that is liable under IC 6-1.1-2-4, as applied under IC 6-1.1-3 or IC 6-1.1-8, for ad valorem  
44 property taxes on abatement property.

45 **Sec. 9. A taxpayer is entitled to a deduction from the assessed value of abatement property**  
46 **in each year in which the abatement property is subject to taxation for ad valorem property**  
47 **taxes.**



1        **Sec. 10. The amount of the deduction is equal to one hundred percent (100%) of the**  
2 **assessed value of the abatement property.**

3        **Sec. 11. The deduction includes ad valorem property taxes calculated using aircraft ground**  
4 **times.**

5        **Sec. 12. To qualify for the deduction, the taxpayer must claim the deduction, in the manner**  
6 **prescribed by the department of local government finance, on the taxpayer's personal**  
7 **property tax return filed under IC 6-1.1-3 or IC 6-1.1-8 (or an amended return filed within**  
8 **the time allowed under this article) for the abated property to which the deduction applies.**

9        SECTION 181. IC 6-6-6.5-9 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
10 JANUARY 1, 2004]: Sec. 9. (a) The provisions of this chapter pertaining to registration and  
11 taxation shall not apply to any of the following:

12        (1) An aircraft owned by and used exclusively in the service of:

13            (i) the United States government;

14            (ii) a state (except Indiana), territory, or possession of the United States;

15            (iii) the District of Columbia; or

16            (iv) a political subdivision of an entity listed in clause (i), (ii), or (iii).

17        (2) An aircraft owned by a resident of another state and registered in accordance with the laws

23        (4) An aircraft owned or operated by a person who is either an air carrier certificated under  
24 Federal Air Regulation Part 121 or a scheduled air taxi operator certificated under Federal Air  
25 Regulation Part 135, unless such person is a corporation incorporated under the laws of the  
26 state of Indiana, ~~or~~ an individual who is a resident of Indiana, **or a corporation with Indiana**  
27 **corporate headquarters (as defined in IC 6-1.1-12.2-6).**

28        (5) An aircraft which has been scrapped, dismantled, or destroyed, and for which the  
29 airworthiness certificate and federal certificate of registration have been surrendered to the  
30 Federal Aviation Administration by the owner.

31        (6) An aircraft owned by a resident of this state that is not a dealer and that is not based in this  
32 state at any time, if the owner files the required form not later than thirty-one (31) days after  
33 the date of purchase; and furnishes the department with evidence, satisfactory to the  
34 department, verifying where the aircraft is based during the year.

35        (7) An aircraft owned by a dealer for not more than five (5) days if the ownership is part of  
36 an ultimate sale or transfer of an aircraft that will not be based in this state at any time.  
37 However, the dealer described in this subdivision is required to file a report of the transaction  
38 within thirty-one (31) days after the ultimate sale or transfer of ownership of the aircraft. The  
39 report is not required to identify the seller or purchaser but must list the aircraft's origin,  
40 destination, N number, date of each transaction, and ultimate sales price.

41        (8) An aircraft owned by a registered nonprofit museum, if the owner furnishes the department  
42 with evidence satisfactory to the department not later than thirty-one (31) days after the  
43 purchase date. The aircraft must be reported for registration, but the department shall issue the  
44 registration without charge.

45        (b) The provisions of this chapter pertaining to taxation shall not apply to an aircraft owned by  
46 and used exclusively in the service of Indiana or a political subdivision of Indiana or any university  
47 or college supported in part by state funds. That aircraft must be reported for registration, but the





1 department will issue the registration without charge.

2 SECTION 182. [EFFECTIVE JULY 1, 2003] (a) This SECTION applies to a county in which  
3 an entity:

16 on abatement property that was subject to assessment in 2002. The department of local  
17 government finance shall adjust the maximum property tax rate in 2004, and the maximum  
18 property tax rate applies to property taxes first due and payable in 2004 and for each

20 SECTION 183. [EFFECTIVE JANUARY 1, 2004] IC 6-6-6.5-9, as amended by this act,  
21 applies to aircraft excise taxes and registration fees imposed under IC 6-6-6.5 after December  
22 31, 2003.

23 SECTION 184. [EFFECTIVE JANUARY 1, 2003 (RETROACTIVE)] IC 6-1.1-12.2, as added  
24 by this act, applies only to assessment dates after January 1, 2003, and ad valorem property  
25 taxes due and payable after January 1, 2004.

26 SECTION 185. IC 5-10.2-2-2.5, AS AMENDED BY P.L. 61-2002, SECTION 2, IS AMENDED  
27 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 2.5. (a) Each board may establish  
28 investment guidelines and limits on all types of investments (including, but not limited to, stocks  
29 and bonds) and take other actions necessary to fulfill its duty as a fiduciary for all assets under its  
30 control, subject to the limitations and restrictions set forth in section 18 of this chapter,  
31 IC 5-10.3-5-3, and IC 21-6.1-3-9.

32 (b) Each board may commingle or pool assets with the assets of any other persons or entities.  
33 This authority includes, but is not limited to, the power to invest in commingled or pooled funds,

35 detailed records of the assets invested. Any decision to commingle or pool assets is subject to the

37 SECTION 186. IC 5-10.2-2-18 IS ADDED TO THE INDIANA CODE AS A NEW SECTION  
38 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 18. (a) As used in this section,  
39 "high growth company" means a sole proprietorship, firm, corporation, partnership, limited  
40 liability company, limited liability partnership, joint venture, trust, syndicate, or other  
41 business unit or association that:

42 (1) is primarily focused on commercialization of research and development, technology  
43 transfers, or the application of new technology or is determined by the department of  
44 commerce to have significant potential to:

45 (A) bring substantial capital into Indiana;

46 (B) create jobs;



- 1 (C) diversify the business base of Indiana; or  
2 (D) significantly promote the purposes of this chapter in any other way;  
3 (2) has had an average annual net worth of less than twenty million dollars (\$20,000,000)  
4 in each of the last two (2) calendar years; and  
5 (3) is not engaged in a business involving:  
6 (A) real estate;  
7 (B) real estate development;  
8 (C) insurance;  
9 (D) professional services provided by an accountant, a lawyer, or a physician;  
10 (E) retail sales, except when the primary purpose of the business is the development  
11 or support of electronic commerce using the Internet; or  
12 (F) gas and oil exploration.

13 A company that meets the definition of a high growth company under this subsection shall  
14 be considered to meet the definition even if affiliated with one (1) or more other companies  
15 that do not meet the definition and regardless of whether any of the affiliated companies is  
16 engaged in a business involving the matters described in subdivision (3).

17 (b) As used in this section, "Indiana high growth company" means a high growth company  
18 as defined in subsection (a) that:

- 19 (1) has its headquarters in Indiana; and  
20 (2) has:  
21 (A) at least fifty percent (50%) of its employees residing in Indiana; or  
22 (B) at least seventy-five percent (75%) of its assets located in Indiana.

23 (c) If the board decides to allocate part of the fund assets to funds investing in high growth  
24 companies, the board is strongly encouraged to establish the following:

- 25 (1) A goal for investment in funds investing in Indiana high growth companies of at least  
26 twenty-five percent (25%) of the amount allocated to funds investing in high growth  
27 companies.  
28 (2) A preference for investments described in subdivision (1) that are started in or

30 (d) The board has five (5) years after the date the goals in subsection (c) are adopted  
31 to achieve the goal percentages.

32 (e) The board is not required to achieve the goal percentages under subsection (c) if the  
33 board, exercising financial and fiduciary prudence, determines that sufficient appropriate  
34 investments in privately held equity or debt assets are not available in Indiana.

35 (f) This section expires July 1, 2013.

36 SECTION 187. IC 5-10.3-5-3 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY  
37 1, 2003]: Sec. 3. (a) The board shall invest its assets with the care, skill, prudence, and diligence  
38 that a prudent person acting in a like capacity and familiar with such matters would use in the

40 investments in accordance with prudent investment standards, **subject to the limitations and**

9 READ AS FOLLOWS [EFFECTIVE JANUARY 1, 2004]:

10 **Chapter 28. Ethanol Production Tax Credit**

11 Sec. 1. As used in this chapter, "board" refers to the Indiana recycling and energy  
12 development board created by IC 4-23-5.5-2.

13 Sec. 2. As used in this chapter, "ethanol" means agriculturally derived ethyl alcohol.

14 Sec. 3. As used in this chapter, "facility" refers to a facility for the production of ethanol  
15 that satisfies all the following:

16 (1) The facility is located in Indiana.

17 (2) The facility has a capacity to produce at least forty million (40,000,000) gallons of  
18 ethanol a year.

19 (3) The facility, after December 31, 2003, increased its ethanol production capacity by  
20 at least forty million (40,000,000) gallons a year.

21 Sec. 4. As used in this chapter, "pass through entity" means:

22 (1) a corporation that is exempt from the adjusted gross income tax under  
23 IC 6-3-2-2.8(2);

24 (2) a partnership;

25 (3) a limited liability company; or

26 (4) a limited liability partnership.

27 Sec. 5. As used in this chapter, "state tax liability" means a taxpayer's total tax liability  
28 that is incurred under:

29 (1) IC 6-2.5 (the state gross retail and use tax);

30 (2) IC 6-3-1 through IC 6-3-7 (the adjusted gross income tax);

31 (3) IC 6-5.5 (the financial institutions tax); and

32 (4) IC 27-1-18-2 (the insurance premiums tax);

33 as computed after the application of the credits that under IC 6-3.1-1-2 are to be applied  
34 before the credit provided by this chapter.

35 Sec. 6. As used in this chapter, "taxpayer" means an individual or entity that has any state  
36 tax liability.

37 Sec. 7. Subject to section 11 of this chapter, a taxpayer that produces ethanol at a facility  
38 is entitled to a credit against the taxpayer's state tax liability equal to the product of:

39 (1) twelve and one-half cents (\$.125); multiplied by

40 (2) the number of gallons of ethanol produced at the Indiana facility.

41 Sec. 8. If a pass through entity is entitled to a credit under this chapter but does not have  
42 state tax liability against which the tax credit may be applied, a shareholder, partner, or  
43 member of the pass through entity is entitled to a tax credit equal to:

44 (1) the tax credit determined for the pass through entity for the taxable year; multiplied  
45 by

46 (2) the percentage of the pass through entity's distributive income to which the  
47 shareholder, partner, or member is entitled.



1           **Sec. 9. (a) If the amount of the credit determined under this chapter for a taxpayer in a**  
2 **taxable year exceeds the taxpayer's state tax liability for that taxable year, the taxpayer may**  
3 **carry over the excess to the following taxable years. The amount of the credit carryover from**  
4 **a taxable year shall be reduced to the extent that the carryover is used by the taxpayer to**  
5 **obtain a credit under this chapter for any subsequent taxable year.**

6           **(b) A taxpayer is not entitled to a carryback or refund of any unused credit.**

7           **Sec. 10. To receive the credit provided by this chapter, a taxpayer must do the following:**

8           **(1) Claim the credit on the taxpayer's state tax return or returns in the manner**  
9 **prescribed by the department.**

10           **(2) Provide a copy of the board's certificate finding that the facility is a qualified facility**  
11 **under IC 4-23-5.5-17.**

12           **(3) Submit to the department proof of all information that the department determines**  
13 **is necessary for the calculation of the credit provided by this chapter.**

14           **Sec. 11. (a) The total amount of credits allowed a taxpayer under this chapter may not**  
15 **exceed a total of five million dollars (\$5,000,000) for all taxable years.**

16           **(b) The total amount of credits allowed under this chapter may not exceed ten million**  
17 **dollars (\$10,000,000) for all taxpayers and all taxable years.**

18           SECTION 201. IC 8-10-1-1 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
19 2003]: Sec. 1. In order to promote the agricultural, industrial and commercial development of the  
20 state, and to provide for the general welfare by the construction and operation, in cooperation with  
21 the federal government, or otherwise, of a modern port on Lake Michigan and/or the Ohio River,  
22 and/or the Wabash River, **system** with terminal facilities to accommodate water, rail, truck, and  
23 air-borne, **and other forms of** transportation, the Indiana Port Commission is hereby authorized  
24 and empowered to construct, maintain and operate, in cooperation with the federal government, or

30 bonds of the state payable solely from revenues, to pay the cost of such projects. **The commission's**  
31 **powers are not limited to ports and may be exercised throughout Indiana for projects that**  
32 **enhance, foster, aid, provide, or promote economic development, public-private partnerships,**  
33 **and other industrial, commercial, business, and transportation purposes.**

34           SECTION 202. IC 8-10-1-2 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
35 2003]: Sec. 2. As used in this chapter, the following words and terms shall have the following  
36 meanings, unless the context shall indicate another or different meaning or intent:

37           (a) The word "commission" shall mean the Indiana Port Commission created by section 3 of this  
38 chapter, or, if said commission shall be abolished, the board, body or commission succeeding to  
39 the principal functions thereof, or to whom the powers given by this chapter to the commission  
40 shall be given by law.

22 including lands under water and riparian rights acquired by the commission for ~~such~~  
23 construction;  
24 (3) the cost of demolishing or removing any buildings or structures on land so acquired,  
25 including the cost of acquiring any lands to which ~~such~~ buildings or structures may be moved;  
26 (4) the cost of relocating public roads;  
27 (5) **the cost of land or easements therefor, for roads;**  
28 (6) the cost of all machinery and equipment;  
29 (7) financing charges;  
30 (8) interest prior to and during construction and for not exceeding two (2) years after the  
31 estimated date of completion of construction;  
32 (9) **the cost of engineering and legal expenses, plans, specifications, surveys, and estimates**  
33 **of cost, traffic and revenues;**  
34 (10) other expenses necessary or incident to determining the feasibility or practicability of  
35 constructing any such project;  
36 (11) administrative expense; ~~and such~~  
37 (12) other expenses as may be necessary or incident to the **acquisition or** construction of the  
38 project, the financing of ~~such~~ **the acquisition or** construction, and the placing of the project  
39 in operation, **including the amount authorized in the resolution of the port commission**  
40 **providing for the issuance of port commission revenue bonds to be paid into any special**  
41 **funds from the proceeds of the bonds; and**  
42 (13) any obligation, cost, or expense incurred by any governmental agency or person for  
43 surveys, borings, the preparation of plans and specifications, and other engineering  
44 services, or any other cost described in this section that is incurred in connection with  
45 the acquisition or construction of a project may be regarded as part of the cost of the  
46 project and may be reimbursed out of the proceeds of port commission revenue bonds

2           (e) The word "owner" shall include all individuals, copartnerships, associations or corporations  
3 having any title or interest in any property, rights, easements and other interests authorized to be  
4 acquired by this chapter.

5           (f) The word "revenues" shall mean all fees, tolls, rentals, gifts, grants, moneys and all other  
6 funds coming into the possession or under the control of the commission by virtue of the terms and  
7 provisions of this ~~chapter~~, **article**, but shall not include real property or personal property other  
8 than money, nor the proceeds from the sale of bonds issued under provisions of this chapter.

9           (g) The word "public roads" shall include all public highways, roads, and streets in the state,  
10 whether maintained by the state, county, city, township or other political subdivision.

11           SECTION 203. IC 8-10-1-3 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
12 2003]: Sec. 3. (a) There is hereby created a commission to be known as the "Indiana port  
13 commission" and by that name the commission may sue and be sued, and plead and be impleaded.  
14 The commission hereby created is a body both corporate and politic in the state of Indiana, and the

33 after their appointment, meet and qualify by subscribing an oath to discharge honestly and faithfully

35 one (1) of the members as chairman and another as vice-chairman, and shall appoint a  
36 secretary-treasurer who need not be a member of the commission. Four (4) members of the  
37 commission shall constitute a quorum and the affirmative vote of four (4) members shall be  
38 necessary for any official action taken by the commission. No vacancy in the membership of the  
39 commission shall impair the rights of a quorum to exercise all the rights and perform all the duties

42 each appointed member of the commission shall give a surety bond to the state in the penal sum of

45 conditioned upon the faithful performance of the duties of the office, to be executed by a surety

2 (d) Each appointed member of the commission shall receive an annual salary of seven thousand,  
3 five hundred dollars (\$7,500), payable in monthly instalments. However, no members of such  
4 commission as appointed hereunder shall receive any salary except a per diem as fixed and  
5 approved by the budget director until said commission is able to carry on the full operations as  
6 intended by this chapter, and the budget director, subject to the approval of the governor of the state  
7 of Indiana, shall determine when said salaries for said commission members shall commence. ~~The~~  
8 ~~governor shall, however, appoint said members as herein provided within a period of sixty (60)~~

10 (e) Each member shall be reimbursed for his actual expenses necessarily incurred in the

14 shall be incurred by the commission hereunder beyond the extent to which moneys shall have been

16 SECTION 204. IC 8-10-1-4 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
17 2003]: Sec. 4. ~~Port~~ Revenue bonds issued under the provisions of this ~~chapter article~~ shall not be  
18 deemed to constitute a debt of the state or of any political subdivision thereof or a pledge of the  
19 faith and credit of the state or of any such political subdivision, but such bonds shall be payable  
20 solely from the funds pledged for their payment as authorized in this ~~chapter article~~, unless such  
21 bonds are refunded by refunding bonds, issued under the provisions of this chapter, which  
22 refunding bonds shall be payable solely from funds pledged for their payment as authorized herein.  
23 All such revenue bonds shall contain on the face thereof a statement to the effect that the bonds,

32 **authorized by the general assembly, the commission may not pledge, in any form, to:**

33 (1) **seek funding from the state in the event of any default in the payment of revenue**

35 (2) **specify, in any form, in an agreement related to revenue bonds that money**  
36 **appropriated by the general assembly may or shall be deposited in a debt service fund**

38 SECTION 206. IC 8-10-1-5 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
39 2003]: Sec. 5. (a) The Indiana port commission may:

40 (1) prepare sketches, plans, and descriptive material relating to ~~such~~ ports or ~~port~~ projects, as  
41 in its discretion may seem feasible, to compile data and prepare literature as to the necessity

13 (b) The title to all property included in any port ~~or~~ project shall be taken in the name of, and  
14 shall be in, the state of Indiana.

15 SECTION 207. IC 8-10-1-7 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
16 2003]: Sec. 7. The commission is authorized and empowered **to do the following:**

17 (1) To adopt bylaws for the regulation of its affairs and the conduct of its business.

18 (2) To adopt an official seal which shall not be the seal of the state of Indiana.

19 (3) To maintain a principal office and sub-offices at such place or places within the state as

36 (7) To acquire, lease, and operate tug boats, locomotives, and any and every kind of motive  
37 power and conveyances or appliances necessary or proper to carry passengers, goods, wares,

39 (8) To fix and revise from time to time and to collect fees, rentals, tolls, and other charges for

41 (9) To acquire, obtain option on, hold, and dispose of real and personal property in the  
42 exercise of its powers and the performance of its duties under this chapter.

43 (10) To designate the location and establish, limit, and control points of ingress to and egress

45 (11) To lease to others for development or operation such portions of any port or ~~port~~ project,  
46 on such terms and conditions as the commission shall deem advisable.



1 (12) To make and enter into all contracts, undertakings, and agreements necessary or  
2 incidental to the performance of its duties and the execution of its powers under this chapter.  
3 When the cost of any such contract for construction, or for the purchase of equipment,  
4 materials, or supplies, involves an expenditure of more than twenty-five thousand dollars  
5 (\$25,000), the commission shall make a written contract with the lowest and best bidder after  
6 advertisement for not less than two (2) consecutive weeks in a newspaper of general  
7 circulation in ~~Marion County, Indiana,~~ **the county where the construction will occur** and  
8 in such other publications as the commission shall determine. The notice shall state the  
9 general character of the work and the general character of the materials to be furnished, the  
10 place where plans and specifications therefor may be examined, and the time and place of  
11 receiving bids. Each bid shall contain the full name of every person or company interested in  
12 it and shall be accompanied by a sufficient bond or certified check on a solvent bank that if  
13 the bid is accepted a contract will be entered into and the performance of its proposal secured.

15 be approved by the commission, shall be required of all contractors in an amount equal to at  
16 least fifty percent (50%) of the contract price conditioned upon the faithful performance of

18 **(13) To construct, assemble, or otherwise build, own, lease, operate, manage, or**  
19 **otherwise control any project throughout Indiana for the purpose of promoting**  
20 **economic growth and development throughout Indiana, retaining existing employment**  
21 **within Indiana, and attracting new employment opportunities within Indiana.**

22 ~~(13)~~ **(14)** To employ an executive director or manager, consulting engineers, superintendents,  
23 and such other engineers, construction and accounting experts, attorneys, and other employees  
24 and agents as may be necessary in its judgment, and to fix their compensation, but no  
25 compensation of any employee of the commission shall exceed the compensation of the  
26 highest paid officer or employee of the state. ~~However, the employment of an attorney shall~~  
27 ~~be subject to such approval of the attorney general as may be required by law.~~

28 ~~(14)~~ **(15)** To receive and accept from any federal agency grants for or in aid of the  
29 construction of any port or ~~port~~ project, and to receive and accept aid or contributions from  
30 any source of either money, property, labor, or other things of value, to be held, used, and  
31 applied only for the purposes for which such grants and contributions may be made.

32 ~~(15)~~ **(16)** To provide coverage for its employees under the provisions of IC 22-3-2 through  
33 IC 22-3-6, and IC 22-4.

34 ~~(16)~~ **(17)** To do all acts and things necessary or proper to carry out the powers expressly  
35 granted in this ~~chapter:~~ **and article.**

36 ~~(17)~~ **(18)** To hold, use, administer, and expend such sum or sums as may herein or hereafter  
37 be appropriated or transferred to the commission.

38 SECTION 208. IC 8-10-1-8 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,  
39 2003]: Sec. 8. If the commission shall find it necessary to change the location of any portion of any  
40 public road, **highway**, railroad, or public utility facility, it shall cause the same to be reconstructed  
41 at such location as the division of government having jurisdiction over such road, highway, railroad  
42 or public utility facility shall deem most favorable and of substantially the same type and in as good  
43 condition as the original road, highway, or railroad or public utility facility. The cost of such  
44 reconstruction, relocation, or removal and any damage incurred in changing the location of any  
45 such road, highway, railroad, or public utility facility, shall be ascertained and paid by the  
46 commission as a part of the cost of ~~such the port or port~~ project. The commission shall have

32 other rights, acquired to accomplish such relocation or removal, shall be ascertained and paid by  
33 the commission as a part of the cost of ~~such the~~ port or ~~port~~ project, excepting, however, cases in  
34 which such equipment or facilities are located within the limits of highways or public thoroughfares  
35 being constructed, reconstructed, or improved under the provisions of this chapter. In case of any  
36 such relocation or removal of facilities, the public utility owning or operating the same, its  
37 successors or assigns, may maintain and operate such facilities, with the necessary appurtenances,  
38 in the new location or new locations, for as long a period, and upon the same terms and conditions,  
39 as it had the right to maintain and operate such facilities in their former location or locations  
40 subject, however, to the state's right of regulation under its police powers.

1 1, 2003]: Sec. 11. The commission is hereby authorized and empowered to acquire by  
2 appropriation, under the provisions of the eminent domain law of the state, any land, including

4 SECTION 242. IC 36-7-13-16, AS AMENDED BY P.L.174-2001, SECTION 11, IS  
5 AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 16. (a) A unit may  
6 issue bonds or other obligations to finance the costs of addressing the development obstacles  
7 described in section 12(b)(3), 12(c), 12(d)(3), ~~or~~ 12(e)(2), **or 12.1(a)** of this chapter in the district.

8 (b) The district bonds are special obligations of indebtedness of the district. The district bonds  
9 issued under this section, and interest on the district bonds, are payable solely out of amounts  
10 deposited in the industrial development fund under this chapter.

11 SECTION 243. [EFFECTIVE JANUARY 1, 2003 (RETROACTIVE)] **IC 6-3.1-19-1.5 and**  
12 **IC 6-3.1-19-2.5, both as added by this act, and IC 6-3.1-19-3, as amended by this act, apply**  
13 **to taxable years beginning after December 31, 2002.**

14 SECTION 244. [EFFECTIVE JULY 1, 2003] (a) **As used in this SECTION, "commission"**  
15 **refers to the government efficiency commission established by subsection (c).**

16 (b) **As used in this SECTION, "state educational institution" has the meaning set forth in**  
17 **IC 20-12-0.5-1.**

18 (c) **The government efficiency commission is established.**

19 (d) **The commission consists of the following members:**

20 (1) **One (1) co-chairperson appointed before July 16, 2003, by the president pro tempore**  
21 **of the senate.**

22 (2) **One (1) co-chairperson appointed before July 16, 2003, by the speaker of the house**  
23 **of representatives.**

24 (3) **Ten (10) members appointed before August 16, 2003, by the president pro tempore**  
25 **of the senate, five (5) of those members appointed with the advice and consent of the**  
26 **minority leader of the senate.**

27 (4) **Ten (10) members appointed before August 16, 2003, by the speaker of the house of**  
28 **representatives, five (5) of those members appointed with the advice and consent of the**  
29 **minority leader of the house of representatives.**

30 (e) **The following may not be members of the commission:**

31 (1) **An elected or appointed state or local official.**

32 (2) **An employee or a person receiving a pension or other retirement benefit related to**  
33 **service to any of the following:**

34 (A) **A state educational institution.**

35 (B) **A school corporation or a charter school.**

36 (C) **The state or any agency of the state.**

37 (3) **A person who has a direct business relationship with any of the following:**

38 (A) **A state educational institution.**

39 (B) **A public school corporation.**

40 (C) **The state or any agency of the state.**

41 (D) **An elected or appointed state agency official.**

42 (E) **The general assembly or any of its members.**

43 (f) **A member of the commission is not entitled to a salary per diem.**

44 (g) **A member of the commission is entitled to reimbursement for traveling expenses and**  
45 **other expenses actually incurred in connection with the member's duties, as provided in the**  
46 **legislative council's travel policies and procedures.**

47 (h) **The commission shall meet upon the call of the co-chairpersons.**



1 (i) The co-chairpersons may advise the president pro tempore of the senate, the minority  
2 leader of the senate, the speaker of the house of representatives, and the minority leader of  
3 the house of representatives concerning the appointment of other members of the  
4 commission.

5 (j) A quorum of the commission must be present to conduct business. A quorum consists  
6 of a majority of the voting members appointed to the commission.

7 (k) The commission may not take an official action unless the official action has been  
8 approved by at least a majority of the voting members appointed to serve on the commission.

9 (l) The co-chairpersons shall establish and appoint commission members to four (4)  
10 subcommittees as follows:

11 (1) The K-12 education subcommittee.

12 (2) The higher education subcommittee.

13 (3) The Medicaid and human services subcommittee.

14 (4) The general government subcommittee.

15 (m) The co-chairpersons shall name the chairperson of each subcommittee.

16 (n) The commission shall do the following:

17 (1) Review all state funded agencies, departments, and programs.

18 (2) Make recommendations to improve efficiency and reduce waste or other unnecessary  
19 costs associated with any state funded agency, department, or program.

20 (o) The commission may accept donations to carry out the purposes of this SECTION.

21 (p) The following persons shall serve as staff advisers to the commission:

22 (1) The state budget director.

23 (2) The commissioner of the commission for higher education.

24 (3) The Indiana state board of education administrator.

25 (4) The executive director of the legislative services agency.

26 (q) The commission shall provide its final recommendations before December 31, 2004, to  
27 the following:

28 (1) The governor.

29 (2) The general assembly.

30 (r) This SECTION expires January 1, 2005.

31 SECTION 245. IC 4-4-5.1-12 IS ADDED TO THE INDIANA CODE AS A NEW SECTION  
32 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 12. The board shall submit an  
33 annual report to the legislative council before September 1. The report must contain the  
34 following information concerning fund activity in the preceding state fiscal year:

35 (1) The name of each entity receiving a grant from the fund.

36 (2) The location of each entity sorted by:

37 (A) county, in the case of an entity located in Indiana; or

38 (B) state, in the case of an entity located outside Indiana.

39 (3) The amount of each grant awarded to each entity.

40 SECTION 246. IC 6-1.1-18.5-13, AS AMENDED BY P.L.192-2002(ss), SECTION 37, IS  
41 AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 13. With respect to an  
42 appeal filed under section 12 of this chapter, the local government tax control board may  
43 recommend that a civil taxing unit receive any one (1) or more of the following types of relief:

44 (1) Permission to the civil taxing unit to reallocate the amount set aside as a property tax  
45 replacement credit as required by IC 6-3.5-1.1 for a purpose other than property tax relief.

46 However, whenever this occurs, the local government tax control board shall also state the  
47 amount to be reallocated.



1 (2) Permission to the civil taxing unit to increase its levy in excess of the limitations  
2 established under section 3 of this chapter, if in the judgment of the local government tax  
3 control board the increase is reasonably necessary due to increased costs of the civil taxing  
4 unit resulting from annexation, consolidation, or other extensions of governmental services  
5 by the civil taxing unit to additional geographic areas or persons.

6 (3) Permission to the civil taxing unit to increase its levy in excess of the limitations  
7 established under section 3 of this chapter, if the local government tax control board finds that  
8 the civil taxing unit needs the increase to meet the civil taxing unit's share of the costs of  
9 operating a court established by statute enacted after December 31, 1973. Before  
10 recommending such an increase, the local government tax control board shall consider all  
11 other revenues available to the civil taxing unit that could be applied for that purpose. The  
12 maximum aggregate levy increases that the local government tax control board may  
13 recommend for a particular court equals the civil taxing unit's share of the costs of operating  
14 a court for the first full calendar year in which it is in existence.

15 (4) Permission to the civil taxing unit to increase its levy in excess of the limitations  
16 established under section 3 of this chapter, if the local government tax control board finds that  
17 the quotient determined under STEP SIX of the following formula is equal to or greater than  
18 one and three-hundredths (1.03):

19 STEP ONE: Determine the three (3) calendar years that most immediately precede the  
20 ensuing calendar year and in which a statewide general reassessment of real property does  
21 not first become effective.

22 STEP TWO: Compute separately, for each of the calendar years determined in STEP ONE,  
23 the quotient (rounded to the nearest ten-thousandth (0.0001)) of the civil taxing unit's total  
24 assessed value of all taxable property in the particular calendar year, divided by the civil  
25 taxing unit's total assessed value of all taxable property in the calendar year immediately  
26 preceding the particular calendar year.

27 STEP THREE: Divide the sum of the three (3) quotients computed in STEP TWO by three  
28 (3).

29 STEP FOUR: Compute separately, for each of the calendar years determined in STEP  
30 ONE, the quotient (rounded to the nearest ten-thousandth (0.0001)) of the total assessed  
31 value of all taxable property of all civil taxing units in the particular calendar year, divided  
32 by the total assessed value of all taxable property of all civil taxing units in the calendar  
33 year immediately preceding the particular calendar year.

34 STEP FIVE: Divide the sum of the three (3) quotients computed in STEP FOUR by three  
35 (3).

36 STEP SIX: Divide the STEP THREE amount by the STEP FIVE amount.

37 In addition, before the local government tax control board may recommend the relief allowed  
38 under this subdivision, the civil taxing unit must show a need for the increased levy because  
39 of special circumstances, and the local government tax control board must consider other  
40 sources of revenue and other means of relief.

41 (5) Permission to the civil taxing unit to increase its levy in excess of the limitations  
42 established under section 3 of this chapter, if the local government tax control board finds that  
43 the civil taxing unit needs the increase to pay the costs of furnishing fire protection for the  
44 civil taxing unit through a volunteer fire department. For purposes of determining a township's  
45 need for an increased levy, the local government tax control board shall not consider the  
46 amount of money borrowed under IC 36-6-6-14 during the immediately preceding calendar  
47 year. However, any increase in the amount of the civil taxing unit's levy recommended by the



1 local government tax control board under this subdivision for the ensuing calendar year may  
2 not exceed the lesser of:

3 (A) ten thousand dollars (\$10,000); or

4 (B) twenty percent (20%) of:

5 (i) the amount authorized for operating expenses of a volunteer fire department in the  
6 budget of the civil taxing unit for the immediately preceding calendar year; plus

7 (ii) the amount of any additional appropriations authorized during that calendar year for  
8 the civil taxing unit's use in paying operating expenses of a volunteer fire department  
9 under this chapter; minus

10 (iii) the amount of money borrowed under IC 36-6-6-14 during that calendar year for the  
11 civil taxing unit's use in paying operating expenses of a volunteer fire department.

12 (6) Permission to a civil taxing unit to increase its levy in excess of the limitations established  
13 under section 3 of this chapter in order to raise revenues for pension payments and  
14 contributions the civil taxing unit is required to make under IC 36-8. The maximum increase  
15 in a civil taxing unit's levy that may be recommended under this subdivision for an ensuing  
16 calendar year equals the amount, if any, by which the pension payments and contributions the  
17 civil taxing unit is required to make under IC 36-8 during the ensuing calendar year exceeds  
18 the product of one and one-tenth (1.1) multiplied by the pension payments and contributions  
19 made by the civil taxing unit under IC 36-8 during the calendar year that immediately precedes  
20 the ensuing calendar year. For purposes of this subdivision, "pension payments and  
21 contributions made by a civil taxing unit" does not include that part of the payments or  
22 contributions that are funded by distributions made to a civil taxing unit by the state.

23 (7) Permission to increase its levy in excess of the limitations established under section 3 of  
24 this chapter if the local government tax control board finds that:

25 (A) the township's poor relief ad valorem property tax rate is less than one and sixty-seven  
26 hundredths cents (\$0.0167) per one hundred dollars (\$100) of assessed valuation; and

27 (B) the township needs the increase to meet the costs of providing poor relief under  
28 IC 12-20 and IC 12-30-4.

29 The maximum increase that the board may recommend for a township is the levy that would  
30 result from an increase in the township's poor relief ad valorem property tax rate of one and  
31 sixty-seven hundredths cents (\$0.0167) per one hundred dollars (\$100) of assessed valuation  
32 minus the township's ad valorem property tax rate per one hundred dollars (\$100) of assessed  
33 valuation before the increase.

34 (8) Permission to a civil taxing unit to increase its levy in excess of the limitations established  
35 under section 3 of this chapter if:

36 (A) the increase has been approved by the legislative body of the municipality with the  
37 largest population where the civil taxing unit provides public transportation services; and

38 (B) the local government tax control board finds that the civil taxing unit needs the increase  
39 to provide adequate public transportation services.

40 The local government tax control board shall consider tax rates and levies in civil taxing units  
41 of comparable population, and the effect (if any) of a loss of federal or other funds to the civil  
42 taxing unit that might have been used for public transportation purposes. However, the  
43 increase that the board may recommend under this subdivision for a civil taxing unit may not  
44 exceed the revenue that would be raised by the civil taxing unit based on a property tax rate  
45 of one cent (\$0.01) per one hundred dollars (\$100) of assessed valuation.

46 (9) Permission to a civil taxing unit to increase the unit's levy in excess of the limitations  
47 established under section 3 of this chapter if the local government tax control board finds that:



- 1 (A) the civil taxing unit is:  
2 (i) a county having a population of more than one hundred forty-eight thousand  
3 (148,000) but less than one hundred seventy thousand (170,000);  
4 (ii) a city having a population of more than fifty-five thousand (55,000) but less than  
5 fifty-nine thousand (59,000);  
6 (iii) a city having a population of more than twenty-eight thousand seven hundred  
7 (28,700) but less than twenty-nine thousand (29,000);  
8 (iv) a city having a population of more than fifteen thousand four hundred (15,400) but  
9 less than sixteen thousand six hundred (16,600); or  
10 (v) a city having a population of more than seven thousand (7,000) but less than seven  
11 thousand three hundred (7,300); and  
12 (B) the increase is necessary to provide funding to undertake removal (as defined in  
13 IC 13-11-2-187) and remedial action (as defined in IC 13-11-2-185) relating to hazardous  
14 substances (as defined in IC 13-11-2-98) in solid waste disposal facilities or industrial sites  
15 in the civil taxing unit that have become a menace to the public health and welfare.

16 The maximum increase that the local government tax control board may recommend for such  
17 a civil taxing unit is the levy that would result from a property tax rate of six and sixty-seven  
18 hundredths cents (\$0.0667) for each one hundred dollars (\$100) of assessed valuation. For  
19 purposes of computing the ad valorem property tax levy limit imposed on a civil taxing unit  
20 under section 3 of this chapter, the civil taxing unit's ad valorem property tax levy for a  
21 particular year does not include that part of the levy imposed under this subdivision. In  
22 addition, a property tax increase permitted under this subdivision may be imposed for only  
23 two (2) calendar years.

24 (10) Permission for a county:

25 (A) having a population of more than eighty thousand (80,000) but less than ninety  
26 thousand (90,000) to increase the county's levy in excess of the limitations established  
27 under section 3 of this chapter, if the local government tax control board finds that the  
28 county needs the increase to meet the county's share of the costs of operating a jail or  
29 juvenile detention center, including expansion of the facility, if the jail or juvenile  
30 detention center is opened after December 31, 1991;

31 **(B) that operates a county jail or juvenile detention center that is subject to an order  
32 that:**

- 33 (i) was issued by a federal district court; and  
34 (ii) has not been terminated;

35 **(C) that operates a county jail that fails to meet:**

- 36 (i) American Correctional Association Jail Construction Standards; and  
37 (ii) Indiana jail operation standards adopted by the department of correction; or

38 **(D) that operates a juvenile detention center that fails to meet standards equivalent  
39 to the standards described in clause (C) for the operation of juvenile detention  
40 centers.**

41 Before recommending an increase, the local government tax control board shall consider all  
42 other revenues available to the county that could be applied for that purpose. An appeal for  
43 operating funds for a jail or a juvenile detention center shall be considered individually, if a  
44 jail and juvenile detention center are both opened in one (1) county. The maximum aggregate  
45 levy increases that the local government tax control board may recommend for a county equals  
46 the county's share of the costs of operating the jail or a juvenile detention center for the first  
47 full calendar year in which the jail or juvenile detention center is in operation.



1 (11) Permission for a township to increase its levy in excess of the limitations established  
2 under section 3 of this chapter, if the local government tax control board finds that the  
3 township needs the increase so that the property tax rate to pay the costs of furnishing fire  
4 protection for a township, or a portion of a township, enables the township to pay a fair and  
5 reasonable amount under a contract with the municipality that is furnishing the fire protection.  
6 However, for the first time an appeal is granted the resulting rate increase may not exceed fifty  
7 percent (50%) of the difference between the rate imposed for fire protection within the  
8 municipality that is providing the fire protection to the township and the township's rate. A  
9 township is required to appeal a second time for an increase under this subdivision if the  
10 township wants to further increase its rate. However, a township's rate may be increased to  
11 equal but may not exceed the rate that is used by the municipality. More than one (1) township  
12 served by the same municipality may use this appeal.

13 (12) Permission for a township to increase its levy in excess of the limitations established  
14 under section 3 of this chapter, if the local government tax control board finds that the  
15 township has been required, for the three (3) consecutive years preceding the year for which  
16 the appeal under this subdivision is to become effective, to borrow funds under IC 36-6-6-14  
17 to furnish fire protection for the township or a part of the township. However, the maximum

23 (13) Permission to a city having a population of more than twenty-nine thousand (29,000) but  
24 less than thirty-one thousand (31,000) to increase its levy in excess of the limitations  
25 established under section 3 of this chapter if:

- 26 (A) an appeal was granted to the city under subdivision (1) in 1998, 1999, and 2000; and  
27 (B) the increase has been approved by the legislative body of the city, and the legislative  
28 body of the city has by resolution determined that the increase is necessary to pay normal  
29 operating expenses.

30 The maximum amount of the increase is equal to the amount of property tax replacement  
31 credits under IC 6-3.5-1.1 that the city petitioned to have reallocated in 2001 under  
32 subdivision (1) for a purpose other than property tax relief.

33 SECTION 247. IC 6-3.5-6-13 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON  
34 PASSAGE]: Sec. 13. (a) A county income tax council of a county in which the county option  
35 income tax is in effect may adopt an ordinance to increase the percentage credit allowed for  
36 homesteads in its county under IC 6-1.1-20.9-2.

37 (b) A county income tax council may not increase the percentage credit allowed for homesteads  
38 by an amount that exceeds ~~eight percent (8%)~~. **the amount determined in the last STEP of the**  
39 **following formula:**

40 **STEP ONE: Determine the amount of the sum of all property tax levies for all taxing**  
41 **units in a county which are to be paid in the county in 2003 as reflected by the auditor's**  
42 **abstract for the 2002 assessment year, adjusted, however, for any postabstract**  
43 **adjustments which change the amount of the levies.**

44 **STEP TWO: Determine the amount of the county's estimated property tax replacement**  
45 **under IC 6-1.1-21-3(a) for property taxes first due and payable in 2003.**

46 **STEP THREE: Subtract the STEP TWO amount from the STEP ONE amount.**

47 **STEP FOUR: Determine the amount of the county's total county levy (as defined in**



1 **IC 6-1.1-21-2(g)) for property taxes first due and payable in 2003.**

2 **STEP FIVE: Subtract the STEP FOUR amount from the STEP ONE amount.**

3 **STEP SIX: Subtract the STEP FIVE result from the STEP THREE result.**

4 **STEP SEVEN: Divide the STEP THREE result by the STEP SIX result.**

5 **STEP EIGHT: Multiply the STEP SEVEN result by eight-hundredths (0.08).**

6 **STEP NINE: Round the STEP EIGHT product to the nearest one thousandth and**  
7 **express the result as a percentage.**

8 (c) The increase of the homestead credit percentage must be uniform for all homesteads in a  
9 county.

10 (d) In the ordinance that increases the homestead credit percentage, a county income tax council  
11 may provide for a series of increases or decreases to take place for each of a group of succeeding  
12 calendar years.

13 (e) An ordinance may be adopted under this section after January 1 but before June 1 of a  
14 calendar year.

15 (f) An ordinance adopted under this section takes effect on January 1 of the next succeeding  
16 calendar year.

17 (g) Any ordinance adopted under this section for a county is repealed for a year if on January  
18 1 of that year the county option income tax is not in effect.

19 **SECTION 248. [EFFECTIVE UPON PASSAGE] (a) Notwithstanding IC 6-3.5-6-13, as**  
20 **amended by this act, or any other law, a county income tax council of a county in which the**  
21 **county option income tax is in effect may adopt an ordinance to increase the percentage credit**  
22 **allowed for homesteads in its county under IC 6-1.1-20.9-2 for property taxes first due and**  
23 **payable in 2003 and each year thereafter.**

24 (b) An ordinance may be adopted under this SECTION before July 1, 2003.

25 (c) Property tax statements mailed under IC 6-1.1-22 before July 1, 2003, in a county  
26 adopting an ordinance under this SECTION are superseded by property tax statements  
27 recalculated to implement this SECTION.

28 (d) The department of local government finance shall assist a county adopting an  
29 ordinance under this SECTION in implementing this SECTION.

30 (e) This SECTION expires January 1, 2004.

31 **SECTION 249. IC 6-9-10-5 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON**  
32 **PASSAGE]: Sec. 5. (a) For purposes of this section, "person" includes a sole proprietorship,**  
33 **a partnership, an association, a corporation, a limited liability company, a fiduciary, or an**  
34 **individual.**

35 (b) The board may:

36 (1) accept and use gifts, grants, and contributions from any public or private source, under  
37 terms and conditions which the board deems necessary and desirable;

38 (2) sue and be sued;

39 (3) enter into contracts and agreements;

40 (4) make rules and regulations necessary for the conduct of its business and the  
41 accomplishment of its purposes; and

42 (5) receive and approve, alter, or reject requests and proposals for funding by organizations;

43 and

44 (6) either:

45 (A) finance facilities; or

46 (B) enter into contracts with a person to assist in the financing of facilities;





1 to be used by the board or a person to promote the development and growth of the  
2 convention and tourism industry in the county.

3 (c) By resolution of the board and by ordinance of the county fiscal body, the board and  
4 the county may jointly:

5 (1) pledge tax revenues received under this chapter to pay:

6 (A) the principal of or interest on bonds;

8 (C) other obligations of the county;

9 to finance facilities described in subsection (b)(6); or

10 (2) require financial or other reports from:

13 (d) The board may pledge tax revenues received under this chapter to pay the interest on  
14 obligations entered into by a person with whom the board has entered into a contract to assist  
15 in financing facilities under subsection (b)(6).

16 (e) A pledge of revenues under this section is enforceable under IC 5-1-14-4.

17 SECTION 250. IC 6-9-10-6 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON  
18 PASSAGE]: Sec. 6. (a) There is imposed a tax on every person engaged in the business of renting  
19 or furnishing, for periods of less than thirty (30) days, any room or rooms, lodging, or  
20 accommodations in any hotel, motel, inn, university residence hall, tourist camp, or tourist cabin  
21 located in the county. However, the tax is not imposed on the renting or furnishing of rooms,  
22 lodgings, or accommodations to a person for a period of thirty (30) days or more, or on the renting  
23 or furnishing of any room, lodging, or accommodations in a university or college residence hall to  
24 a student participating in a course of study for which the student receives college credit from a  
25 college or university located in the county.

26 (b) The tax shall be imposed at the rate of three percent (3%) on the gross income derived from  
27 lodging income only. **Except as provided in subsection (g)**, the fiscal body of the county may  
28 increase the tax rate up to a maximum rate of five percent (5%). The tax is in addition to the state  
29 gross retail tax imposed on such persons by IC 6-2.5.

30 (c) The county fiscal body may adopt an ordinance to require that the tax be reported on forms  
31 approved by the county treasurer and that the tax shall be paid monthly to the county treasurer. If  
32 such an ordinance is adopted, the tax shall be paid to the county treasurer not more than twenty (20)  
33 days after the end of the month the tax is collected. If such an ordinance is not adopted, the tax shall  
34 be imposed, paid, and collected in exactly the same manner as the state gross retail tax is imposed,  
35 paid, and collected pursuant to IC 6-2.5.

36 (d) All of the provisions of IC 6-2.5 relating to rights, duties, liabilities, procedures, penalties,  
37 definitions, exemptions, and administration shall be applicable to the imposition and administration  
38 of the tax imposed by this section except to the extent such provisions are in conflict or inconsistent  
39 with the specific provisions of this chapter or the requirements of the county treasurer. Specifically,  
40 and not in limitation of the foregoing sentence, the terms "person" and "gross income" have the  
41 same meaning in this section as they have in IC 6-2.5, except that "person" does not include state  
42 supported educational institutions.

43 (e) If the tax is paid to the department of state revenue, the returns to be filed for the payment  
44 of the tax under this section may be either a separate return or may be combined with the return  
45 filed for the payment of the state gross retail tax, as the department of state revenue may by rule  
46 determine.

22 **Sec. 4. "Economic development" refers to the purposes described in IC 4-1.5-1-1.**

23 **Sec. 5. "Office" refers to the office of economic development established by IC 4-1.5-7-1.**

24 **Chapter 3. Indiana economic development corporation**

25 **Sec. 1. The Indiana economic development corporation is established.**

26 **Sec. 2. The corporation is a body politic and corporate, not a state agency but an**  
27 **independent instrumentality exercising essential public functions.**

28 **Sec. 3. Employees of the corporation are not employees of the state.**

29 **Chapter 4. Corporation Board**

30 **Sec. 1. The corporation shall be governed by a board.**

31 **Sec. 2. The board is composed of the following twenty-three (23) members, none of whom**  
32 **may be members of the general assembly:**

- 33 (1) **Three (3) persons appointed by the governor who must be employed in or retired**  
34 **from the private or nonprofit sector.**
- 35 (2) **The lieutenant governor.**
- 36 (3) **Three (3) persons appointed by the speaker of the house of representatives who must**  
37 **be employed in or retired from the private or nonprofit sector.**
- 38 (4) **Three (3) persons appointed by the minority leader of the house of representatives**  
39 **who must be employed in or retired from the private or nonprofit sector.**
- 40 (5) **Three (3) persons appointed by the president pro tempore of the senate who must be**  
41 **employed in or retired from the private or nonprofit sector.**
- 42 (6) **Three (3) persons appointed by the minority leader of the senate who must be**  
43 **employed in or retired from the private or nonprofit sector.**
- 44 (7) **One (1) person appointed by the president of Indiana University who must be**  
45 **employed in or retired from the private or nonprofit sector or academia.**
- 46 (8) **One (1) person appointed by the president of Purdue University who must be**



1 employed in or retired from the private or nonprofit sector or academia.

2 (9) One (1) person appointed by the president of Indiana State University who must be  
3 employed in or retired from the private or nonprofit sector or academia.

4 (10) One (1) person appointed by the president of Ball State University who must be  
5 employed in or retired from the private or nonprofit sector or academia.

6 (11) One (1) person appointed by the president of the University of Southern Indiana  
7 who must be employed in or retired from the private or nonprofit sector or academia.

8 (12) One (1) person appointed by the president of Ivy Tech State College who must be  
9 employed in or retired from the private or nonprofit sector or academia.

10 (13) One (1) person appointed by the president of Vincennes University who must be  
11 employed in or retired from the private or nonprofit sector or academia.

12 **Sec. 3. Subject to section 4 of this chapter, the terms of office of the members of the board  
13 are as follows:**

14 (1) Members appointed by the governor, president pro tempore of the senate, or  
15 minority leader of the senate serve for terms of four (4) years.

16 (2) Members appointed by the speaker of the house of representatives, the minority  
17 leader of the house of representatives, or the president of a university or college serve  
18 for terms of two (2) years.

19 Each member shall hold office for the term of appointment and shall continue to serve after  
20 expiration of the appointment until a successor is appointed and qualified. Members are  
21 eligible for reappointment.

22 **Sec. 4. The initial members of the board must be appointed before July 16, 2003. Each

29 of the board are entitled to receive reimbursement for actual and necessary expenses on the  
30 same basis as state employees.**

31 **Sec. 7. Fifteen (15) members constitute a quorum for the transaction of business. The  
32 affirmative vote of at least twelve (12) members is necessary for any action to be taken by the  
33 board. Members may vote by written proxy delivered in advance to any other member who  
34 is present at the meeting.**

35 **Sec. 8. Meetings of the board shall be held at the call of the chairperson or whenever any  
36 six (6) members request a meeting. The members shall meet at least once every three (3)  
37 months to attend to the business of the board.**

### 38 **Chapter 5. General Powers**

39 **Sec. 1. Beginning July 1, 2005, the corporation shall carry out the economic development  
40 functions of the state in conformity with the laws enacted by the general assembly. Until July  
41 1, 2005, the board of the corporation shall serve as an advisory board to the state on economic  
42 development matters.**

43 **Sec. 2. The corporation is granted all powers necessary or appropriate to carry out and  
44 effectuate the corporation's public and corporate purposes under this chapter.**

45 **Sec. 3. The corporation may, without the approval of the attorney general or any other  
46 state officer, employ bond counsel (after June 30, 2005), other legal counsel, technical experts,  
47 and other officers, agents, and employees, permanent or temporary, the corporation**



1 considers necessary to carry out the efficient operation of the corporation.

2 **Sec. 4.** The corporation shall determine qualifications, duties, compensation, and terms of  
3 service for persons employed by the corporation as employees or as independent contractors.

4 **Sec. 5.** After June 30, 2005, the corporation may incur debt. Debt incurred by the  
5 corporation does not represent or constitute a debt of the state within the meaning of the  
6 Constitution of the State of Indiana or Indiana statutes.

7 **Chapter 6. Duties; Oversight**

8 **Sec. 1.** On July 1, 2005, the following entities become subsidiaries or agencies of the  
9 corporation:

10 (1) Indiana small business development corporation established under IC 4-3-12-1.

11 (2) Indiana economic development council established under IC 4-3-14.

12 (3) Indiana development finance authority established by IC 4-4-11-4.

13 (4) The Indiana twenty-first century research and technology fund established under  
14 IC 4-4-5.1.

15 (5) The Indiana venture fund established under IC 4-4-11.7.

16 **Sec. 2.** Beginning July 1, 2005, the corporation is responsible for overseeing the operations  
17 of the entities described in section 1 of this chapter.

18 **Sec. 3.** The corporation shall do the following:

19 (1) Create and regularly update a strategic economic development plan.

20 (2) Establish strategic benchmarks and performance measures.

21 (3) Monitor and report on Indiana's economic performance.

22 (4) Market Indiana to businesses worldwide.

23 (5) Assist Indiana businesses that want to grow.

24 (6) Solicit funding from the private sector for selected initiatives.

25 **Chapter 7. Office of Economic Development**

26 **Sec. 1.** The office of economic development is established within the corporation.

27 **Sec. 2.** The office shall staff the board.

28 **Sec. 3.** The office shall carry out the functions of the corporation under the direction of the  
29 board.

30 **SECTION 261.** [EFFECTIVE JULY 1, 2003] (a) The duties conferred on the department of  
31 commerce relating to energy policy are transferred to the office of energy policy on July 1,  
32 2005.

33 (b) The rules adopted by the department of commerce concerning energy policy before  
34 July 1, 2005, are considered, after June 30, 2005, rules of the office of energy policy until the  
35 office of energy policy adopts replacement rules.

36 (c) On July 1, 2005, the office of energy policy becomes the owner of all property relating  
37 to energy policy of the department of commerce.

38 (d) Any appropriations to the department of commerce relating to energy policy and any  
39 funds relating to energy policy under the control or supervision of the department of  
40 commerce on June 30, 2005, are be transferred to the control or supervision of the office of  
41 energy policy on July 1, 2005.

42 (e) The legislative services agency shall prepare legislation for introduction in the 2004  
43 regular session of the general assembly to organize and correct statutes affected by the  
44 transfer of responsibilities to the office of energy policy by this act.

45 (f) This SECTION expires January 1, 2006.

46 **SECTION 262.** [EFFECTIVE JULY 1, 2003] (a) The duties conferred on the department of  
47 commerce relating to tourism and community development are transferred to the department



1 of tourism and community development on July 1, 2005.

2 (b) The rules adopted by the department of commerce concerning tourism and community  
3 development before July 1, 2005, are considered, after June 30, 2005, rules of the department  
4 of tourism and community development until the department of tourism and community  
5 development adopts replacement rules.

6 (c) On July 1, 2005, the department of tourism and community development becomes the  
7 owner of all property relating to tourism promotion and community development of the  
8 department of commerce.

9 (d) Any appropriations to the department of commerce relating to tourism and community  
10 development and funds relating to tourism and community development under the control  
11 or supervision of the department of commerce on June 30, 2005, are transferred to the  
12 control or supervision of the department of tourism and community development on July 1,  
13 2005.

14 (e) The legislative services agency shall prepare legislation for introduction in the 2004  
15 regular session of the general assembly to organize and correct statutes affected by the  
16 transfer of responsibilities to the department of tourism and community development by this  
17 act.

18 (f) This SECTION expires January 1, 2006.

19 SECTION 263. [EFFECTIVE JULY 1, 2003] (a) The duties conferred on the department of  
20 commerce relating to economic development in Indiana, except those relating to energy policy  
21 or tourism and community development, are transferred to the Indiana economic  
22 development corporation established by IC 4-1.5-3-1, as added by this act, on July 1, 2005.

23 (b) The rules and policies adopted by the department of commerce related to economic  
24 development, except those related to energy policy and tourism and community development,  
25 before July 1, 2005, are considered, after June 30, 2005, policies of the Indiana economic  
26 development corporation until the corporation adopts replacement policies.

27 (c) On July 1, 2005, the Indiana economic development corporation becomes the owner of  
28 all property and obligations of the department of commerce that are associated with the  
29 economic development activities of the department of commerce, except property and

31 (d) Any appropriations to the department of commerce and funds under the control or  
32 supervision of the department of commerce related to its economic development functions,

36 (e) Any reference in a law or other document to the department of commerce or director

40 (f) The legislative services agency shall prepare legislation for introduction in the 2004

44 SECTION 264. [EFFECTIVE JULY 1, 2003] The following bodies corporate and politic are  
45 transferred to the Indiana economic development corporation to be operated as separate  
46 corporate entities under the supervision of the Indiana economic development corporation  
47 on July 1, 2005:

4 SECTION 265. IC 5-1-14-12.5 IS ADDED TO THE INDIANA CODE AS A NEW SECTION  
5 TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 12.5. Notwithstanding any**  
6 **other law, an issuer may purchase any obligations on terms the issuer finds reasonable and**  
7 **may issue its obligations to effectuate that purpose on terms that the issuer finds reasonable.**

8 SECTION 266. IC 6-1.1-10-15.5 IS ADDED TO THE INDIANA CODE AS A NEW SECTION  
9 TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 15.5. (a) As used in this**  
10 **section, "airport development zone" means an airport development zone designated under**  
11 **IC 8-22-3.5-5.**

12 (b) As used in this section, "allocated tax proceeds" refers to property taxes allocated  
13 under IC 8-22-3.5-9.

14 (c) As used in this section, "commission" has the meaning set forth in IC 8-22-3.5-2.

15 (d) As used in this section, "qualified airport development project" has the meaning set

17 (e) Before a person maintaining commercial passenger aircraft that is not subject to the  
18 aircraft excise tax under IC 6-6-6.5 may claim an exemption from property taxation for the

12 **resolution to amend the definition to include that portion or expansion.**

13 SECTION 268. IC 8-22-3.5-15, AS AMENDED BY P.L.192-2002(ss), SECTION 149, IS  
14 AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 15. (a) As used in  
15 this section, "state income tax liability" means a tax liability that is incurred under:

35 AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 25.1. (a) In  
36 addition to other methods of raising money for property acquisition or redevelopment in a blighted  
37 area, and in anticipation of the special tax to be levied under section 27 of this chapter, the taxes  
38 allocated under section 39 of this chapter, or other revenues of the district, or any combination of

5 (b) If the redevelopment commission plans to acquire different parcels of land or let different  
6 contracts for redevelopment work at approximately the same time, whether under one (1) or more  
7 resolutions, the commission may provide for the total cost in one (1) issue of bonds.

8 (c) The bonds must be dated as set forth in the bond resolution and negotiable, subject to the  
9 requirements of the bond resolution for registering the bonds. The resolution authorizing the bonds  
10 must state:

- 11 (1) the denominations of the bonds;
- 12 (2) the place or places at which the bonds are payable; and
- 13 (3) the term of the bonds, which may not exceed fifty (50) years.

14 The resolution may also state that the bonds are redeemable before maturity with or without a  
15 premium, as determined by the redevelopment commission.

16 (d) The redevelopment commission shall certify a copy of the resolution authorizing the bonds  
17 to the municipal or county fiscal officer, who shall then prepare the bonds, **subject to subsection**  
18 **(p)**. The seal of the unit must be impressed on the bonds, or a facsimile of the seal must be printed  
19 on the bonds.

20 (e) The bonds must be executed by the appropriate officer of the unit, and attested by the  
21 municipal or county fiscal officer.

22 (f) The bonds are exempt from taxation for all purposes.

23 (g) The municipal or county fiscal officer shall give notice of the sale of the bonds by  
24 publication in accordance with IC 5-3-1. The municipal fiscal officer, or county fiscal officer or  
25 executive, shall sell the bonds to the highest bidder, but may not sell them for less than ninety-seven

- 39 (3) from other revenues available to the redevelopment commission; or
- 40 (4) from a combination of the methods stated in subdivisions (1) through (3).

41 If the bonds are payable solely from the tax proceeds allocated under section 39(b)(2) of this  
42 chapter, other revenues of the redevelopment commission, or any combination of these sources,  
43 they may be issued in any amount without limitation.

44 (j) Proceeds from the sale of bonds may be used to pay the cost of interest on the bonds for a  
45 period not to exceed five (5) years from the date of issuance.

46 (k) All laws relating to the giving of notice of the issuance of bonds, the giving of notice of a  
47 hearing on the appropriation of the proceeds of the bonds, the right of taxpayers to appear and be



1 heard on the proposed appropriation, and the approval of the appropriation by the department of  
2 local government finance apply to all bonds issued under this chapter that are payable from the  
3 special benefits tax levied pursuant to section 27 of this chapter or from taxes allocated under  
4 section 39 of this chapter.

5 (l) All laws relating to the filing of petitions requesting the issuance of bonds and the right of  
6 taxpayers to remonstrate against the issuance of bonds apply to bonds issued under this chapter,  
7 except for bonds payable solely from tax proceeds allocated under section 39(b)(2) of this chapter,  
8 other revenues of the redevelopment commission, or any combination of these sources.

9 (m) If a debt service reserve is created from the proceeds of bonds, the debt service reserve may  
10 be used to pay principal and interest on the bonds as provided in the bond resolution.

11 (n) Any amount remaining in the debt service reserve after all of the bonds of the issue for which  
12 the debt service reserve was established have matured shall be deposited in the allocation fund  
13 established under section 39(b)(2) of this chapter.

14 (o) If bonds are issued under this chapter that are payable solely or in part from revenues to the  
15 redevelopment commission from a project or projects, the redevelopment commission may adopt  
16 a resolution or trust indenture or enter into covenants as is customary in the issuance of revenue  
17 bonds. The resolution or trust indenture may pledge or assign the revenues from the project or  
18 projects, but may not convey or mortgage any project or parts of a project. The resolution or trust  
19 indenture may also contain any provisions for protecting and enforcing the rights and remedies of  
20 the bond owners as may be reasonable and proper and not in violation of law, including covenants  
21 setting forth the duties of the redevelopment commission. The redevelopment commission may  
22 establish fees and charges for the use of any project and covenant with the owners of any bonds to  
23 set those fees and charges at a rate sufficient to protect the interest of the owners of the bonds. Any  
24 revenue bonds issued by the redevelopment commission that are payable solely from revenues of  
25 the commission shall contain a statement to that effect in the form of bond.

26 **(p) If the total principal amount of bonds authorized by a resolution of the redevelopment**  
27 **commission is equal to or greater than three million dollars (\$3,000,000), the bonds may not**  
28 **be issued without the approval, by resolution, of the legislative body of the unit.**

29 SECTION 270. IC 20-1-20.5-8, AS ADDED BY P.L.146-1999, SECTION 1, IS AMENDED  
30 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 8. (a) The roundtable shall provide

23   county in which:

24       (1) the average annualized unemployment rate in each of the two (2) calendar years

15 result in an allocation in the county from all industrial development projects in the county  
16 of not more than five hundred thousand dollars (\$500,000)) to the industrial development  
17 project area fund for an industrial development project:

23 (A) are incurred by an individual or entity that leases, controls, uses, or operates in;

25 (B) are attributable to a taxable event related to or earned through lease, control, use,

27 facilities developed through an industrial development project, including gross retail  
28 taxes collectible by a retail merchant on goods or services provided to the individual or  
29 entity.

30 (3) Covered taxes that:

31 (A) are incurred by an individual or entity that is a partner, shareholder, or member  
32 of an entity that leases, controls, uses, or operates in; and

33 (B) are attributable to a taxable event related to or earned through lease, control, use,  
34 or operations in;

35 facilities developed through an industrial development project.

36 (4) Four percent (4%) of covered taxes on wages or other compensation earned by  
37 persons employed or providing services at facilities financed through an industrial  
38 development project, including services related to the construction, reconstruction,  
39 improvement, or repair of the facilities.

40 The power to allocate money under this section expires not later than two (2) years after the  
41 beginning date specified by the authority.

42 Sec. 4. (a) The authority shall provide the department of state revenue, the auditor of state,  
43 and the budget agency with a copy of any resolution adopted under section 2 of this chapter  
44 and the related financing agreement.

45 (b) A resolution adopted under section 2 of this chapter is subject to the approval of the  
46 budget agency. The budget agency shall notify the authority, the department of state revenue,  
47 and the auditor of state of its decision concerning the resolution.



- 1 (c) Upon receipt of notification that the budget agency has approved the resolution:  
2 (1) the auditor of state shall establish an industrial development project area fund for

4 (2) the department of state revenue shall compute the base allocation amount for the

6 (3) the department of state revenue shall annually deposit the covered taxes subject to

16 the calendar year immediately preceding the calendar year in which the resolution is adopted

18 **Sec. 6.** An industrial development project area fund established under section 4 of this  
19 chapter shall be treated as a trust fund. Money in an industrial development project area  
20 fund is annually appropriated for purposes of the industrial development project for which  
21 it was created and may be used only for the purposes specified in the resolution and financing  
22 agreement for the industrial development project. Money in the industrial development  
23 project area fund at the end of a state fiscal year does not revert to the state general fund.  
24 However, unencumbered money remaining in an industrial development project area fund

27 **Sec. 7.** The department of state revenue may adopt rules under IC 4-22-2 and prescribe  
28 forms to carry out its responsibilities under this chapter, including the establishment of  
29 requirements concerning the filing of informational returns necessary to identify tax receipts  
30 that are to be deposited in an industrial development project area fund.

31 **Sec. 8.** This chapter expires July 1, 2005.

32 **SECTION 275.** [EFFECTIVE JULY 1, 2003] (a) The department of state revenue may adopt  
33 rules in the manner provided for the adoption of emergency rules under IC 4-22-2-37.1 to  
34 carry out its responsibilities under IC 4-4-31, as added by this act. A rule adopted under this  
35 SECTION expires on the latest of the following:

- 36 (1) The date specified by the department of state revenue in a rule.  
37 (2) The date the department of state revenue adopts a temporary or permanent rule to  
38 replace another rule adopted under this SECTION.  
39 (3) July 1, 2005.

40 (b) This SECTION expires July 2, 2005.

41 **SECTION 276.** IC 5-13-9-10 IS ADDED TO THE INDIANA CODE AS A NEW SECTION  
42 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: **Sec. 10.** (a) The investing officers of  
43 two (2) or more political subdivisions located within a county may establish a joint investment  
44 fund by entering into a written master agreement that defines the rights and obligations of  
45 the participating political subdivisions.

46 (b) An investing officer of a political subdivision that enters into a written master  
47 agreement under subsection (a) may pay funds that are held by the investing officer and that



1 are available for investment into the joint investment fund.

2 (c) The fund shall be administered by a board, which must be comprised of the investing

26 (C) provide any other services appropriate and customary for a custodian;

28 (6) The board of a joint investment fund may select and contract with a fund  
29 administrator to provide investment advice to the board and any other services  
30 determined by the board to be appropriate and necessary for the efficient administration  
31 and accounting of the joint investment fund. The fund administrator shall agree to  
32 recommend only securities and other investments as prescribed in the written policies  
33 established by the board in rendering investment advice to the board and shall agree to  
34 be responsible, accountable, and liable for any breach of this provision. The fund  
35 administrator must have experience in the investment of public funds for governmental  
36 entities and must be either of the following:

37 (A) A financial institution located in Indiana.

38 (B) Registered as an investment adviser with the United States Securities and  
39 Exchange Commission under the Investment Advisors Act of 1940, as amended (15  
40 U.S.C. 80a-9 et seq.), with public funds under management in the amount of at least  
41 one hundred million dollars (\$100,000,000).

42 (7) A joint investment fund must be audited at least annually by an independent auditing  
43 firm, with a copy of the audit provided to each participating political subdivision.

44 (8) The administrative expenses of a joint investment fund, including fees for the fund  
45 administrator, custodian, auditor, and other professional services, must be paid from the  
46 fund's interest earnings.

47 (9) The interest earnings that exceed the administrative expenses of a joint investment



1 fund must be credited to each political subdivision participating in the joint investment  
2 fund in a manner that equitably reflects the differing amounts and terms of the political  
3 subdivision's investment in the joint investment fund.

4 (10) Each participating political subdivision shall receive reports, including a daily  
5 transaction confirmation reflecting any activity in the political subdivision's account and  
6 monthly reports reflecting its investment activity in the joint investment fund and the  
7 performance and composition of the joint investment fund itself.

8 (11) The board of a joint investment fund shall meet at least annually to review the

12 necessary for the efficient administration and accounting of the joint investment fund

30 (d) In addition to reviewing the commission report prepared under subsection (c), the regulatory  
31 flexibility committee shall also issue a report and recommendations to the legislative council by  
32 November 1 ~~1993~~, ~~and of each year thereafter~~ that is based on a review of the following issues:

33 (1) The effects of competition in the telephone industry and impact of competition on  
34 available subsidies used to maintain universal service.

35 (2) The status of modernization of the public telephone network in Indiana and the incentives  
36 required to further enhance this infrastructure.

37 (3) The effects on economic development and educational opportunities of this modernization.

38 (4) The current method of regulating telephone companies and the method's effectiveness.

39 (5) The economic and social effectiveness of current telephone service pricing.

40 (6) All other telecommunications issues the committee deems appropriate.

41 (e) The regulatory flexibility committee shall meet on the call of the ~~co-chairmen~~  
42 **co-chairpersons** to study telecommunications issues described in subsection (d). The committee  
43 shall, with the approval of the commission, retain the independent consultants the committee  
44 considers appropriate to assist the committee in the review and study. The expenses for the  
45 consultants shall be paid by the commission.

46 SECTION 278. IC 4-12-1-11.5 IS ADDED TO THE INDIANA CODE AS A NEW SECTION



1 TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 11.5.** For purposes of any

9 **Sec. 1.** This chapter applies only to the following:

12 (B) are used in the air transportation of passengers or passengers and property; and

13 (C) are owned or operated by a person that is:

14 (i) an air carrier certified under Federal Aviation Regulation Part 121; or

15 (ii) a scheduled air taxi operator certified under Federal Aviation Regulation Part  
16 135.

17 (2) Aircraft that:

18 (A) are used to transport only property, regardless of whether the aircraft is operated  
19 as a common carrier for compensation; and

20 (B) are owned or operated by a person that is:

21 (i) an air carrier certified under Federal Aviation Regulation Part 121; or

22 (ii) a scheduled air taxi operator certified under Federal Aviation Regulation Part  
23 135.

24 **Sec. 2.** As used in this chapter "abatement property" refers to aircraft described in section  
25 1 of this chapter.

26 **Sec. 3.** As used in this chapter, "aircraft" has the meaning set forth in 49 U.S.C. 40102.

27 **Sec. 4.** As used in this chapter, "air transportation" means transportation of passengers  
28 or property by aircraft as a common carrier for compensation.

29 **Sec. 5.** As used in this chapter, "business entity" refers to a corporation (as defined in  
30 IC 6-3-1-10) or partnership (as defined in IC 6-3-1-19).

31 **Sec. 6.** As used in this chapter, "intrastate airline service" means service provided in  
32 Indiana by an aircraft that is used during a service period in which ground time is  
33 determined for purposes of calculating ad valorem property taxes to fly:

34 (1) either directly:

35 (A) between:

36 (i) a qualifying medium hub airport; and

37 (ii) at least two (2) qualifying underserved airports; or

38 (B) between:

39 (i) two (2) qualifying commercial service airports, one (1) of which is not a  
40 qualifying underserved airport; or

41 (ii) a qualifying medium hub airport and a qualifying commercial service airport  
42 other than a qualifying underserved airport; and

43 (2) a route described in subdivision (1)(A) or (1)(B) at least five (5) times per week in

2 airport (as defined in 14 CFR 398.2, as effective January 1, 2003) that is located in Indiana.

3           **Sec. 9.** As used in this chapter, "qualifying underserved airport" means a qualifying  
4 commercial service airport that serves a municipality that is not directly connected by an  
5 interstate highway with a municipality served by a qualifying medium hub airport.

6           **Sec. 10.** As used in this chapter, "service period" means a period beginning March 1 in a  
7 year immediately preceding an assessment date and ending on February 28 in the year  
8 containing an assessment date.

9           **Sec. 11.** As used in this chapter, "taxpayer" means a business entity that is liable under

38           **Sec. 16.** Based on:

39           (1) extraordinary circumstances that prevent a taxpayer from using abatement property

41           (2) the start-up of service after the beginning of a service period;

42 the airport operator of the airports (other than a qualifying medium hub airport) that were  
43 directly affected by reduced service may waive compliance with section 6(2) of this chapter  
44 during all or part of the period in which the circumstances preventing regular service  
45 occurred. A taxpayer shall be treated as in compliance with section 6(2) of this chapter to the  
46 extent that compliance with the provision is waived under this section.

47           **Sec. 17.** To qualify for the deduction, the taxpayer must claim the deduction, in the manner



1 prescribed by the department of local government finance, on the taxpayer's personal  
2 property tax return filed under IC 6-1.1-3 or IC 6-1.1-8 (or an amended return filed within  
3 the time allowed under this article) for the abatement property to which the deduction  
4 applies.

5 SECTION 280. IC 6-6-6.5-12 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
6 JANUARY 1, 2003 (RETROACTIVE)]: Sec. 12. (a) Effective January 1, 1976, there is hereby  
7 imposed an annual license excise tax upon taxable aircraft, which tax shall be in lieu of the ad  
8 valorem property tax levied for state or local purposes. No taxable aircraft shall be assessed as  
9 personal property for the purpose of the assessment and levy of personal property or shall be  
10 subject to ad valorem taxes, beginning with taxes for the year of 1975 payable in 1976 and  
11 thereafter.

12 (b) Eligibility of aircraft for a deduction under IC 6-1.1-12.3 does not exempt a taxpayer  
13 from the tax imposed under this chapter on the aircraft.

14 SECTION 281. IC 8-22-3-25, AS AMENDED BY P.L.1-1999, SECTION 24, IS AMENDED  
15 TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 25. (a) Subject to subsection (c),  
16 the board may provide a cumulative building fund in compliance with IC 6-1.1-41 to provide for  
17 the acquisition of real property, and the construction, enlarging, improving, remodeling, repairing,  
18 or equipping of buildings, structures, runways, or other facilities for use in connection with the  
19 airport and needed to carry out this chapter and to facilitate and support commercial intrastate  
20 air transportation.

21 (b) The board may levy in compliance with IC 6-1.1-41 a tax not to exceed:

22 (1) thirty-three hundredths of one cent (\$0.0033) on each one hundred dollars (\$100) of  
23 assessed value of taxable property within the district, if an eligible entity other than a city  
24 established the district or if the district was established jointly with an eligible entity that is  
25 not a city;

26 (2) one and thirty-three hundredths cents (\$0.0133) on each one hundred dollars (\$100) of  
27 assessed value of taxable property within the district, if the authority was established under  
28 IC 19-6-3 (before its repeal on April 1, 1980); and

29 (3) for any other district not described in subdivision (1) or (2), the following:

40 As the tax is collected it may be invested in negotiable United States bonds or other securities that  
41 the federal government has the direct obligation to pay. Any of the funds collected that are not  
42 invested in government obligations shall be deposited in accordance with IC 5-13-6 and shall be  
43 withdrawn in the same manner as money is regularly withdrawn from the general fund but without  
44 further or additional appropriation. The levy authorized by this section is in addition to the levies  
45 authorized by section 11 and section 23 of this chapter.

46 (c) Spending under subsection (a) to facilitate and support commercial intrastate air  
47 transportation is subject to a maximum of one million dollars (\$1,000,000) cumulatively for



1 all years in which money is spent under that subsection.

2 SECTION 282. [EFFECTIVE JANUARY 1, 2004] IC 6-3.1-27 and 6-3.1-28, both as added  
3 by this act, apply to taxable years beginning after December 31, 2003.

4 SECTION 283. [EFFECTIVE JULY 1, 2002 (RETROACTIVE) Notwithstanding IC  
5 4-33-13-5(a)(1), before July 1, 2003, the first thirty-three million dollars (\$33,000,000) of tax  
6 revenues collected in a state fiscal year under IC 4-33-13 shall be deposited in the state  
7 general fund.

8 SECTION 284. [EFFECTIVE UPON PASSAGE] (a) The provisions of this act are severable  
9 in the manner provided by IC 1-1-1-8(b).

10 (b) If a provision of this act is found by a court of competent jurisdiction to be in violation  
11 of Article 4, Section 23 of the Constitution of the State of Indiana, it is the intent of the  
12 general assembly that the provision be given general application.

13 SECTION 285. An emergency is declared for this act.
