Subject: Indiana Federal Grants Report – Federal Fiscal Year (FFY) 2024

Pursuant to IC 4-3-24-7, the State Budget Agency is required to publish an annual report summarizing the federal assistance received by state agencies for the relevant federal fiscal year. See Attachment A at the end of this document for the full list of federal grant awards received by state agencies for FFY 2024.

In addition, this report provides updated information regarding multi-year trends in Indiana's federal funding. An analysis of Indiana's current data on federal grants reveals two key trends. First, Indiana's federal funding level remains elevated in the wake of the COVID-19 pandemic, even as new COVID funding itself has functionally ended. Second, state match obligations are increasing at an even more rapid rate than federal funding. Rising Medicaid costs are a key driver of both trends.

1) Federal funding remains elevated post-COVID, even as new COVID funding itself has functionally ended.

Indiana received over \$19.5 billion in federal funding in FFY 2024. As [Chart 1](#) shows, this level of funding represents an increase of over \$1.5 billion from FFY 2023, and further outpaces the pre-COVID (FFY 2014-2019) rate of growth even as new COVID-19 relief funding has functionally ended (see [Table 1](#)).

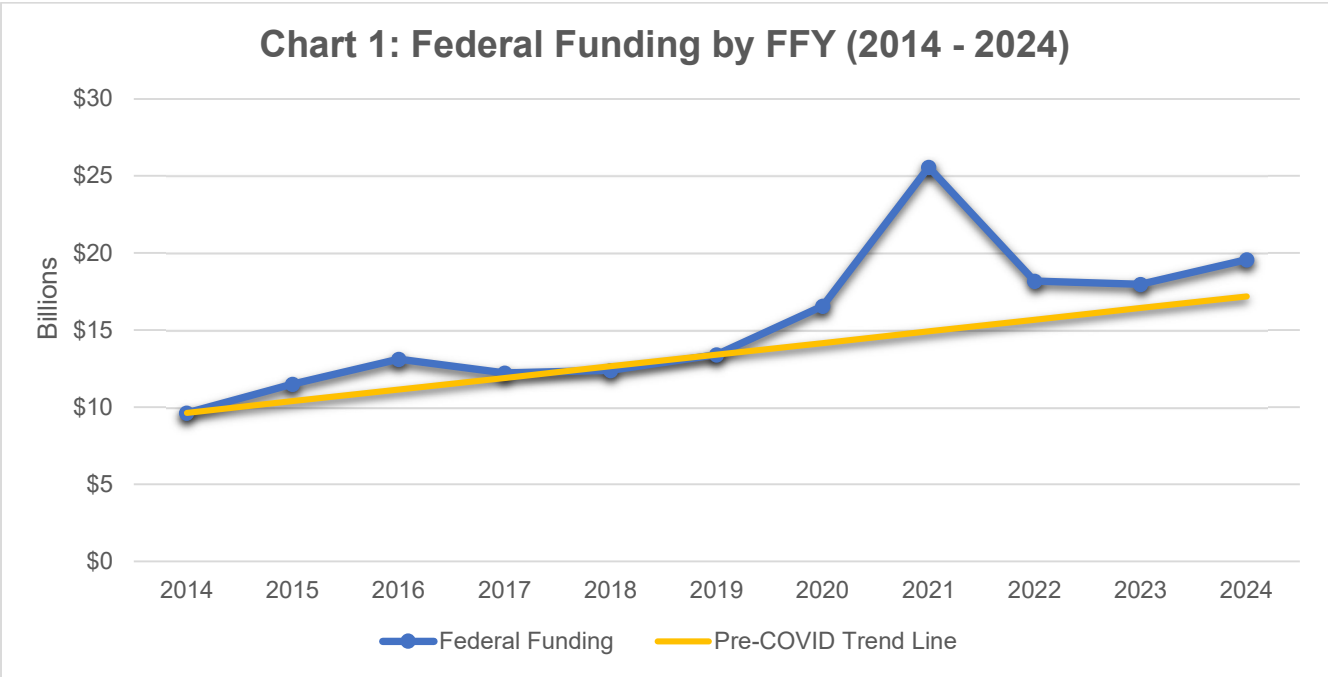
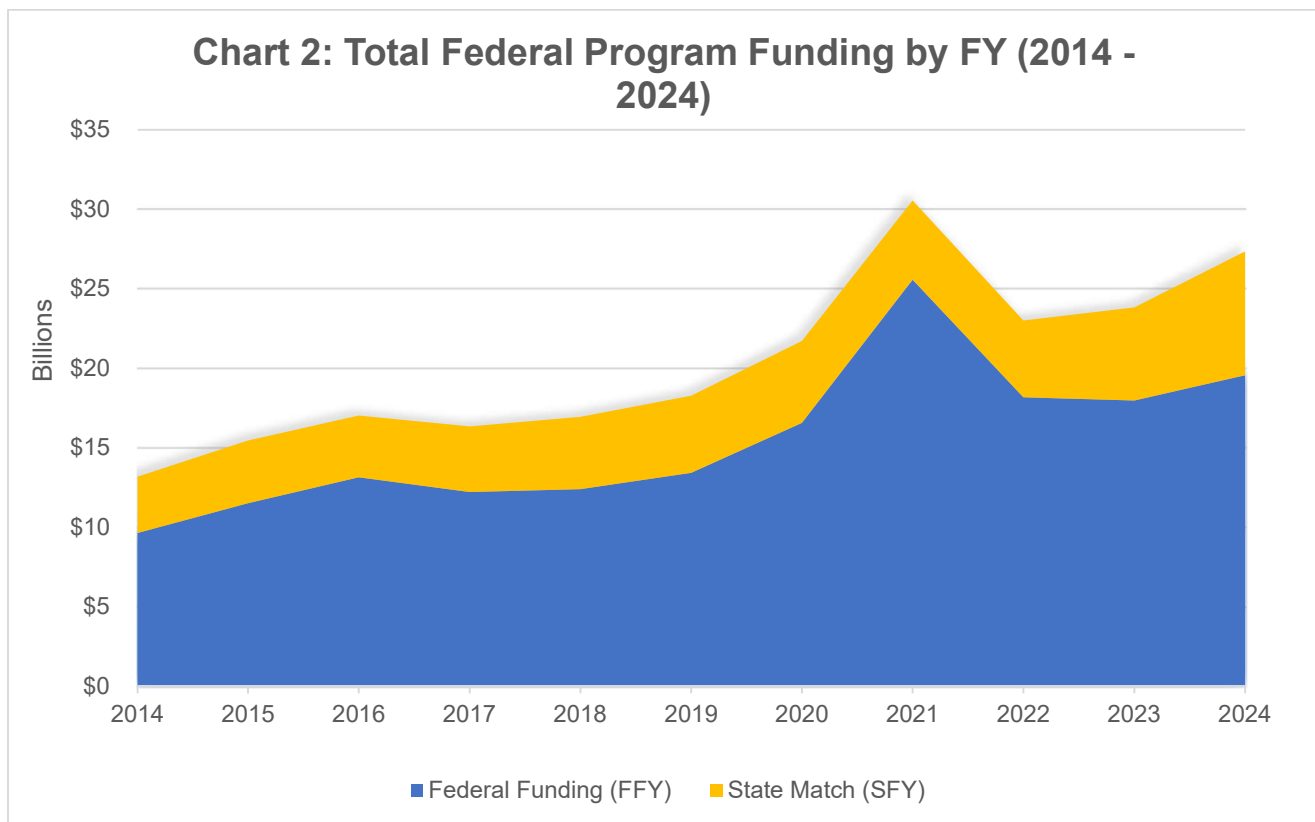

Medicaid is a key driver of growth in Indiana’s federal funding. Indiana’s federal share of Medicaid Payment Assistance increased by \$1.4 billion from FFY 2023 to 2024 and is responsible for nearly all the growth in federal funding during this period.

2) State match obligations are increasing more rapidly than federal funding.

Indiana’s state match funding level for the 2024 state fiscal year (SFY) increased by nearly 33% from 2023, compared to a 9% increase in federal funding from FFY 2023 to 2024. As [Chart 2](#) demonstrates, Indiana’s total 2024 federal program funding level was the second highest on record, and included the highest ever level of corresponding state match.



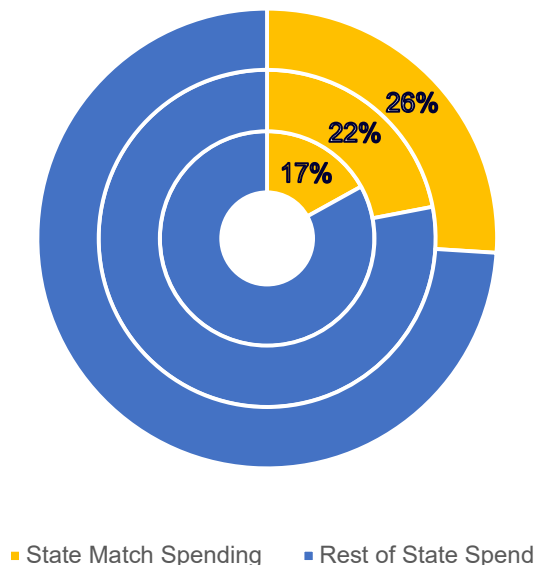
Indiana’s federal program spending as a share of total state spending remains elevated as well. Per [Table 2](#), the FFY 2024 share of federal program spending increased slightly from 2023, and represented the highest annual share of federal and state match spending since 2014.

State match spending has specifically grown as a proportion of the state's total spending. [Chart 3](#) outlines the steady increase in state match spending as a percentage of total state revenue spending (state match + state program) over the past decade.

Medicaid is a key driver of growth in Indiana's state match obligations, as well. Indiana's Medicaid Payment Assistance match funding increased by \$1.6 billion from SFY 2023 to 2024.

3) Medicaid costs are projected to continue to increase.

As has been previously mentioned, Medicaid is one of the primary drivers of Indiana's elevated federal funding and state match levels. Medicaid costs are projected to increase into the future as well; in December 2023, a revised forecast revealed that initial Medicaid cost projections for state fiscal years 2023, 2024, and 2025 were short by nearly \$1 billion, and rising Medicaid expenses are anticipated to be a point of focus for the General Assembly as the 2026-2027 budget is developed.

The recent increase in Medicaid costs is due to several factors, some of which are attributable to challenges in the national healthcare environment and others of which are more specific to Indiana. Big-picture healthcare trends that are contributing to increased Medicaid costs include:

- Generalized healthcare inflation, which has exceeded the pace of baseline inflation in recent years.
- Rising spending on "fee for service" Medicaid claims, specifically hospital visits and nursing home care.
- Rising costs related to pharmacy benefits, both for low utilization, high-cost medications

and high utilization, lower cost medications.

- Overall expenditures on behalf of the aging/long-term care population, which is growing.

Some of the Indiana-specific challenges that are driving increased Medicaid costs include:

- Enrollment levels for general Medicaid services in the wake of the COVID-19 pandemic that substantially outpaced enrollment trends prior to the pandemic. (At least some of this enrollment increase is due to a higher share of the Medicaid-eligible population receiving services.)
- Increased utilization of home- and community-based services among the aging and long-term care population. (These services are generally less expensive than nursing home care; however, the rate of growth for these services in Indiana has been greater than anticipated.)

Over the past year, FSSA has taken some initial steps to slow the rate at which Medicaid expenses are growing, including:

- Creating new managed care entities for long-term home- and community-based services (and implementing waitlists for these programs).
- Reorganizing the range of benefits available to families with medically complex children.

FSSA has also started releasing [Monthly Medicaid Financial Reports](#) that “compare actual monthly experience to forecasted projections across expenditures, enrollment, and funding” and provide context for and commentary on the data.

Attachment A – List of Federal Awards Received for FFY 2024

In FFY 2024, state agencies received 390 federal grant awards for a total of \$19.54 billion, with \$7.7 billion in corresponding matching obligations. The largest award was approximately \$13.7 billion for Medicaid Payment Assistance.
