Tuition Support

Current Appropriation

2018 \$7,059,329,402 2019 \$7,160,000,000

Requested Appropriation

2020 \$ 7,374,800,000 2021 \$ 7,596,044,000

- Tuition Support provides funding for students in traditional public school corporations and charter schools through the school funding formula found in Indiana Code 20-43.
- To ensure all students have access to the educational programs and services provided by Indiana school corporations, the
 Department is requesting an increase of 3% annually to the Tuition Support Fund, which reflects the current rate of inflation.



Curricular Materials Reimbursement

Current Appropriation

2018 \$39,000,000 2019 \$39,000,000

Requested Appropriation

2020 \$50,000,000 2021 \$50,000,000

- Costs claimed for Curricular Materials Reimbursement requests continue to increase each year and the amount reimbursed has begun to decrease each year.
- To align costs daimed and the amount available for reimbursement, an \$11 million increase in the annual
 appropriation is requested.
- 2018: \$69,110,153 was daimed; \$30,110,153 was unreimbursed.



Non-English Speaking Programs

Current Appropriation

2018 \$15,000,000 2019 \$17,500,000

Requested Appropriation

2020 \$34,004,712 2021 \$34,004,712

- Students who are English Learners (EL) are disproportionately enrolled at higher rates in D and Fschools compared to native English speaking students.
- Students who are Bugraduate high school at a rate almost 20% lower than the general student population.
- Increase from \$300 to \$450 per student.
- 1,965 (90%) schools reported **L**
- 59,000 total EL students.
- 291 languages are spoken in Indiana schools.



STEM

Current Appropriation

Requested Appropriation

2020 \$10,000,000 2021 \$10,000,000

These additional funds will be used:

- To implement Indiana's newly developed statewide STEM plan by addressing the following:
 - professional development and training for both in-service and pre-service educators,
 - access to high-quality STEM curriculum, and
 - connection to STEM career opportunities and partners.
- To ensure Governor Holcomb's STEM strategic priorities and Next Level pillars are met.
- To support stakeholders in developing a thriving, interactive, and relevant K-12 STBM system to prepare for the workforce of tomorrow.



Special Education S5

Current Appropriation

2018 \$24,070,000 2019 \$24,070,000

Requested Appropriation

2020 \$29,070,000 2021 \$29,070,000

- Support schools in meeting excess cost associated with students identified as eligible for special education.
- Disability needs warrant special placement outside of LEA.
- Insufficient FY18 State appropriation funds resulted in emergency measures impacting LEA's general fund and federal Part B funds.
- Insufficient FY18 State funds resulted in less technical assistance for LEAs.
- Since 2015, there have been 500+students served.



Testing

Current Appropriation

2018 \$26,300,000 2019 \$26,300,000

Requested Appropriation

2020 \$28,800,000 2021 \$28,800,000

- Assessment data beginning with pre-Kwill help inform college-and-career readiness grades 3-8 and ultimately high school.
- Contracted Lexile and Quantile measurement data offers a connection from the summative assessment into daily instructional practices.
- Ourrently, ILEARN serves grades 3-8 and ISTEP+ serves grade 10 representing approximately 560,000 students.
- Pre-K students make up approximately 150,000 annually across all certified providers.



Advanced Placement

Current Appropriation

2018 \$5,200,000 2019 \$5,200,000

Requested Appropriation

2020 \$6,200,000 2021 \$6,200,000

- The State of Indiana pays for AP mathematics, science, and English exams for all students in grades 11 and 12.
- The goal of this exam fee program is to promote college-and-career readiness in STEM and English content areas.
- AP assessments fulfill a portion of the graduation requirements.
- The number of AP tests have increased over the last three years from 77,086 to 88,225.



PSAT Program

Current Appropriation

2018 \$1,900,000 2019 \$2,200,000

Requested Appropriation

2020 \$2,510,000 2021 \$2,510,000

- This funding is used to cover the costs of administering the PSAT/NMSQT exam to all eligible students in grades 10 and 11.
- The Department requests a change in funding of \$310,000 for each year of the upcoming biennium to account for increased participation in the assessment.
- This \$310,000 can be moved from the previous budget for Remediation and Testing.
- In 2018, 460/536 (85%) high schools offered PSAT.



Teacher Appreciation Grants

Current Appropriation

2018 \$30,000,000 2019 \$30,000,000

Requested Appropriation

2020 \$30,000,000 2021 \$30,000,000

- Indiana Department of Education's Teacher Survey: Your Voice Matters, 88% of teachers who responded were unsatisfied with their salaries.
- Within the first five years (2011-2016), 35% of educators leave the profession.
- Additionally, among teachers who responded with interest in leaving the profession, pay was the number one reason communicated through the survey.
- In SY18-19, 371 (97%) of districts submitted policies and received TAG.
- For some districts, TAG is the only new monies received.



Special Education Pre-K Funding

The Department requests an increase in the Special Education Preschool portion of the Tuition Support formula (I.C. 20-43-7-6).

The Preschool amount has remained at \$2,750 per student since 1991.

• **4,004** students identified pre-Kspecial education in 1991: **13,066** students (200% increase) identified pre-Kspecial education in 2018.

However, three other components to the Special Education funding formula have increased since 1996.

- APC funding level for Severe Disabilities has increased from \$6,000 in 1996 to \$9,156 for FY19. This is a 52.6% increase.
- The Mld and Moderate Disabilities amount has increased from \$1,850 per student in 1996 to \$2,300 since FY16. This represents a 24.3% increase.
- The Communication Disorder category has increased from \$410 per student in 1996 to \$500 per student since FY16. This represents a 22% increase. (Please note: From FY01 to FY15 this amount was larger than it is today, topping out at \$533.)



Distribution for Summer School

Current Appropriation

\$18,360,000 2019 \$18,360,000

Requested Appropriation

2018

2020 \$20,000,000 2021 \$20,000,000

- Summer school is a state-reimbursable K-12 program.
- SBOE approved course titles and descriptions are eligible to be offered for K-12.
- In 2018, the shortfall exceeded \$4 million.

For the past several years, the Department has not been able to reimburse schools for 100% of their summer school costs.

These additional funds will be used:

- To create the position of Opioid Use Prevention Specialist;
- To administer a pilot grant program for opioid use prevention to 10 schools;
- To administer mini-grants to school corporations with Telehealth Medicine contracts for the purchase of the equipment necessary to
 provide the services, particularly in rural communities; and
- To create a School Nurse Emergency Course to ensure schools nurses, as first responders, are trained and prepared to handle opioid related emergencies.
