



TOTAL REVENUE BY FUND TYPE 2013-2015 BIENNIUM \$59,269.0 MILLION




TOTAL REVENUE BY SOURCE 2013-2015 BIENNIUM

TOTAL GENERAL FUND REVENUE BY SOURCE 2013-2015 BIENNIUM \$29,986.8 MILLION





TOTAL DEDICATED FUND REVENUE BY SOURCE 2013-2015 BIENNIUM \$8,999.5 MILLION


