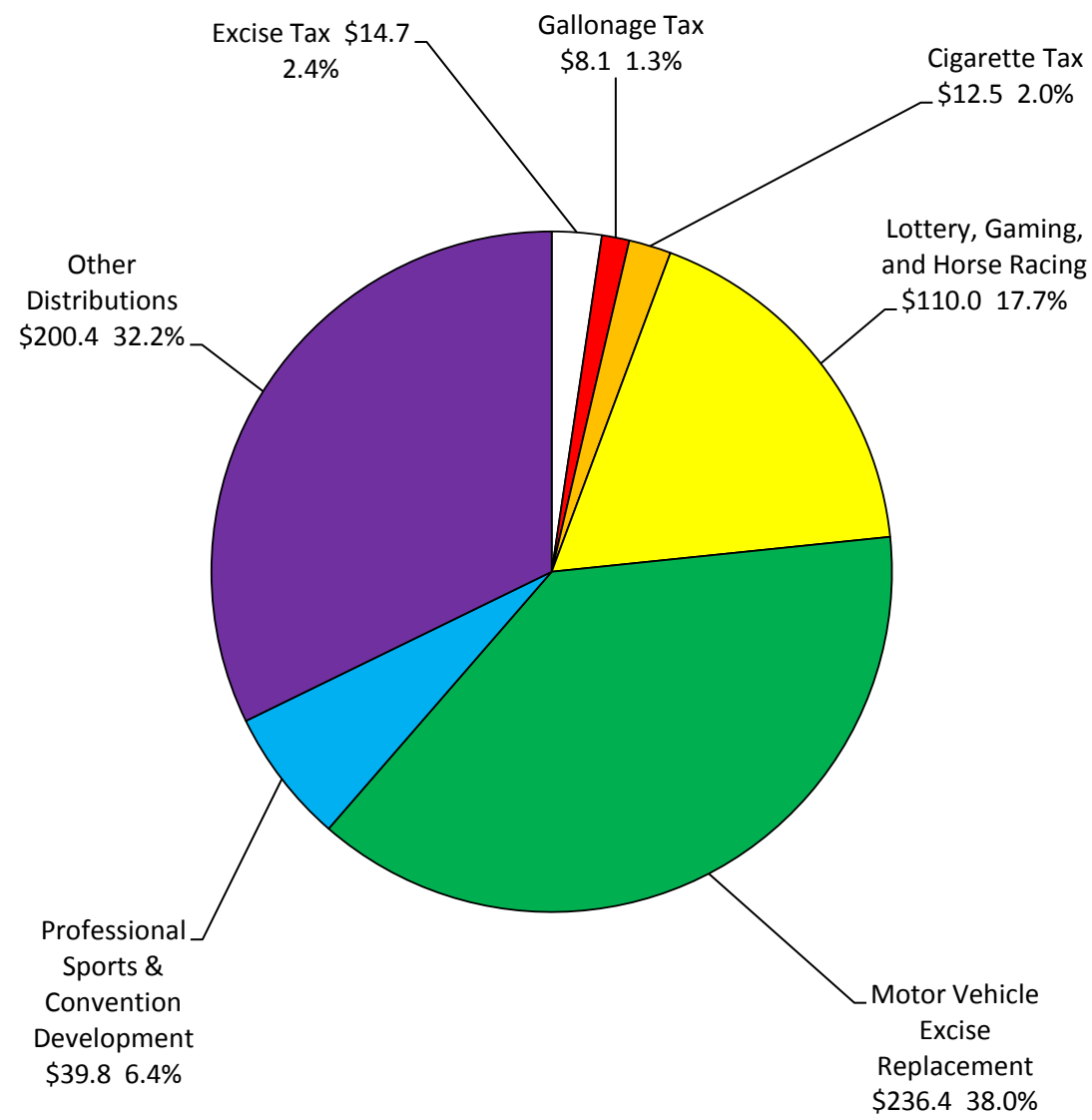


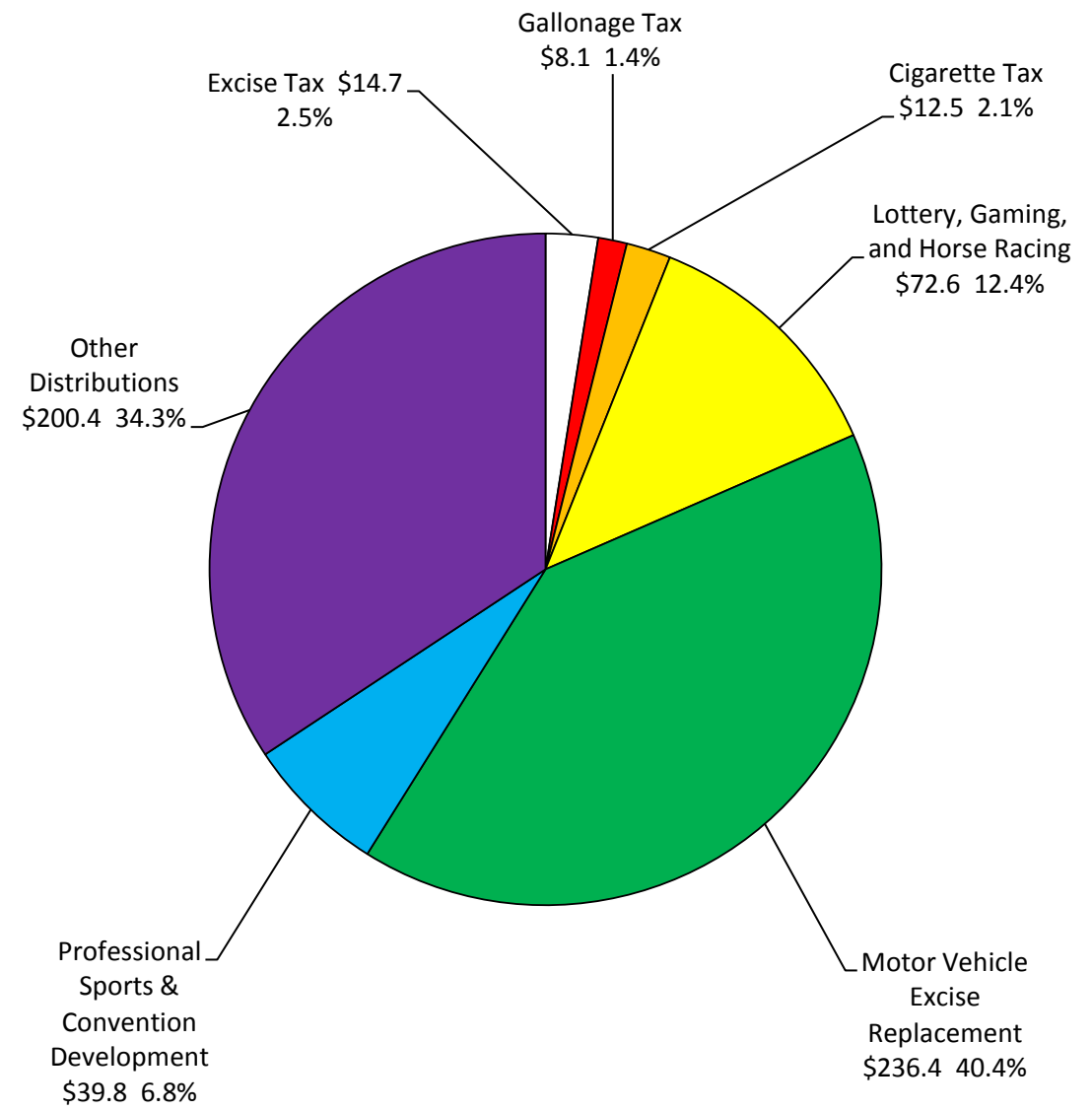

FY 2013-2014 \$621.9 Million

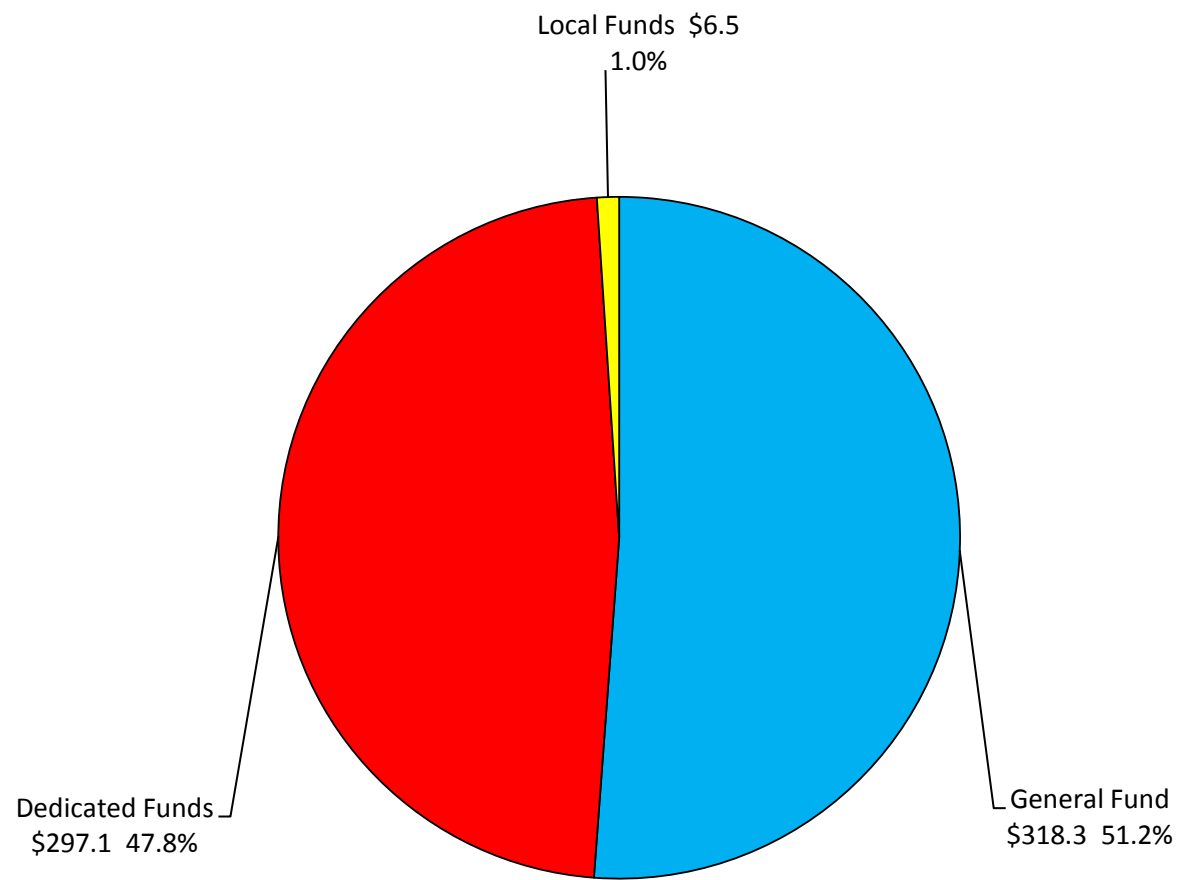

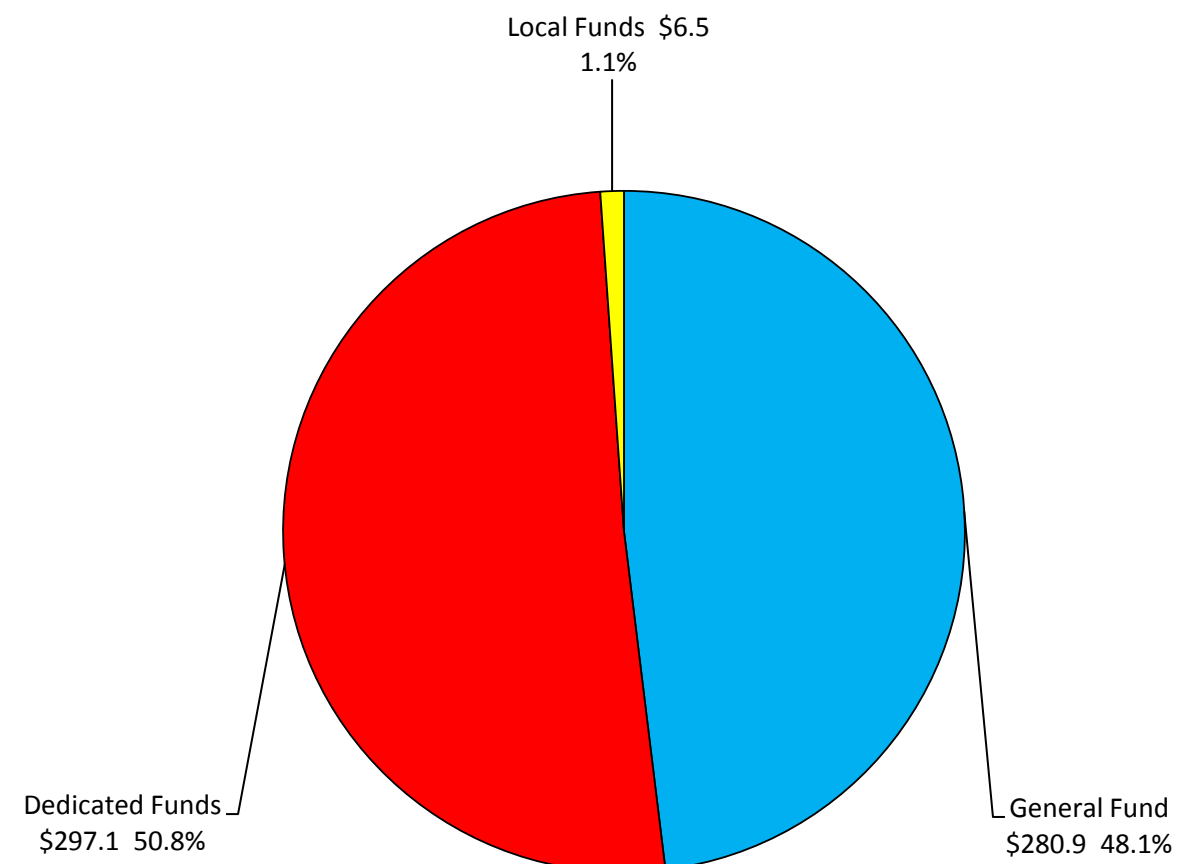
