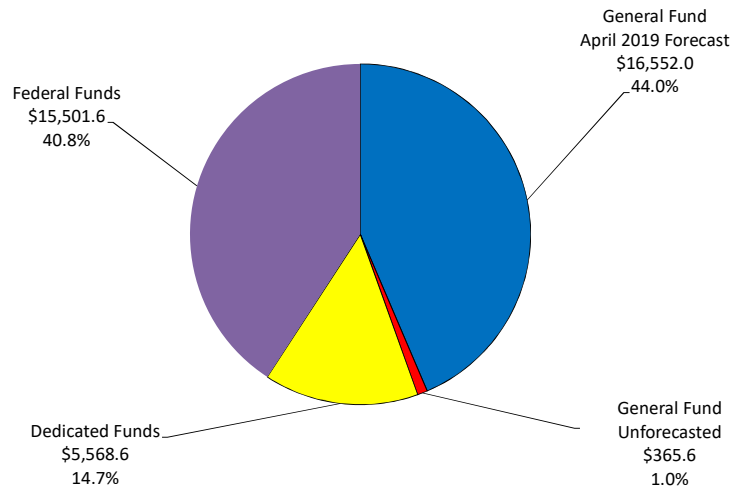


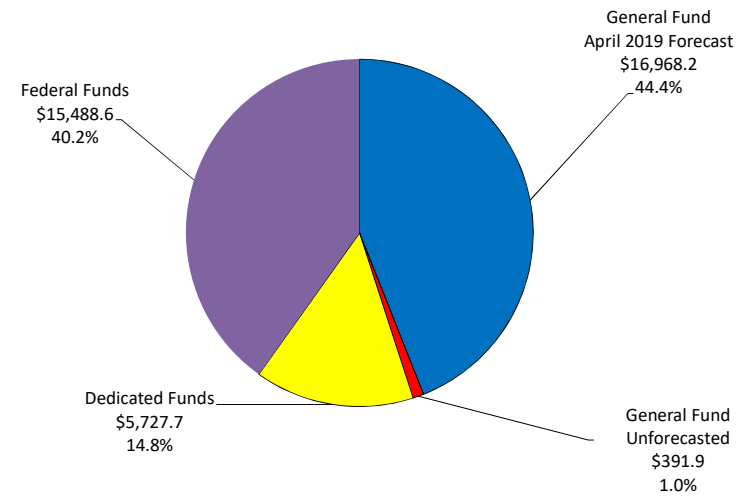
**TOTAL REVENUE BY FUND TYPE

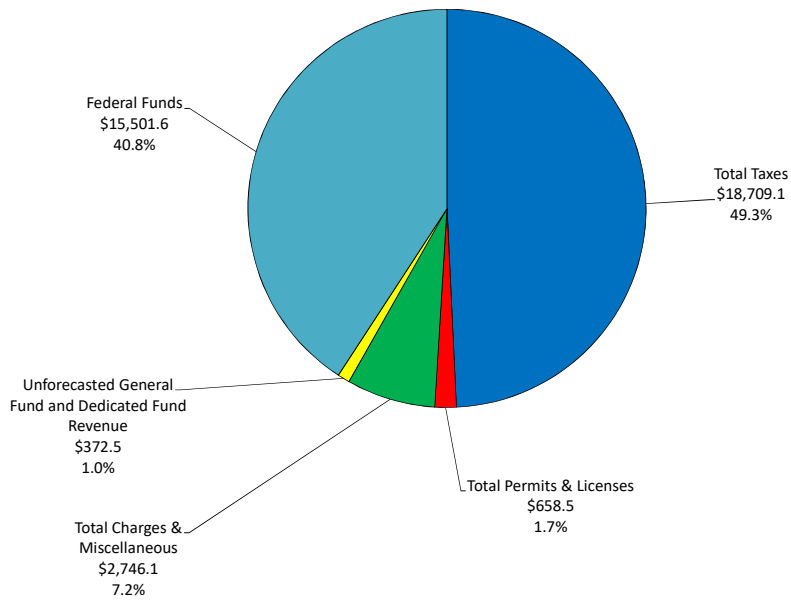

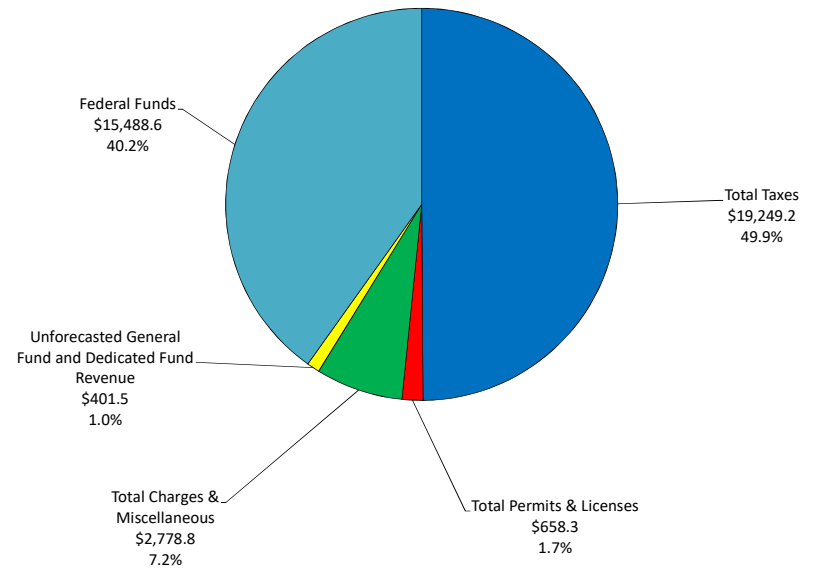

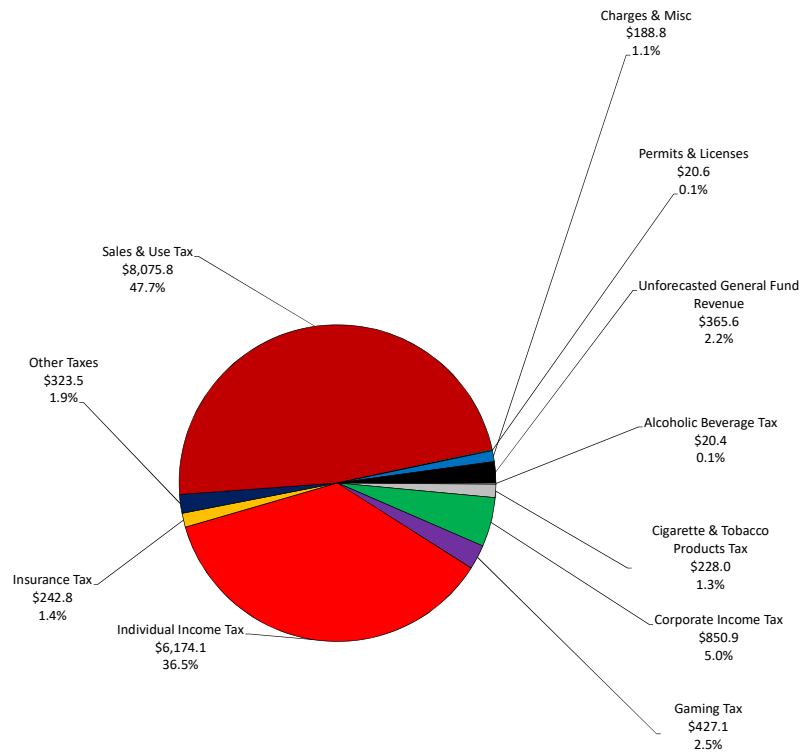

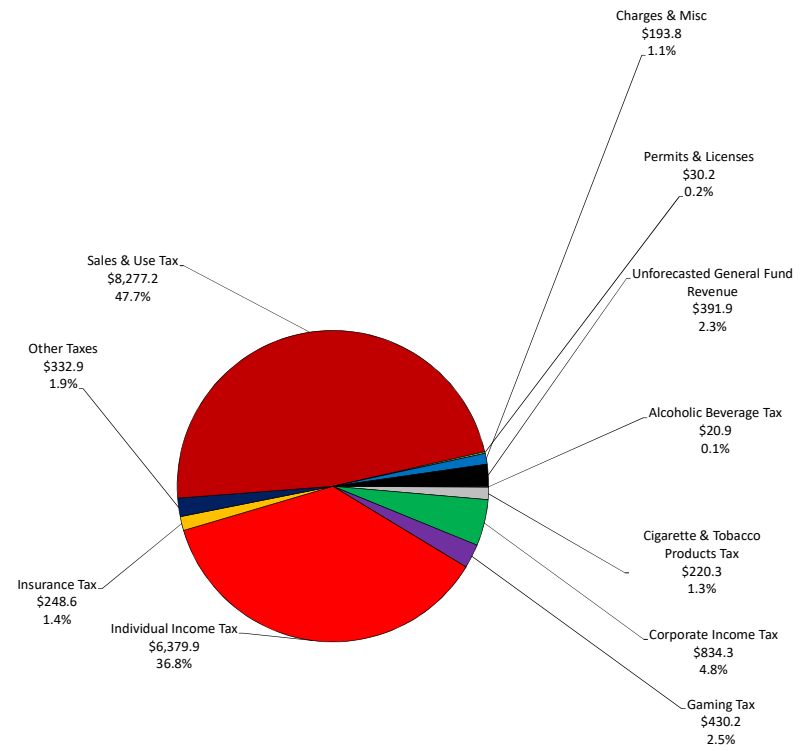
**TOTAL GENERAL FUND REVENUE BY SOURCE

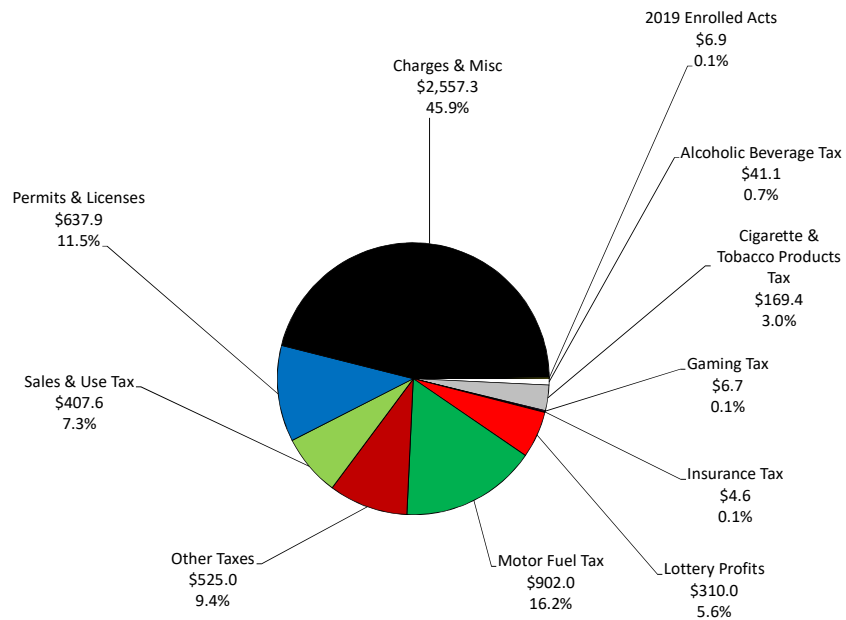
**TOTAL GENERAL FUND REVENUE

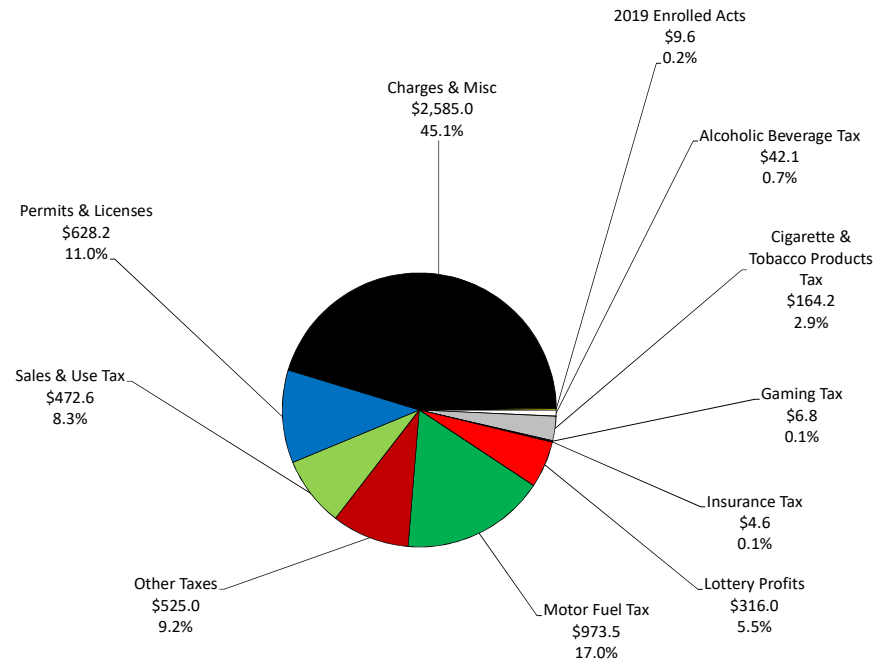
**TOTAL DEDICATED FUND REVENUE BY SOURCE

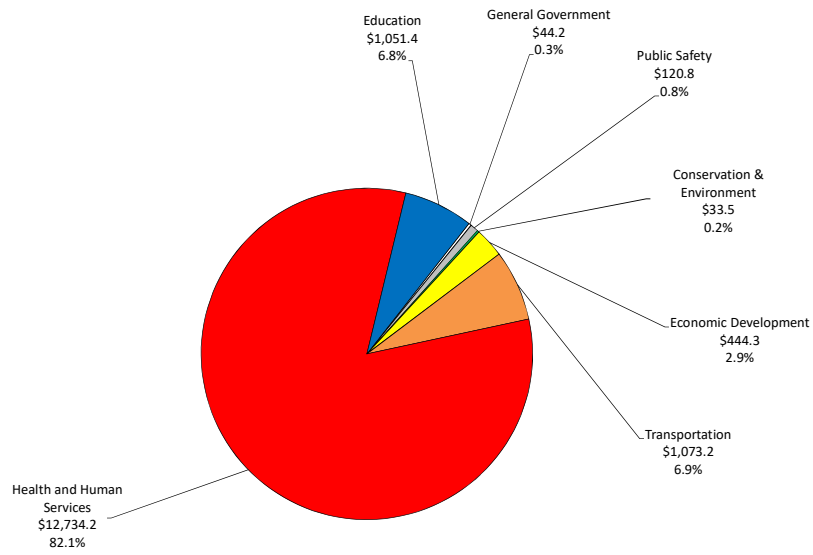

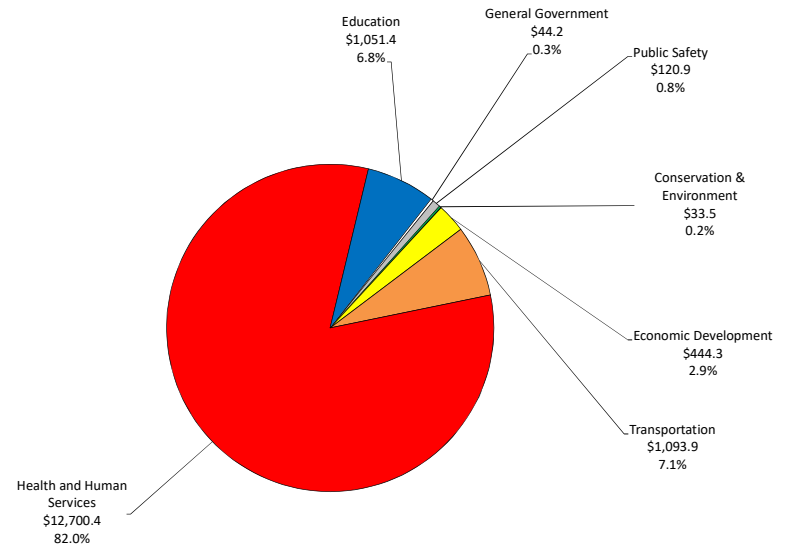
**TOTAL FEDERAL FUND REVENUE BY SOURCE

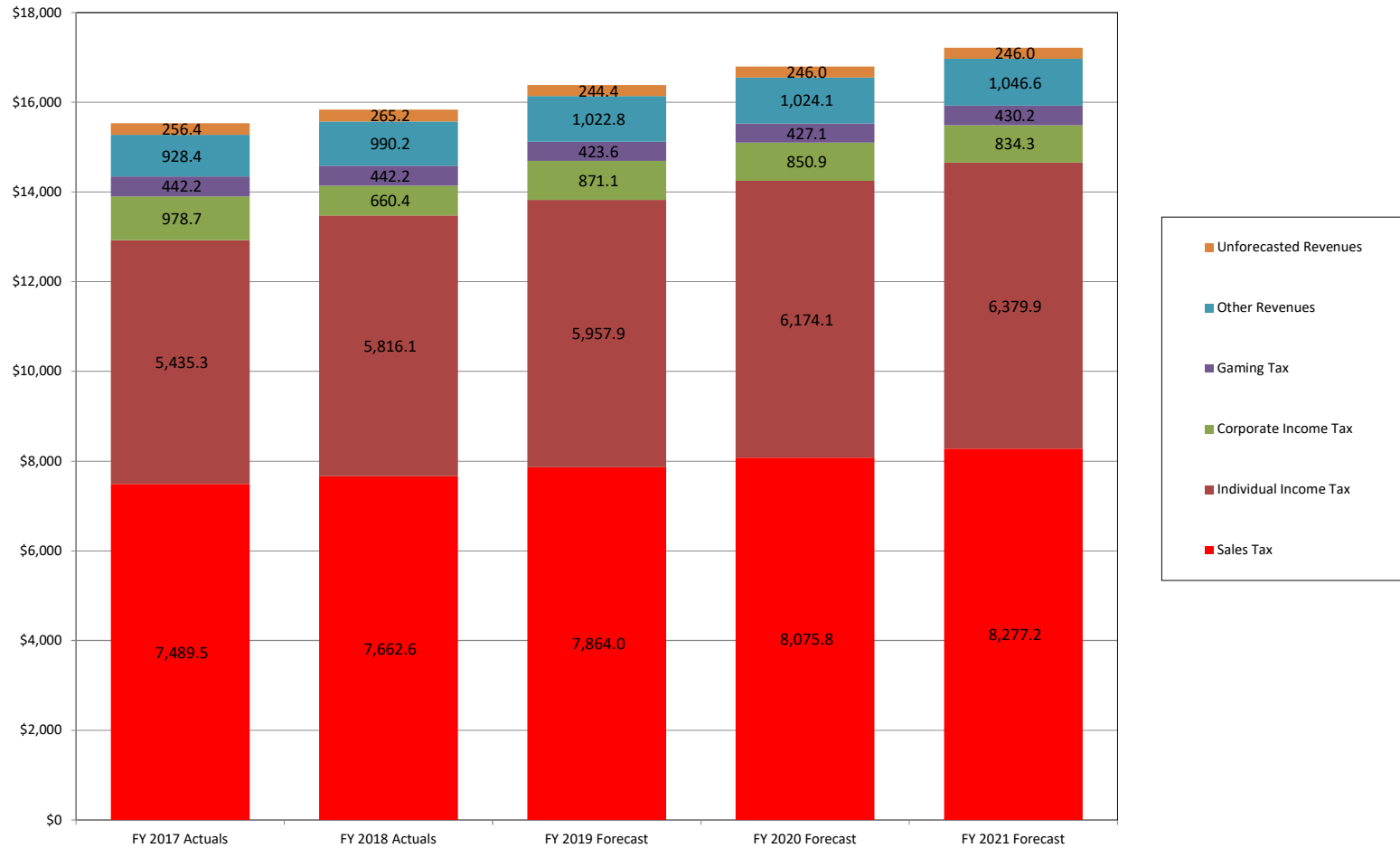
