


CARES Act- Coronavirus Relief Fund

- Program reconciliation and close-out
 - Residual is to be transferred to Unemployment Insurance Fund
 - Estimated to be \$110 million
- Final report due December 31

ARP – NEU Distribution

- 509 of 542 eligible NEUs received distributions
 - 32 NEUs did not apply
 - 1 NEU declined
- Second 50% installment in process
 - Verification of points of contact and new identifier for federal grants
 - Second distribution equal to final, first round amount after adjustments for nonresponsive units and budget formula limits

- 210 applications from 185 organizations
- 154 awards totaling \$35 million
- Priority Areas
 - Chronic Disease and Disease Prevention
 - Asthma -- \$850,000
 - Cancer -- \$980,000
 - Cardiovascular/Diabetes -- \$2.7 million
 - Hepatitis C -- \$6.5 million
 - Tobacco Prevention/Cessation -- \$790,000
 - Food Insecurity/Obesity -- \$9.4 million
 - Elevated Blood Lead Level Reduction -- \$4.2 million
 - Community health workers, paramedicine -- \$9.6 million
