Subject: Indiana Federal Grants Report – Federal Fiscal Year (FFY) 2023

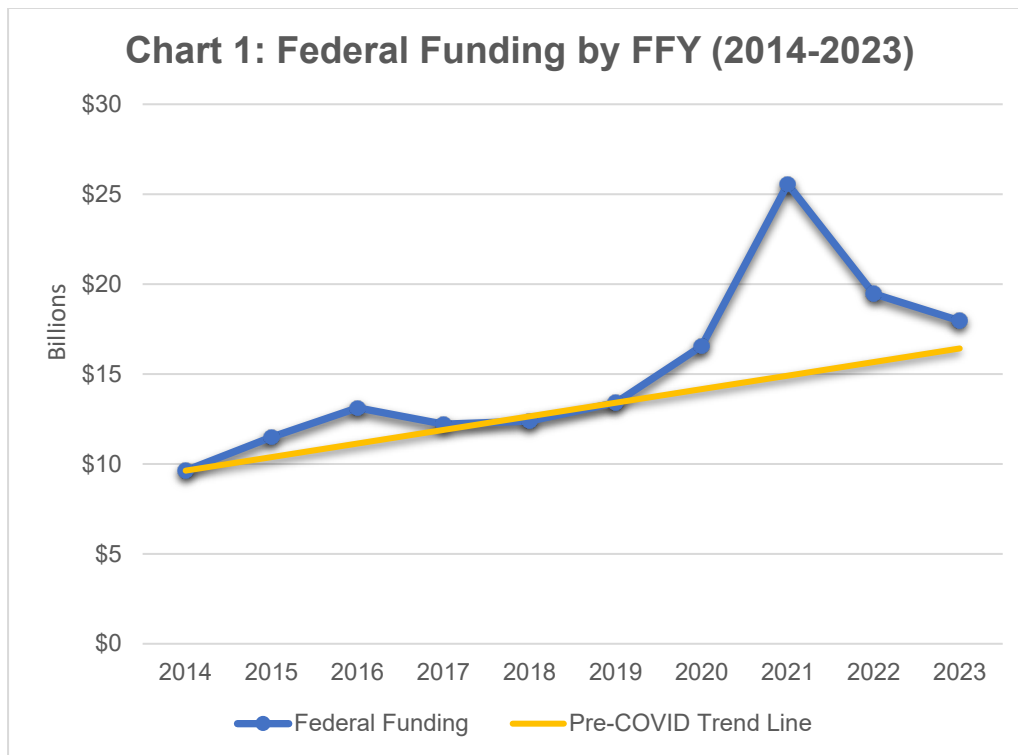
Pursuant to IC 4-3-24-7, the State Budget Agency is required to publish an annual report summarizing the federal assistance received by state agencies for the relevant federal fiscal year. See Attachment A at the end of this document for the full list of federal grant awards received by state agencies for FFY 2023.

In addition, this report provides information regarding multi-year trends in Indiana's federal funding FFY 2023 data. Unless indicated otherwise, all data for this report was pulled from the state's accounting system.

An analysis of Indiana's federal grants data reveals two key trends. First, Indiana's federal funding has increased over the last decade. Second, Indiana's state match obligations have also increased over the last decade.

1. Federal funding levels have steadily increased over the past decade.

As [Chart 1](#) indicates below, Indiana's federal funding levels rose on an almost yearly basis from FFY 2014-2021 and remained elevated in 2022 and 2023.



While much of the growth in 2020 and 2021 was driven by COVID-19 relief funding¹, Indiana's 2022 and 2023 federal funding levels outpaced the pre-COVID (2014-2019) growth trend with a smaller amount of COVID funding.

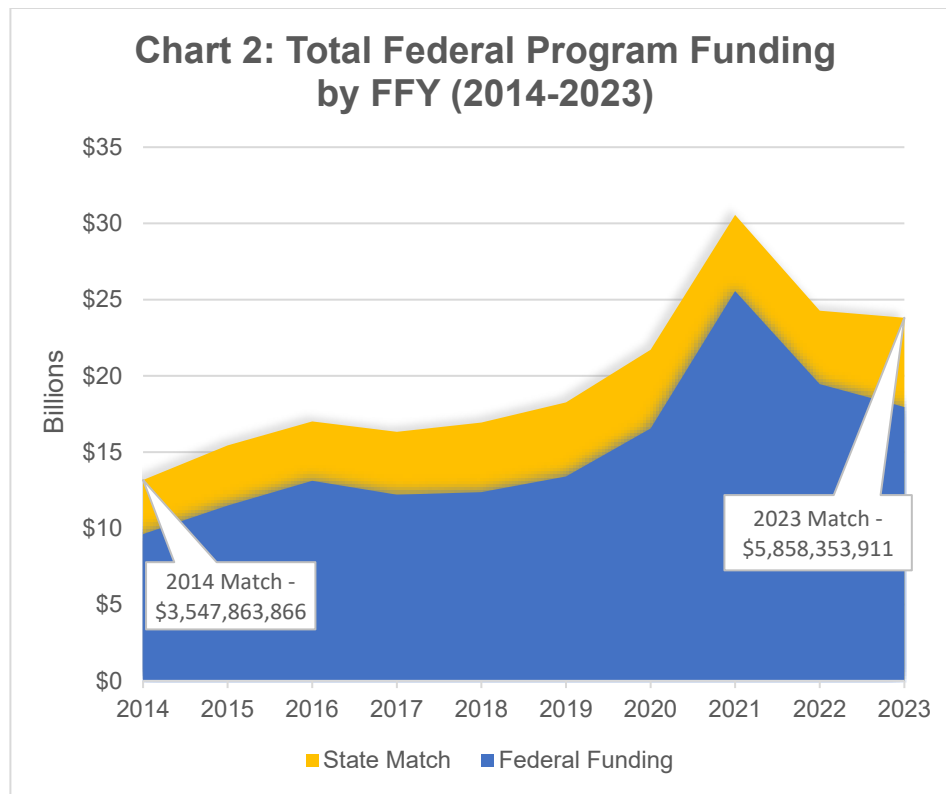

2. State match levels have grown alongside federal funding.

From 2014-2023, state match funding associated with federal grants increased by over \$2.3 billion. [Chart 2](#) below displays the growth in Indiana's federal funding and total federal program funding (federal funds + state match funds) from FFY 2014-2023.

¹ For the purposes of this report, "COVID funding" is defined as funding originating from any of the major federal COVID-19 relief appropriations packages – CARES, ESSER, CRSSA, and ARP.



[Table 2](#) delineates how the proportion of federal program spending (federal and state match) relative to Indiana’s overall spending has increased over the past 10 years.

Attachment A –List of Federal Awards Received for FFY 2023

In FFY 2023, state agencies received 388 federal grant awards for a total of \$17.79 billion, with \$5.8 billion in corresponding matching obligations. The largest award was approximately \$12.3 billion for Medicaid Payment Assistance. The State received \$43.4 million in various grants for COVID-19 related funding.
