

## MEMORANDUM OF UNDERSTANDING

Between the

**INDIANA STATE BUDGET AGENCY**

and the

**INDIANA STATE PERSONNEL DEPARTMENT**

This Memorandum of Understanding is entered into by and between the Indiana State Budget Agency (“SBA”) and the Indiana State Personnel Department (“SPD”). The parties mutually agree to the terms and conditions set forth herein.

**WHEREAS**, SBA, an agency of the Office of Management and Budget (“OMB”), is designated by OMB to accept and administer funds from the federal Coronavirus Aid, Relief and Economic Security (CARES) Act, Pub.L. 116–136; and

**WHEREAS**, SPD has authority under IC 5-10-8-7 to contract for health insurance and self-insurance programs for State employees.

**WHEREAS**, the parties enter into this MOU to memorialize their understanding of the mutual advantages of this cooperative relationship.

**NOW, THEREFORE**, the parties agree to the terms and conditions set forth below:

### **I. Purpose**

The purpose of this MOU is to memorialize an agreement to reimburse SPD for necessary expenditures related to the State’s response to the COVID-19 public health emergency, as more fully set forth in Attachment A, (the “Program”) and provide guidance to SPD for the purpose of complying with federal requirements under 2 C.F.R 200.

### **II. Grant Information**

- f) Total Amount of Funds obligated to the sub state agency: **up to \$25,000,000.00 for eligible claims described in Attachment A**
- g) Period of time sub state agency can obligate funds: start and end date. **The CRF funds may be used to cover expenditures that were incurred between March 1, 2020, and December 30, 2021.**

- h) Period of time to sub state agency can liquidate funds: start and end date: **The CRF funds may be used to cover expenditures that were incurred by December 30, 2021. Liquidation period, although not defined, is expected to be no later than 90 days after the close of the calendar year.**
- i) Requirements imposed on the sub-state agency so that the award is used in accordance with Federal statutes, regulations and the terms and conditions of the award. **The federal funds are considered federal financial assistance subject to the Single Audit Act of (31 U.S.C. §§ 7501-7507) and the related provisions of the Uniform Grant Guidance; 2 C.F.R. § 200.303 regarding internal controls, 2 C.F. R. § § 200.330 through 200.332 regarding subrecipient monitoring and management, and subpart F regarding audit requirements. In addition, guidance from the Department of Treasury.**
- j) Indirect cost rate or cost allocation that can be charged to the federal grant: **None at this time.**
- k) Match requirements: **None.**
- l) Reporting requirements: SPD must encumber all contractual and grant agreement amounts spent with Coronavirus Relief Funds in PeopleSoft, preferably in the SPD Department of Treasury PeopleSoft Fund. Where amounts are encumbered outside of the SPD Department of Treasury PeopleSoft Fund and transferred to the Coronavirus Relief Fund via journal entry, SPD must attach a spreadsheet with Vendor and PO details to the journal entry so that OMB/SBA can comply with Department of Treasury Reporting Requirements.

(All contracts, grants, loans, transfers to other government entities, or direct payments greater than or equal to \$50,000 must be disclosed by OMB/SBA in the Department of Treasury's GrantSolutions portal within 10 calendar days of the end of each quarter until October 31, 2022.)

SPD shall provide a list of all subrecipients as defined in 2 CFR 200.330 and the amount of the award as part of SPD's monthly report.

SPD should inquire with its CRF vendors if they are registered in SAM and if they have a DUNS number. If DUNS numbers are received, these should be forwarded to OMB/SBA as part of SPD's monthly report.

### **III. Term**

The MOU shall be in effect from March 1, 2020, through January 31, 2022.

When the Director of the SBA makes a written determination that funds are not appropriated or otherwise available to support continuation of performance of this memoranda, the memoranda shall be canceled. A determination by the Director of the SBA that funds are not appropriated or otherwise available to support continuation of performance shall be final and conclusive.

### **IV. Obligations of the Parties**

The parties agree to the following obligations under this MOU:

1. SBA agrees to provide SPD from the CARES Act an amount not to exceed the amount listed in Section II(f), which may be amended from time to time. SPD may access funds as actual claims, as described in Attachment A, are incurred by SPD and SBA will not provide funds in excess of actual claims incurred. SPD agrees to return to SBA any unused funds.
2. SPD will follow federal expenditure procedures as outlined in the State Board of Accounts manual.
3. SPD acknowledges that it is a Sub-State Agency as that term is used in the State Board of Accounts manual.
4. SPD will administer the Program in accordance with federal laws and guidance of the CARES Act, US Treasury guidance and policies, OMB and SBA policies and procedures, State Board of Accounts guidance on administration and tracking of COVID-19 funds, and any policies or procedures implemented by SPD for administration of the program. SPD's responsibilities to administer the Program include:
  - a. Provide communications and monthly reports to the Director of the OMB and the Director of SBA no later than ten (10) days after the end of the month regarding the status of the Program, including a detailed breakdown of the expenditures reimbursed under the Program and an explanation of why those expenditures were necessary to respond to the COVID-19 public health emergency;
  - b. Cooperate with any audit regarding use of Program funds by State Board of Accounts or as otherwise required under the CARES Act or other federal law.
5. SBA will assist SPD as necessary with the administration of the Program.

### **V. Records Retention**

SPD agrees to maintain records to support compliance with subsection 601(d) of the Social Security Act, as amended, (42 U.S.C. 801(d)). This may include, but is not limited to, copies of the following:

1. general ledger and subsidiary ledgers used to account for (a) the receipt of Coronavirus Relief Fund payments and (b) the disbursements from such payments to meet eligible expenses related to the public health emergency due to COVID-19;
2. budget records for 2019, 2020, 2021, and 2022;

3. payroll, time records, human resource records to support costs incurred for payroll expenses related to addressing the public health emergency due to COVID-19;
4. receipts of purchases made related to addressing the public health emergency due to COVID-19;
5. contracts and subcontracts entered into using Coronavirus Relief Fund payments and all documents related to such contracts;
6. grant agreements and grant subaward agreements entered into using Coronavirus Relief Fund payments and all documents related to such awards;
7. all documentation of reports, audits, and other monitoring of contractors, including subcontractors, and grant recipient and subrecipients;
8. all documentation supporting the performance outcomes of contracts, subcontracts, grant awards, and grant recipient subawards;
9. all internal and external email/electronic communications related to use of Coronavirus Relief Fund payments; and
10. all investigative files and inquiry reports involving Coronavirus Relief Fund payments.

SPD will maintain records for a period of five (5) years after final payment is made using Coronavirus Relief Fund monies. These record retention requirements are applicable to all prime recipients and their grantees and subgrant recipients, contractors, and other levels of government that received transfers of Coronavirus Relief Fund payments from prime recipients.

#### **VI. SEFA Reporting**

SPD will identify Emergency Acts expenditures separately on the SPD Schedules of Expenditures of Federal Awards (SEFA).

Personnel expenses reimbursed by CRF funds must meet the requirements of the program as provided by the U.S. Department of Treasury.

#### **VII. Modifications**

This parties may modify this MOU by a written, mutual, signed amendment.

#### **VIII. Notices**

**IX. Termination or Suspension**

This MOU may be terminated or suspended by either party if the other party has failed to comply with the terms of this MOU, or for any reason if such termination is in the best interest of the terminating agency, upon thirty (30) days written notice. The notice of termination or suspension shall state the reasons for termination or suspension. Regardless of the reason for termination or suspension, the parties will be compensated for services properly rendered prior to termination or suspension of this MOU.


**X. Entire Agreement**

## ATTACHMENT A

As part of the State's response to the COVID-19 public health pandemic, the Indiana State Personnel Department (SPD) has incurred additional expenses due to COVID-19 health care claims by State employees, including claims related to COVID-19 tests performed on State employees. As of April 22, 2021, SPD's key metrics included:

### Summary of key metrics:

- 4,219 confirmed COVID-19 cases
- 20,908 unique claimants with a claim related to COVID-19 testing or treatment
- Testing results based on lab data Anthem has access to:
  - a. 11,179 unique individuals with lab data
  - b. 18,206 total lab tests from lab data
  - c. 10.9% positivity rate from lab data
- Total testing counts based on all claims:
  - a. 20,041 unique individuals with a testing claim
  - b. 33,248 total testing claims
- 237 inpatient admissions
  - a. \$42k per admission
  - b. 7.6 days average inpatient admission length of stay
- \$15.4M in claims cost attributed to COVID-19
  - a. \$2.9M of total claims cost is attributed to COVID-19 testing
- 6,683 1<sup>st</sup> dose, 3,761 2<sup>nd</sup> dose vaccine claims (CVS/Caremark data)

SPD anticipates that it will continue to incur expenses related to COVID-19 health care claims by State employees through December 31, 2021. Only claims related to COVID-19 are eligible to be reimbursed under this MOU.

## Amendment 1

### MEMORANDUM OF UNDERSTANDING

Between the

This is an Amendment to the existing Memorandum of Understanding entered into by and between the **Indiana State Budget Agency** (hereinafter referred to as SBA) and the **Indiana State Personnel Department** (hereinafter referred to as SPD) approved by the last State signatory on **April 28, 2021**

In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree as follows:

**All other matters previously agreed to and set forth in the original Memorandum of Understanding and not affected by this Amendment shall remain in full force and effect. The parties having read and understanding the foregoing terms of the Memorandum of Understanding Amendment do by their respective signatures dated below agree to the terms thereof.**


