I. Review Item

1. Indiana Office of Medicaid Policy and Planning State Plan Amendment Review

Mandatory Coverage of Medication-Assisted Treatment (MAT) State Plan Amendment

The Family and Social Services (FSSA) Office of Medicaid Policy and Planning (OMPP) proposes a technical correction to modify the state plan in accordance with the SUPPORT Act. In this federal law, states are required to provide Medicaid coverage of certain drugs and biological products, and related counseling services and behavioral therapy. In addition, the SUPPORT Act requires state Medicaid plans to include coverage of MAT for all eligible to enroll in the state plan or waiver of state plan and for this coverage to be retroactive to October 1, 2020. The state plan currently covers most MAT drugs and services. The only MAT drugs that are not covered are those from labelers who do not participate in the Medicaid Drug Rebate Program. Our expectation is there will be no increase in utilization of these non-rebating MAT drugs. Therefore, this state plan amendment is budget neutral and there is no fiscal impact.

When the change will be effective: October 1, 2020
