Note: Of the \$269.4M in total cigarette tax revenue deposited in the General Fund and dedicated funds through November, \$97.4 million was directed to the Healthy Indiana Plan accounts established under HEA 1678-2007 as follows:

- \$73.0M to the Check Up Plan Trust Fund to fund health insurance for the uninsured;
- \$6.6M for health benefit and wellness plan tax credits;
- \$11.1M for retiree medical expenses of elected officials and state employees pursuant to the provisions of SEA 501; and
- \$6.6M for Medicaid provider reimbursements.
