




Odyssey Release Update Transitioning to Odyssey Navigator







Fee Changes 2021

HEA 1271 amends IC 33-32-5-1

- Increases State share from \$10 to \$15
- Increases County share from \$8 to \$10 for Indiana Residents
- Directs \$2 of the County share to the Clerk Record Perpetuation Fund

IOCT has:

- Created the Marriage Certificate (Clerk Record Perpetuation) fee
- Updated your Report of Collections numbers
 - If your various fees point to a single line on the ROC, we pointed this new fee to the same account
 - If your various fees point to individual line items on the ROC, we created a new line
