 - Addresses listed should be Township office Set Default Address
 - Remember to hit "Enter" button on keyboard after inputting information in each box
 - Remember to hit "Save All Work" button on top or bottom of screen before exiting

- Changes to Risk Assessment Questions
- Changes to the defined benefits Pension screen
- Question asking what type of accounting software is used by the Township (Unit Questions section)
- Internal Control Certification answered no, then an explanation must be entered (Unit Questions section)
- Attestation form is no longer required to print, sign, and mail to our office



Our most common questions answered:

- Submission Errors
 - Disbursements by Vendor does not match Disbursements on Financial Data by Fund
 - Official Bonds
 - Capital Asset or Debt Schedule not completed
- Submission Warnings
 - Beginning balances do not equal prior ending balances
- General Questions
 - Do we have to advertise and what is the deadline?
 - Do we have to take a copy to the County Auditor and what is the deadline?
 - Username/password does not work



What are the penalties for not completing the AFR?

- Subsequent Budget and Additional Appropriations will be denied by DLGF
- Subpoena issued by SBOA
- Court action filed by Attorney General
- Request to local prosecutor to file Infraction
 - Possible civil fine and removal from office

Required by IC 5-14-3.8-3.5

- Contracts entered into after June 30, 2016
- Applies to all contracts in excess of \$50,000 except employment contracts
- Must be uploaded within 60 days of contract execution
- May redact information as allowed by law
